A RESOLUTION

- 1 Honoring the life and memory of Mr. Phillip James Oliver; and for other purposes.
- 2 WHEREAS, the State of Georgia mourns the loss of one of its most distinguished citizens
- 3 with the passing of Mr. Phillip James Oliver; and
- 4 WHEREAS, Mr. Oliver was born in Opelika, Alabama, and graduated from Opelika High
- 5 School; and
- 6 WHEREAS, he earned an associate's degree in applied science from Gadsden State Junior
- 7 College, where he played basketball and interned at the Veterans Administrative Hospital in
- 8 Tuskegee, Alabama; and
- 9 WHEREAS, Mr. Oliver earned a bachelor's degree in social welfare from the University of
- 10 Alabama, where he worked as a lab assistant in genetic research for the biology department;

- 12 WHEREAS, he diligently and conscientiously devoted his time, talents, and energy in the
- 13 field of sickle cell disease, serving as an administrative assistant, lab assistant, health
- 14 educator, social worker, and genetic counselor for the Sickle Cell Foundation of Georgia; and
- 15 WHEREAS, an expert in the field of sickle cell disease, Mr. Oliver hosted a weekly radio
- 16 show for two years called *Health Talk*, worked on research for the disease with the Bio
- 17 Medical Research Institute, and conducted numerous lectures and radio and talk shows on
- 18 the subjects of sickle cell disease and health; and
- 19 WHEREAS, a man of deep and abiding faith, Mr. Oliver was an active member of Ebenezer
- 20 Baptist Church in Atlanta, where he served as a youth church school teacher for 12 years;

22 WHEREAS, Mr. Oliver was a community leader, serving as an assistant basketball coach for
23 men's basketball at Clark Atlanta University from 2002 to 2005 and volunteering his time
24 for the Mike Glenn Basketball Camp for the Hearing Impaired and Wheelchair Charities; and

25 WHEREAS, he gave inspiration to many through his high ideals, morals, and deep concern
26 for his fellow citizens, and the devotion, patience, and understanding he demonstrated to his
27 family and friends were admired by others; and

28 WHEREAS, he was a person of magnanimous strengths with an unimpeachable reputation
29 for integrity, intelligence, fairness, and kindness and, by the example he made of his life, he
30 made this world a better place in which to live; and

31 WHEREAS, a compassionate and generous man, Mr. Oliver will long be remembered for
32 his love of family and friendship, and this loyal researcher, counselor, and friend will be
33 missed by all who had the great fortune of knowing him.

34 NOW, THEREFORE, BE IT RESOLVED BY THE SENATE that the members of this body
35 join in honoring the life and memory of Mr. Phillip James Oliver and express their deepest
36 and most sincere regret at his passing.
