

House Resolution 2102

#### A RESOLUTION

1 Urging the Georgia Department of Community Health to require patient centered medical  
2 home pilot projects be established for the Medicaid population and to establish a pilot project  
3 of the patient centered medical home through the State Health Benefit Health Insurance  
4 Plans; and for other purposes.

5 WHEREAS, medical homes should provide patient centered care that is accessible,  
6 continuous, and coordinated with a focus on maintaining a healthy lifestyle for patients with  
7 preventive and ongoing health services; and

8 WHEREAS, the primary care provided at medical homes should be respectful of, and  
9 responsive to, individual patient preferences, needs, and values; and

10 WHEREAS, physicians practicing in medical homes should target eligible individuals for  
11 program participation and should be responsible for providing safe and secure technology  
12 that promotes patient access to personal health information, for developing a health  
13 assessment tool for targeted individuals, and for providing training to personnel involved in  
14 the coordination of care; and

15 WHEREAS, personal physicians in medical homes should be eligible for case management  
16 fees and incentive payments for providing "medical home" services; and

17 WHEREAS, personal physicians who provide first contact and continuous care for their  
18 patients should be board certified and have the staff and resources to manage the  
19 comprehensive and coordinated care of each of their patients; and

20 WHEREAS, participating physicians in the program should be specialists or subspecialists  
21 for patients requiring ongoing care for specific conditions, for multiple chronic conditions,  
22 or for those with a prolonged illness; and

23 WHEREAS, personal physicians should be responsible for providing ongoing support,  
24 oversight, and guidance to implement an integrated, coherent, cross-discipline plan of care  
25 developed in partnership with patients and any of their other medical providers; and

26 WHEREAS, physicians in medical homes should be required to use evidence based medicine  
27 and clinical decision support tools to guide their decision making to patient-specific  
28 symptoms; and

29 WHEREAS, the use of health information technology should be required of physicians in  
30 medical homes, and patients should be encouraged to engage in management of their own  
31 health through education and support systems; and

32 WHEREAS, the evaluation of the patient centered medical home should be based on patient  
33 satisfaction, provider satisfaction, clinical process and outcome measures, program costs and  
34 savings, and the economic impact on health care providers; and

35 WHEREAS, evaluation should be on the extent to which the medical home coordinated  
36 health care services, provided safe and high-quality care, encouraged long-term patient and  
37 provider relationships, engaged and educated consumers, and encouraged innovation in  
38 payment methodologies.

39 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES that  
40 the members of this body urge the Georgia Department of Community Health to establish  
41 patient centered medical home pilot projects.

42 BE IT FURTHER RESOLVED that the Clerk of the House of Representatives is authorized  
43 and directed to transmit an appropriate copy of this resolution to the Georgia Department of  
44 Community Health.
