

The House Committee on Intragovernmental Coordination - Local Legislation offers the following substitute to SB 533:

A BILL TO BE ENTITLED  
AN ACT

1 To amend an Act creating a new charter for the City of Lilburn, approved August 25, 2002  
2 (Ga. L. 2002, p. 4757), so as to change the corporate limits of the city; to provide for a  
3 referendum; to provide for an effective date; to repeal conflicting laws; and for other  
4 purposes.

5 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

6 style="text-align:center">**SECTION 1.**

7 An Act creating a new charter for the City of Lilburn, approved August 25, 2002 (Ga. L.  
8 2002, p. 4757), is amended by adding a new subsection to Section 1.11 to read as follows:  
9 "(c) In addition to any territory lying within the corporate limits of the City of Lilburn,  
10 such corporate limits shall also include the following properties included in the tax parcels  
11 set forth below as those tax parcels exist on the tax rolls and the tax maps of Gwinnett  
12 County for the year 2010, and all of the public roadways and rights of way adjacent to  
13 those parcels, including railroad rights of way lying adjacent to those parcels or to public  
14 road ways adjacent to those parcels:

166 **SECTION 2.**

167 Unless prohibited by the federal Voting Rights Act of 1965, as amended, the election  
 168 superintendent of Gwinnett County shall call and conduct an election as provided in this  
 169 section for the purpose of submitting this Act to the electors of Gwinnett County who reside  
 170 in the area proposed to be annexed into the City of Lilburn pursuant to Section 1 of this Act  
 171 for approval or rejection. The election superintendent shall conduct that election on the third  
 172 Tuesday in June, 2010, and shall issue the call and conduct that election as provided by

173 general law. The superintendent shall cause the date and purpose of the election to be  
174 published once a week for two weeks immediately preceding the date thereof in the official  
175 organ of Gwinnett County. The ballot shall have written or printed thereon the words:

176 "( ) YES Shall the Act be approved which annexes certain territory into the corporate  
177 ( ) NO limits of the City of Lilburn?"

178 All persons desiring to vote for approval of the Act shall vote "Yes," and all persons desiring  
179 to vote for rejection of the Act shall vote "No." If more than one-half of the total votes cast  
180 on such question are for approval of the Act, it shall become of full force and effect  
181 December 1, 2010. If the Act is not so approved or if the election is not conducted as  
182 provided in this section, the remaining sections of this Act shall not become effective, and  
183 this Act shall be automatically repealed on the first day of January immediately following  
184 that election date. The expense of such election shall be borne by the City of Lilburn. It  
185 shall be the election superintendent's duty to certify the result thereof to the Secretary of  
186 State.

187 **SECTION 3.**

188 Except as provided in Section 2 of this Act, this Act shall become effective upon its approval  
189 by the Governor or upon its becoming law without such approval. If this Act becomes  
190 effective, the clerk for the City of Lilburn shall immediately notify the Secretary of State's  
191 office of this Act's effectiveness. If this Act does not become effective, this Act shall  
192 automatically be repealed.

193 **SECTION 4.**

194 All laws and parts of laws in conflict with this Act are repealed.
