- 4 of the South and was later renamed in honor of our most famous Supreme Court Chief
- 5 Justice; and

- 7 an opportunity law school for nontraditional or adult learners; and
- 8 WHEREAS, Atlanta's John Marshall Law School demonstrates a history of integration and

- 19 opportunities for professional skills education, and provides access to a high-quality program

- 34 education in Georgia.
