

ADOPTED

Senators Mullis of the 53rd and Chance of the 16th offered the following amendment:

1 *Amend the House substitute to SB 519 by substituting "certain definitions" for "the definition*
 2 *of motorized cart" on line 2 and by adding "to allow golf carts to make seasonal deliveries*
 3 *in residential areas;" after "carts;" on line 3.*

4 *By substituting "revising paragraphs (25.1) and (32) and adding new paragraphs to" for*
 5 *"revising paragraph (32)" on line 9.*

6 *By adding between lines 9 and 10 the following:*

7 "(25.1) 'Low-speed vehicle' means any four-wheeled electric vehicle whose top speed
 8 attainable in one mile is greater than 20 miles per hour but not greater than 25 miles per
 9 hour on a paved level surface and which is manufactured in compliance with those
 10 federal motor vehicle safety standards for low-speed vehicles set forth in 49 C.F.R.
 11 Section 571.500 and in effect on January 1, 2001. Low-speed vehicle shall include golf
 12 carts and landscape type vehicles. Either of these types of vehicles could have cargo
 13 platforms or bins to transport parcels or a hitch to tow a trailer and be powered by gas or
 14 electric motors. These vehicles shall not be required to have a vehicle identification
 15 number."

16 *By adding between lines 12 and 13 the following:*

17 "(51.1) 'Residential area' means areas zoned primarily or exclusively for single-family
 18 or multifamily residential use."

19 "(55.1) 'Seasonal delivery personnel' means an employee of a licensed commercial
 20 delivery service that has at least 10,000 employees in this state who is delivering
 21 packages during the shipping period from October 1 to December 31 each year."

22 *By substituting for lines 31 through 44 the following:*

23 (a) ~~Motorized carts may be operated on streets only during daylight hours unless they~~
 24 ~~comply with the equipment regulations promulgated by the commissioner of public safety.~~
 25 ~~Motorized carts may be operated on streets only during daylight hours unless the applicable~~
 26 ~~local government determines that a motorized cart may be operated at night if it complies~~
 27 ~~with the equipment regulations promulgated by that local government. At a minimum, the~~
 28 ~~equipment for motorized carts that may be operated at night shall include operable~~

29 headlights and tail lamps. Motorized carts that may be operated at night which are
30 manufactured after January 1, 2011, shall also be equipped with a horn and side reflectors.
31 (b) Seasonal delivery personnel may use golf carts and landscape type vehicles solely for
32 the purpose of delivering express envelopes and packages that have a maximum size of 130
33 inches for the combined length and girth and weighing not more than 150 pounds.
34 (c) Golf carts and landscape type vehicles may travel on public roads within residential
35 areas with a posted speed limit of 35 miles per hour or less. Operators of golf carts and
36 landscape type vehicles must possess a valid driver's license.
37 (d) Seasonal delivery personnel may pull a trailer from a golf cart or landscape type
38 vehicle provided such vehicles are marked in a conspicuous manner with the name of the
39 delivery service and equipped with the minimum equipment required under this Code
40 section, including, but not limited to, headlights, tail lamps, and any other safety equipment
41 required for operation after sunset."
