

COMMITTEE OF CONFERENCE SUBSTITUTE TO HB 169

A BILL TO BE ENTITLED
AN ACT

1 To amend Title 12 of the Official Code of Georgia Annotated, relating to conservation and
2 natural resources, so as to create the Georgia Geospatial Advisory Council; to provide for its
3 members and purposes; to provide for reports; to provide for automatic repeal; to provide for
4 related matters; to provide for an effective date; to repeal conflicting laws; and for other
5 purposes.

6 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

7 **SECTION 1.**

8 Title 12 of the Official Code of Georgia Annotated, relating to conservation and natural
9 resources, is amended by adding a new Code section to read as follows:

10 "12-5-9.

11 (a) As used in this Code section, the term:

12 (1) 'Director' means the director of the division.

13 (2) 'Division' means the Environmental Protection Division of the department.

14 (b) It is the intent of the General Assembly to provide the general public with access to
15 reliable geospatial data, including but not limited to flood map modernization. Currently,
16 Georgia lacks many of the components which would provide for reliable data such as
17 geospatial coordination and collaboration, policies, standards, state-wide geospatial
18 datasets, current inventory, state-wide license agreements, business and strategic plans,
19 trained work force, data life cycle support, and contract and program management support.

20 (b)(1) In order to provide reliable geospatial data to the public, there shall be created the
21 Georgia Geospatial Advisory Council. The division shall coordinate the creation of such
22 council. The division shall coordinate with state executive branch departments and
23 agencies to appoint members of the council, which may consist of representatives from
24 state departments and agencies, local governments, universities, regional commissions,
25 or any other entity the division determines to be a stakeholder active in the development
26 or consumption of reliable geospatial resources.

27 (2) The council shall meet initially upon the call of the director and shall elect a
28 chairperson at the initial meeting. Subsequent meetings shall be called by the
29 chairperson. The members of the council shall serve at the pleasure of the director.
30 Councilmembers shall receive no compensation for their services as members of the
31 council, but their travel expenses, if any, related to the performance of their official duties
32 may be covered by the departments, agencies, or organizations they represent.

33 (3) The council shall audit Georgia's geospatial capabilities at county, regional, and state
34 levels. The audit shall contain a complete status update and recommendations for
35 utilizing the geospatial capabilities in Georgia to meet Federal Emergency Management
36 Agency notification requirements, recommendations for moving forward to achieve
37 governmental data interoperability and enhanced delivery of services to Georgia citizens
38 through the geospatial approach, and any other information determined by the council to
39 be necessary for the advancement of geospatial technology.

40 (4) The council shall closely coordinate its efforts with the Georgia Technology
41 Authority to ensure compliance with all state and federal standards, contracts, and
42 procedures.

43 (5) The reports generated by the council shall be made available on an annual basis by
44 the department to the members of the General Assembly, all departments and agencies
45 of state government, and all county and municipal governments and shall be posted on
46 the Internet website of the department.

47 (c) The Board of Natural Resources shall promulgate such rules and regulations as may
48 be reasonable and necessary for the administration of this Code section.

49 (d) This Code section shall stand repealed on June 30, 2012."

50 **SECTION 2.**

51 This Act shall become effective on July 1, 2010.

52 **SECTION 3.**

53 All laws and parts of laws in conflict with this Act are repealed.
