- 3 WHEREAS, Mr. William Wesley "Wes" Taylor has served as the principal of Lowndes High
- 4 School in Valdosta, Georgia, since 2003; and
- 5 WHEREAS, as principal, he has numerous accomplishments and been the recipient of
- 6 numerous awards and accolades, including selection as 2010-2011 Principal of the Year by
- 7 the Georgia Association of Secondary School Principals, 2009 Leadership Lowndes
- 8 Graduate, and a finalist for 2009 Secondary Educator of the Year by the Georgia Association
- 9 of Educational Leaders; recipient of the 2008 Distinguished Principal Award by the Georgia
- 10 Association of Secondary School Principals; appointee to the 2008 State School
- 11 Superintendent's Principal Advisory Council; and 2007 graduate of the Georgia School
- 12 Superintendents Association's Superintendent Professional Development Program; and
- 13 WHEREAS, during Mr. Taylor's tenure as principal of Lowndes High School, the school was
- 14 chosen as a Showcase School by the Georgia Partnership for Excellence in Education in
- 15 2008, was selected by the Professional Association of Georgia Educators to participate in the
- 16 High School Redesign Initiative in 2008, was recognized as a Distinguished School by the
- 17 Community Partners in Education in 2008 and 2009, and received Accreditation with
- 18 Distinction from the Southern Association of Colleges and Schools in 2007; and
- 19 WHEREAS, academically, the school has increased its graduation rate by 13 percentage
- 20 points over the last five years, increased the passage rate for the Georgia High School
- 21 Graduation Test, increased the number of students enrolled in Advanced Placement courses,
- 22 increased the number of students scoring three or higher on Advanced Placement exams, and
- 23 consistently maintained End-of-Course Test scores above state averages; and

- 32 WHEREAS, Mr. Taylor is a shining example of the quality educators committed to public
