

House Bill 258 (AS PASSED HOUSE AND SENATE)

A BILL TO BE ENTITLED  
AN ACT

1 To amend Chapter 5 of Title 40 of the Official Code of Georgia Annotated, relating to  
2 drivers' licenses, so as to allow any person 15 years of age or older who has a parent or  
3 guardian who is medically incapable of being licensed to operate a motor vehicle to drive  
4 with the disabled person in the vehicle; to allow a holder of a valid instruction permit to drive  
5 with a disabled guardian or parent who has been issued an identification card containing the  
6 international handicapped symbol; to allow for issuance of a limited driving permit to a  
7 driver between 18 and 21 years old who has his or her license suspended for driving 24 or  
8 more miles per hour but less than 34 miles per hour over the speed limit; to provide for  
9 related matters; to provide for an effective date; to repeal conflicting laws; and for other  
10 purposes.

11 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

12 style="text-align:center">**SECTION 1.**

13 Chapter 5 of Title 40 of the Official Code of Georgia Annotated, relating to drivers' licenses,  
14 is amended by revising subsection (b) of Code Section 40-5-22, relating to the qualifications  
15 for a driver's license, as follows:

16 "(b)(1) Notwithstanding the provisions of subsection (a) of this Code section, any person  
17 14 years of age who has a parent or guardian who is medically incapable of being  
18 licensed to operate a motor vehicle due to visual impairment may apply for and, subject  
19 to the approval of the commissioner, may be issued a restricted noncommercial Class P  
20 instruction permit for the operation of a noncommercial Class C vehicle. Any person  
21 permitted pursuant to this subsection shall be accompanied by such visually impaired  
22 parent or guardian whenever operating a motor vehicle.

23 (2) Notwithstanding the provisions of subsection (a) of this Code section, any person 15  
24 years of age or older who has a parent or guardian who is medically incapable of being  
25 licensed to operate a motor vehicle due to physical impairment and has been issued an  
26 identification card containing the international handicapped symbol pursuant to Article

27 8 of this chapter may apply for and, subject to the approval of the commissioner, may be  
 28 issued a restricted noncommercial Class P instruction permit for the operation of a  
 29 noncommercial Class C vehicle. Any person permitted pursuant to this paragraph shall  
 30 be accompanied whenever operating a motor vehicle by such physically impaired parent  
 31 or guardian or by a person at least 21 years of age who is licensed as a driver for a  
 32 commercial or noncommercial Class C vehicle, who is fit and capable of exercising  
 33 control over the vehicle, and who is occupying a seat beside the driver. The department  
 34 shall require satisfactory proof that the physically impaired parent or guardian previously  
 35 held a valid driver's license in the State of Georgia, another state, or the District of  
 36 Columbia before issuing an instructional permit pursuant to this paragraph."

37 **SECTION 2.**

38 Said chapter is further amended by revising paragraph (1) of subsection (a) of Code  
 39 Section 40-5-24, relating to the issuance of instruction permits, as follows:

40 "(a)(1)(A) Any resident of this state who is at least 15 years of age may apply to the  
 41 department for an instruction permit to operate a noncommercial Class C vehicle. The  
 42 department shall, after the applicant has successfully passed all parts of the examination  
 43 referred to in Code Section 40-5-27 other than the driving test, issue to the applicant an  
 44 instruction permit which shall entitle the applicant, while having such permit in his or  
 45 her immediate possession, to drive a Class C vehicle upon the public highways for a  
 46 period of two years when accompanied by a person at least 21 years of age who is  
 47 licensed as a driver for a commercial or noncommercial Class C vehicle, who is fit and  
 48 capable of exercising control over the vehicle, and who is occupying a seat beside the  
 49 driver.

50 (B) Notwithstanding the provisions of subparagraph (A) of this paragraph, any person  
 51 holding a valid Class C instructional permit may drive a Class C motor vehicle when  
 52 accompanied by a disabled parent or guardian who has been issued an identification  
 53 card containing the international handicapped symbol pursuant to Article 8 of this  
 54 chapter."

55 **SECTION 3.**

56 Said chapter is further amended by revising subsection (a) of Code Section 40-5-64, relating  
 57 to issuance of limited driving permits for certain offenders, as follows:

58 "(a) *To whom issued.*

59 (1) Notwithstanding any contrary provision of Code Section 40-5-57 or 40-5-63 or any  
 60 other Code section of this chapter, any person who has not been previously convicted or  
 61 adjudicated delinquent for a violation of Code Section 40-6-391 within five years, as

62 measured from the dates of previous arrests for which convictions were obtained or pleas  
63 of nolo contendere were accepted to the date of the current arrest for which a conviction  
64 is obtained or a plea of nolo contendere is accepted, may apply for a limited driving  
65 permit when and only when that person's driver's license has been suspended in  
66 accordance with paragraph (2) of subsection (a.1) of Code Section 40-5-22, subsection  
67 (d) of Code Section 40-5-57, paragraph (1) of subsection (a) of Code Section 40-5-63, or  
68 paragraph (1) of subsection (a) of Code Section 40-5-67.2, or subsection (a) of Code  
69 Section 40-5-57.1, when the person is 18 or over and his or her license was suspended for  
70 exceeding the speed limit by 24 miles per hour or more but less than 34 miles per hour,  
71 and the sentencing judge, in his or her discretion, decides it is reasonable to issue a  
72 limited driving permit.  
73 (2) Any person whose driver's license has been suspended and who is subject to a court  
74 order for installation and use of an ignition interlock device as a condition of probation  
75 pursuant to the provisions Article 7 of Chapter 8 of Title 42 may apply for a limited  
76 driving permit."

77 **SECTION 4.**

78 This Act shall become effective on July 1, 2010.

79 **SECTION 5.**

80 All laws and parts of laws in conflict with this Act are repealed.
