## A BILL TO BE ENTITLED AN ACT

To provide a new charter for the City of Waco; to provide for incorporation, boundaries, and
powers of the city within the County of Haralson; to provide for a governing authority of
such city and the powers, duties, authority, election, terms, method of filling vacancies,
compensation, qualifications, prohibitions, and removal from office relative to members of
such governing authority; to provide for inquiries and investigations; to provide for
organization and procedures; to provide for ordinances and codes; to provide for the office
of mayor and certain duties and powers relative to the office of mayor; to provide for
administrative responsibilities; to provide for boards, commissions, and authorities; to
provide for a city attorney, a city clerk, and other personnel; to provide for rules and
regulations; to provide for practices and procedures; to provide for taxation and fees; to
provide for franchises, service charges, and assessments; to provide for bonded and other
indebtedness; to provide for accounting and budgeting; to provide for purchases; to provide
for the sale of property; to provide for bonds for officials; to provide for penalties; to provide
for definitions and construction; to provide for other matters relative to the foregoing; to
repeal a specific Act; to provide for an effective date; to repeal conflicting laws; and for other
purposes.

### BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

20	SECTION 1.01.
21	Name.

- 22 This city and the inhabitants thereof are reincorporated by the enactment of this charter and
- are hereby constituted and declared a body politic and corporate under the name and style

39	Powers and construction.
40	(a) This city shall have all powers possible for a city to have under the present or future
41	constitution and laws of the State of Georgia as fully and completely as though they were
42	specifically enumerated in this charter. This city shall have all the powers of
43	self-government not otherwise prohibited by this charter or by general law.
44	(b) The powers of this city shall be construed liberally in favor of the city. The specific
45	mention or failure to mention particular powers shall not be construed as limiting in any way
46	the powers of this city.
47	SECTION 1.04.
48	Examples of powers.
49	The powers of the city shall include, but are not limited to, the power:
50	(1) Animal regulations. To regulate and license or to prohibit the keeping or running
51	at-large of animals and fowl, and to provide for the impoundment of same if in violation
52	of any ordinance or lawful order; to provide for the disposition by sale, gift, or humane
53	destruction of animals and fowl when not redeemed as provided by ordinance; and to
54	provide punishment for violation of ordinances enacted hereunder:

(2) Appropriations and expenditures. To make appropriations for the support of the

government of the city; to authorize the expenditure of money for any purposes

- otherwise, any real, personal, or mixed property, in fee simple or lesser interest, inside

- property and equipment of the city, and the administration and use of same by the public;
- and to prescribe penalties and punishment for violations thereof;

- of public utilities, including, but not limited to, a system of waterworks, sewers and
- drains, sewage disposal, gas works, electric light plants, cable television and other

To levy and provide for the collection of special assessments 194 195 to cover the costs for any public improvements; (37) Taxes: ad valorem. To levy and provide for the assessment, valuation, revaluation, 196 197 and collection of taxes on all property subject to taxation; (38) Taxes: other. To levy and collect such other taxes as may be allowed now or in the 198 future by law; 199 (39) Taxicabs and other public transportation. To regulate and license vehicles operated 200

for hire in the city; to limit the number of such vehicles; to require the operators thereof

to be licensed; to require public liability insurance on such vehicles in the amounts to be prescribed by ordinance; and to regulate the parking of such vehicles;

(40) Urban redevelopment. To organize and operate an urban redevelopment program; and

(41) Other powers. To exercise and enjoy all other powers, functions, rights, privileges, and immunities necessary or desirable to promote or protect the safety, health, peace, security, good order, comfort, convenience, or general welfare of the city and its inhabitants; and to exercise all implied powers necessary or desirable to carry into execution all powers granted in this charter as fully and completely as if such powers were fully stated herein; and to exercise all powers now or in the future authorized to be exercised by other municipal governments under other laws of the State of Georgia; and no listing of particular powers in this charter shall be held to be exclusive of others, nor restrictive of general words and phrases granting powers, but shall be held to be in addition to such powers unless expressly prohibited to municipalities under the Constitution or applicable laws of the State of Georgia.

**SECTION 1.05.** 

Exercise of powers.

All powers, functions, rights, privileges, and immunities of the city, its officers, agencies, or employees shall be carried into execution as provided by this charter. If this charter makes no provision, such shall be carried into execution as provided by ordinance or as provided by pertinent laws of the State of Georgia.

229 City council creation; number; election.

The legislative authority of the government of this city, except as otherwise specifically provided in this charter, shall be vested in a city council to be composed of a mayor and four councilmembers. The councilmembers shall be elected by city-wide, at large elections. Each duly elected councilmember will occupy a seat on the council to be designated as Post One, Post Two, Post Three, and Post Four, respectively. The city council established shall in all

respects be a successor to and continuation of the governing authority under prior law. The mayor and councilmembers shall be elected in the manner provided by general law and this charter.

The members of the city council shall serve for terms of four years and until their respective successors are elected and qualified. No person shall be eligible to serve as a councilmember unless that person shall be a citizen of the United States of America; have attained the age of 21 years; and have established his or her domicile within the city, so as to be a legal resident of the city, for the 12 consecutive months prior to the first day of the period of time set for qualification as a candidate for the office of councilmember. A duly elected councilmember shall continue to reside within the city during that individual's period of service and shall continue to be registered and qualified to vote in municipal elections of this city.

- 273 (1) Engage in any business or transaction, or have a financial or other personal interest, 274 direct or indirect, which is incompatible with the proper discharge of that person's official 275 duties or which would tend to impair the independence of the official's judgment or action 276 in the performance of those official duties;
- 277 (2) Engage in or accept private employment, or render services for private interests when 278 such employment or service is incompatible with the proper discharge of that person's 279 official duties or would tend to impair the independence of the official's judgment or 280 action in the performance of those official duties;

- 296 (c) Disclosure Any elected official, appointed officer, or employee who shall have any 297 financial interest, directly or indirectly, in any contract or matter pending before or within 298 any department of the city shall disclose such interest to the city council. The mayor or any 299 councilmember who has a financial interest in any matter pending before the city council 300 shall disclose such interest and such disclosure shall be entered on the records of the city 301 council, and that official shall disqualify himself or herself from participating in any decision

or vote relating thereto. Any elected official, appointed officer, or employee of any agency or political entity to which this charter applies who shall have any financial interest, directly or indirectly, in any contract or matter pending before or within such entity shall disclose such interest to the governing body of such agency or entity.

- 306 (d) Use of Public Property No elected official, appointed officer, or employee of the city
- 307 or any agency or entity to which this charter applies shall use property owned by such
- 308 governmental entity for personal benefit, convenience, or profit except in accordance with

337	Inquiries and investigations.

Following the adoption of an authorizing resolution, the city council may make inquiries and investigations into the affairs of the city and the conduct of any department, office, or agency thereof, and for this purpose may subpoena witnesses, administer oaths, take testimony, and require the production of evidence. Any person who fails or refuses to obey a lawful order issued in the exercise of these powers by the city council shall be punished as provided by ordinance. This provision is intended to allow the council to conduct comprehensive investigations of the city's affairs as well as the conduct of any of its departments, offices, or agencies so as to maintain proper legislative oversight of city government. The inquiries and investigations authorized may only be conducted by the council, not individual councilmembers, and only for the purposes of an official investigation.

(a) The city council shall hold an organizational meeting at the first regular meeting in the first full month following the passage and adoption of this charter; provided, however, that the mayor and councilmembers in office at the time of adoption of this charter shall continue in office until that date. The meeting shall be called to order by the city clerk and the oath of office shall be administered to any and all newly elected members as follows:

Organization.

"I do solemnly swear (or affirm) that I will faithfully perform the duties of (mayor)(councilmember) of this city and that I will support and defend the charter thereof as well as the constitution and laws of the State of Georgia and of the United States of America."

(b) By a majority vote, the city council shall elect a councilmember to serve as mayor pro tem. During the absence or physical or mental disability of the mayor for any cause, the mayor pro tem shall be clothed with all the rights and privileges of the mayor and shall perform the duties of the office of the mayor so long as such absence or disability shall continue. Any such absence or disability shall be declared by majority vote of the city council. The mayor pro tem shall sign all contracts and ordinances in which the mayor has a disqualifying financial interest as provided in Section 2.05 of this charter.

376 **SECTION 2.10.** 

Regular and special meetings.

- 378 (a) The city council shall hold regular meetings at such times and places as shall be 379 prescribed by ordinance.
- 380 (b) Special meetings of the city council may be held on call of the mayor or two members 381 of the city council. Notice of such special meetings shall be served on all other members 382 personally, or by telephone personally, at least 24 hours in advance of the meeting. Such 383 notice to councilmembers shall not be required if the mayor and all councilmembers are 384 present when the special meeting is called. Such notice of any special meeting may be 385 waived by a councilmember in writing before or after such a meeting, and attendance at the meeting shall also constitute a waiver of notice on any business transacted in such 386 387 councilmember's presence. Only the business stated in the call may be transacted at the 388 special meeting.
- 389 (c) All meetings of the city council shall be public to the extent required by law and notice 390 to the public of special meetings shall be made fully as is reasonably possible as provided by

396 (a) The city council shall adopt its rules of procedure and order of business consistent with 397 the provisions of this charter and shall provide for keeping a journal of its proceedings, which 398 shall be a public record.

(b) All committees and committee chairs and officers of the city council shall be nominated and appointed by the mayor with the approval of the city council and shall serve at the pleasure of the city council. The mayor shall have the power to recommend and appoint, with the approval of the city council, new members to any committee at any time.

Three councilmembers, or two councilmembers and the mayor, shall constitute a quorum and shall be authorized to transact business of the city council. Voting on the adoption of ordinances shall be by voice vote and the vote shall be recorded in the journal, but any member of the city council shall have the right to request a roll call vote and such vote shall be recorded in the journal. Adoption of the budget shall take the form of an appropriations ordinance setting out the estimated revenues in detail by sources and making appropriations according to fund and by organizational unit, purpose, or activity as set out in the budget preparation ordinance adopted pursuant to Section 5.15 of this charter.
- (c) The amount set out in the adopted operating budget for each organizational unit shall constitute the annual appropriation for such, and no expenditure shall be made or encumbrance created in excess of the otherwise unencumbered balance of the appropriations or allotment thereof, to which it is chargeable.

**SECTION 5.18.** 

Tax levies.

The city council shall levy by ordinance such taxes as are necessary. The taxes and tax rates set by such ordinance shall be such that reasonable estimates of revenues from such levy shall at least be sufficient, together with other anticipated revenues, fund balances, and applicable reserves, to equal the total amount appropriated for each of the several funds set forth in the annual operating budget for defraying the expenses of the general government of this city.

**SECTION 5.19.** 

Changes in appropriations.

The city council by ordinance may make changes in the appropriations contained in the current operating budget at any regular, special, or emergency meeting called for such purpose, but any additional appropriations may be made only from an existing unexpended surplus.

(a) On or before the date fixed by the city council but no later than 45 days prior to the

beginning of each fiscal year, the mayor shall submit to the city council a proposed capital

improvements plan with a recommended capital budget containing the means of financing the improvements proposed for the ensuing fiscal year. The city council shall have power to accept, with or without amendments, or reject the proposed plan and proposed budget. The city council shall not authorize an expenditure for the construction of any building, structure, work, or improvement, unless the appropriations for such project are included in the capital budget, except to meet a public emergency as provided in Section 2.15 of this charter.

(b) The city council shall adopt by resolution or ordinance the final capital budget for the ensuing fiscal year not later than the last day of the month prior to the beginning of a new fiscal year. No appropriation provided for in a prior capital budget shall lapse until the purpose for which the appropriation was made shall have been accomplished or abandoned; provided, however, that the mayor may submit amendments to the capital budget at any time during the fiscal year, accompanied by recommendations. Any such amendments to the capital budget shall become effective only upon adoption by ordinance.

880 SECTION 5.21. 881 Independent audit. 882 There shall be an annual independent audit of all city accounts, funds, and financial transactions by a certified public accountant selected by the city council. The audit shall be 883 conducted according to generally accepted auditing principles. Any audit of any funds by 884 885 the state or federal governments may be accepted as satisfying the requirements of this charter. Copies of annual audit reports shall be available at printing costs to the public. 886 887 PROCUREMENT AND PROPERTY MANAGEMENT 888 SECTION 5.22. Contracting procedures. 889 Except in an emergency situation, no contract with the city in excess of \$15,000.00 shall be 890 binding on the city unless: 891 892 (1) It is in writing; (2) It is drawn by or submitted and reviewed by the city attorney, and as a matter of 893 894 course, is signed by the city attorney to indicate such drafting or review; and 895 (3) It is made or authorized by the city council and such approval is entered in the city 896 council journal of proceedings pursuant to Section 2.11 of this charter; provided, however, that in the event of an emergency, the contract may be submitted to the city 897 898 council at the next regularly scheduled meeting of mayor and city council for review 899 and ratification. 900 SECTION 5.23. 901 Centralized purchasing. The city council shall by ordinance prescribe procedures for a system of centralized 902 purchasing and contracting for the city. 903 904 SECTION 5.24. 905 Sale and lease of city property. 906 (a) The mayor and city council may sell and convey or lease any real or personal property owned or held by the city for governmental or other purposes as now or hereafter provided 907 908 by law. 909 (b) The city council may quitclaim any rights it may have in property not needed for public purposes upon report by the mayor and adoption of a resolution, both finding that the 910

property is not needed for public or other purposes and that the interest of the city has no readily ascertainable monetary value.

(c) Whenever in opening, extending, or widening any street, avenue, alley, or public place of the city, a small parcel or tract of land is cut off or separated by such work from a larger tract or boundary of land owned by the city, the city council may authorize the mayor to sell and convey said cut-off or separated parcel or tract of land to an abutting or adjoining property owner or owners where such sale and conveyance facilitates the enjoyment of the highest and best use of the abutting owner's property. Included in the sales contract shall be a provision for the rights of way of said street, avenue, alley, or public place. Each abutting property owner shall be notified of the availability of the property and given the opportunity to purchase said property under such terms and conditions as set out by ordinance. All deeds and conveyances heretofore and hereafter so executed and delivered shall convey all title and interest the city has in such property, notwithstanding the fact that no public sale after advertisement was or is hereafter made.

929 Bonds for officials.

The officers and employees of this city, both elective and appointive, shall execute such surety or fidelity bonds in such amounts and upon such terms and conditions as the city council shall from time to time require by ordinance or as may be provided by law.

**SECTION 6.02.** 

Existing ordinances, resolutions, rules, and regulations.

All ordinances, resolutions, rules, and regulations now in force in the city not inconsistent with this charter are hereby declared valid and of full effect and force until amended or repealed by the city council.

**SECTION 6.03.** 

939 Existing personnel and officers.

Except as specifically provided otherwise by this charter, all personnel and officers of the city and their rights, privileges, and powers shall continue beyond the time this charter takes

effect for a period of 90 days before or during which the existing city council shall pass a transition ordinance detailing the changes in personnel and appointive officers required or desired and arranging such titles, rights, privileges, and powers as may be required or desired to allow a reasonable transition.

947 Pending matters.

Except as specifically provided otherwise by this charter, all rights, claims, actions, orders, contracts and legal or administrative proceedings shall continue, and any such ongoing work or cases shall be completed by such city agencies, personnel, or offices as may be provided by the city council.

960 Severability.

If any article, section, subsection, paragraph, sentence, or part thereof of this charter shall be held to be invalid or unconstitutional, such invalidity or unconstitutionality shall not affect or impair other parts of this charter unless it clearly appears that such other parts are wholly and necessarily dependent upon the part held to be invalid or unconstitutional, it being the legislative intent in enacting this charter that each article, section, subsection, paragraph, sentence, or part thereof be enacted separately and independent of each other.

968 Repealer.

An Act incorporating the Town of Waco in the County of Haralson, approved August 16,
