## A BILL TO BE ENTITLED AN ACT

- 1 To amend an Act to create a new charter for the town of Dexter, in the county of Laurens,
- 2 State of Georgia, approved August 15, 1910 (Ga. L. 1910, p. 600), as amended, so as to
- 3 change the corporate limits of such municipality; to provide for related matters; to repeal
- 4 conflicting laws; and for other purposes.

## 5 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

6 SECTION 1.

7 An Act to create a new charter for the City of Dexter, in the county of Laurens, State of

8 Georgia, approved August 15, 1910 (Ga. L. 1910, p. 600), as amended, is amended by

9 revising Section 3 as follows:

10 "SECTION 3.

Be it further enacted, that the corporate limits of said town of Dexter shall be one-half mile

in any direction from the depot warehouse on the Wrightsville and Tennille Railroad and,

in addition to the territory included within the existing corporate boundaries of the town

of Dexter, the following described territory shall also be included within the corporate

boundaries of the town of Dexter:

All that tract or parcel of land lying or located in the 344th GMD in Land Lots 154, 177,

and 178 of the 18th Land District of Laurens County, Georgia, being more particularly

described as follows:
