

House Resolution 15

A RESOLUTION

1 Relative to officials, employees, and committees in the House of Representatives; and for
2 other purposes.

3 BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES that the following
4 provisions shall be in effect during the 2009 regular session of the General Assembly of
5 Georgia and for the duration of this General Assembly and until otherwise provided for by
6 resolution of the House:

PART 1.

SECTION 1-1.

9 Subject to the availability of funds appropriated or otherwise available for the House of
10 Representatives, the Speaker of the House is authorized to employ on behalf of the House
11 of Representatives: a sergeant-at-arms, a postmaster or postmistress, assistant postmasters
12 or assistant postmistresses, assistant doorkeepers, pages, aides, secretaries, stenographers,
13 typists, clerks, porters, court reporters, consultants, and other necessary personnel; and the
14 Speaker is authorized to provide offices for staff services for the House of Representatives
15 and to employ personnel for said offices. The numbers and compensation of personnel so
16 employed pursuant to this section shall be fixed by the Speaker within the limitations of
17 funds appropriated or otherwise available for the operation of the House of Representatives.
18 Personnel employed pursuant to this section may be employed on a permanent or temporary
19 basis and on a part-time or full-time basis, as may be determined by the Speaker. The
20 assignment and duties of personnel employed pursuant to this section shall be as determined
21 by the Speaker; and any such personnel may be assigned to House officers, committees,
22 committee officers, caucuses, and caucus officers as deemed appropriate by the Speaker,
23 including without limitation assignment of aides to the Speaker Pro Tempore, the Majority
24 Leader, and the Minority Leader.

25 **SECTION 1-2.**

26 The Speaker is also authorized to secure the services of chaplains and interns and provide
27 expense reimbursement allowances for them within the limitations of funds appropriated or
28 otherwise available.

29 **SECTION 1-3.**

30 The Doorkeeper of the House and the Messenger of the House, who are elected by the
31 House, shall be compensated in an amount to be fixed by the Speaker of the House.

32 **PART 2.**

33 **SECTION 2-1.**

34 Subject to the availability of funds appropriated or otherwise available for the Clerk of the
35 House's office, the Clerk of the House is authorized to employ for the Clerk's office: assistant
36 clerks, reading clerks, calendar clerks, journal clerks, secretaries, copy readers, typists,
37 Multilith operators, Xerox operators, collator operators, porter-machinists, roll-call operators,
38 clerical assistants, terminal operators, camera operators, supply and mail clerks, document
39 distributors, audio operators, porters, personnel to distribute bills and other materials for
40 members, and other necessary personnel. The numbers and compensation of personnel
41 employed pursuant to this section shall be fixed by the Clerk within the limitations of funds
42 appropriated or otherwise available for the operation of the Clerk of the House's office.
43 Personnel employed pursuant to this section may be employed on a permanent or temporary
44 basis and on a part-time or full-time basis, as may be determined by the Clerk. The
45 assignment and duties of personnel employed pursuant to this section shall be as determined
46 by the Clerk.

47 **SECTION 2-2.**

48 Pursuant to the provisions of Code Section 28-3-23 of the Official Code of Georgia
49 Annotated, the salary of the Clerk of the House shall be the same amount the Clerk was
50 receiving at the time of adoption of this resolution by the House. In addition to that amount,
51 the Clerk shall also receive the same percentage salary increase provided in the General
52 Appropriations Act when granted to other employees of the legislative branch of state
53 government. During the Clerk's tenure of office, he or she shall also receive the same
54 expense allowance and the same mileage allowance or travel allowance as received by
55 members of the General Assembly for each day of service rendered by the Clerk.

PART 3.

SECTION 3-1.

58 Subject to the availability of funds appropriated or otherwise available for the operation of
59 the Speaker of the House's Office, the Speaker of the House is authorized to employ interns,
60 aides, secretaries, stenographers, typists, consultants, and other necessary personnel. The
61 numbers and compensation of personnel employed pursuant to this section shall be fixed by
62 the Speaker within the limitations of funds appropriated or otherwise available for the
63 operation of the Speaker of the House's Office. Personnel employed pursuant to this section
64 may be employed on a permanent or temporary basis and on a part-time or full-time basis as
65 may be determined by the Speaker. The assignment and duties of personnel employed
66 pursuant to this section shall be as determined by the Speaker.

PART 4.

SECTION 4-1.

69 During any day or period of time during which the General Assembly is not in session,
70 including without limitation any day or period of adjournment during a regular or special
71 session, each of the following officers shall be a committee of one for each day spent on
72 official business: The Speaker of the House, the Speaker Pro Tempore, the Majority Leader,
73 the Majority Whip, the Minority Leader, the Minority Whip, the Administration Floor
74 Leader, and the Assistant Administration Floor Leaders. For each such day spent on official
75 business each of such officers shall receive the expense, mileage, and travel allowances
76 authorized by law for members of interim committees, provided that the Assistant
77 Administration Floor Leaders shall receive such expense, mileage, and travel allowances
78 only upon the authorization and approval of vouchers by the Administration Floor Leader.

SECTION 4-2.

80 (a) During any day or period of time during which the General Assembly is not in session,
81 including without limitation any day or period of adjournment during a regular or special
82 session, each member of the House of Representatives is designated as a committee of one
83 for the purpose of carrying out legislative duties only within the State of Georgia. For each
84 such day of service, each member shall receive the expense, mileage, and travel allowances
85 authorized by law for legislative members of interim legislative committees but shall not
86 receive the same for more than seven days each year.

87 (b) In addition to the days provided for in subsection (a) of this section and without counting
88 towards the limit specified in said subsection (a), each member of the House is designated

89 as a committee of one for the purpose of carrying out legislative duties on any weekday
90 which: (1) is a one day recess or adjournment during a regular session; and (2) occurs after
91 Monday and prior to Friday. For each such day of service, each member shall receive the
92 expense and travel allowances (not including mileage which shall be covered by the weekly
93 round trip) for legislative members of interim legislative committees, if such member has
94 engaged in legislative business on that day, but not otherwise.

95 **SECTION 4-3.**

96 Pursuant to the provisions of law, in addition to any other compensation they receive as
97 members of the General Assembly, the Majority Leader, the Minority Leader, and the
98 Administration Floor Leader each shall receive an amount of \$2,400.00 per annum, as salary,
99 to be paid in equal monthly or semimonthly installments. Each of the Assistant
100 Administration Floor Leaders shall likewise receive an amount of \$1,200.00 per annum, as
101 salary, to be paid in equal monthly or semimonthly installments. Prior to serving as
102 Administration Floor Leader or as an Assistant Administration Floor Leader, a
103 Representative must be certified as such by the Governor in writing to the Speaker of the
104 House and the Clerk of the House.

105 **PART 5.**

106 **SECTION 5-1.**

107 During any period or day of adjournment during a regular or special session, the Speaker is
108 empowered to give authorization for standing committees of the House and such other
109 committees as the Speaker might create to remain at the Capitol during any such period of
110 time for the purpose of considering and studying proposed legislation and other matters.
111 Members of such committees as shall be designated by the Speaker to remain at the Capitol
112 shall receive the expense, mileage, and travel allowances authorized by law for members of
113 interim committees.

114 **SECTION 5-2.**

115 The Speaker is authorized to appoint committees from the members of the House to serve
116 as interim legislative study committees and for the purpose of performing such duties as the
117 Speaker shall deem necessary. Such committees are authorized to serve during the interim
118 and the members thereof shall receive the expense, mileage, and travel allowances authorized
119 by law for legislative members of interim legislative committees. The Speaker shall
120 designate the chairperson of any such committee and shall prescribe the time for which any
121 such committee is authorized to function. The Speaker is authorized to extend the time

122 allowed for any committee, whether the committee is created by resolution or by the Speaker.
123 The Speaker is authorized to designate standing committees or any subcommittee thereof to
124 function during the interim for the purpose of performing such duties as the Speaker shall
125 deem necessary. The members of any such committee or subcommittee shall receive the
126 expense, mileage, and travel allowances authorized by law for legislative members of interim
127 legislative committees.

128 **PART 6.**

129 **SECTION 6-1.**

130 The funds necessary to carry out the provisions of Parts 1, 4, and 5 of this resolution shall
131 come from funds appropriated or otherwise available for the operation of the House of
132 Representatives. The funds necessary to carry out the provisions of Part 2 of this resolution
133 shall come from funds appropriated or otherwise available for the operation of the Clerk of
134 the House's office. The funds necessary to carry out the provisions of Part 3 of this resolution
135 shall come from funds appropriated or otherwise available for the operation of the Speaker
136 of the House's Office.

137 **SECTION 6-2.**

138 Any personnel employed pursuant to this resolution shall serve at the pleasure of the
139 appointing authority; and any such personnel may be discharged by the appointing authority
140 with or without cause.

141 **SECTION 6-3.**

142 This resolution shall take effect immediately upon its adoption by the House of
143 Representatives.
