

Senate Resolution 6

ADOPTED SENATE**A RESOLUTION**

1 Relative to officials, employees, and committees in the Senate; and for other purposes.

2 **BE IT RESOLVED BY THE SENATE** that the following provisions shall be in effect during
3 the 2009 regular session and thereafter until otherwise provided for by resolution of the
4 Senate:

PART I**SECTION 1-1.**

7 Subject to the availability of funds appropriated or otherwise available for the Senate, the
8 Senate Committee on Administrative Affairs is authorized to employ on behalf of the Senate:
9 a postmaster or postmistress, assistant doorkeepers, a director of pages, pages, aides,
10 secretaries, clerks, court reporters, consultants, and other necessary personnel; and the Senate
11 Committee on Administrative Affairs is authorized to provide for a Senate Research Office,
12 a Senate Budget and Evaluation Office, and a Senate Press Office, including a Senate
13 Photographer, and to employ personnel for said offices. The numbers and compensation of
14 personnel so employed pursuant to this section shall be fixed by the Senate Committee on
15 Administrative Affairs within the limitations of funds appropriated or otherwise available for
16 the operation of the Senate. Personnel employed pursuant to this section may be employed
17 on a permanent or temporary basis and on a part-time or full-time basis, as may be
18 determined by the Senate Committee on Administrative Affairs. The assignment and duties
19 of personnel employed pursuant to this section shall be as determined by the Senate
20 Committee on Administrative Affairs; and any such personnel may be assigned to Senate
21 officers, committees, and committee officers as deemed appropriate by the Senate Committee
22 on Administrative Affairs. The Senate Committee on Administrative Affairs is authorized
23 to purchase stationery and postage for use by Senators in the conduct of Senate business.

24 **SECTION 1-2.**

25 The Senate Committee on Administrative Affairs is also authorized to secure the services of
26 chaplains and interns and provide expense reimbursement allowances for them within the
27 limitations of funds appropriated or otherwise available.

28 **SECTION 1-3.**

29 The Sergeant-at-Arms of the Senate, who is elected by the Senate, shall be compensated in
30 an amount to be fixed by the Senate Committee on Administrative Affairs.

31 **PART II**

32 **SECTION 2-1.**

33 Subject to the availability of funds appropriated or otherwise available for the Secretary of
34 the Senate's Office, the Secretary of the Senate is authorized to employ for the Secretary's
35 office: an assistant secretary, reading clerks, bill clerks, enrolling and engrossing clerks,
36 calendar clerks, journal clerks, administrative assistants, secretaries, copy readers, typists,
37 Multilith operators, Xerox operators, collator operators, clerical assistants, terminal
38 operators, document distributors, personnel to distribute bills and other materials for
39 members, and other necessary personnel. The numbers and compensation of personnel
40 employed pursuant to this section shall be fixed by the Secretary within the limitations of
41 funds appropriated or otherwise available for the operation of the Secretary of the Senate's
42 Office. Personnel employed pursuant to this section may be employed on a permanent or
43 temporary basis and on a part-time or full-time basis, as may be determined by the Secretary.
44 The assignment and duties of personnel employed pursuant to this section shall be as
45 determined by the Secretary.

46 **SECTION 2-2.**

47 Pursuant to the provisions of Code Section 28-3-23 of the Official Code of Georgia
48 Annotated, the annual salary of the Secretary of the Senate shall be in the same amount as
49 in effect immediately prior to the adoption of this resolution. In addition to that amount, the
50 Secretary shall also receive the same percentage salary increase provided in the General
51 Appropriations Act when granted to other employees of the legislative branch of state
52 government.

PART III

SECTION 3-1.

55 Subject to the availability of funds appropriated or otherwise available for the operation of
56 the President of the Senate's Office, the President of the Senate is authorized to employ in
57 the President of the Senate's office: interns, aides, secretaries, consultants, and other
58 necessary personnel. The numbers and compensation of personnel employed pursuant to this
59 section shall be fixed by the President of the Senate within the limitations of funds
60 appropriated or otherwise available for the operation of the President of the Senate's Office.
61 Personnel employed pursuant to this section may be employed on a permanent or temporary
62 basis and on a part-time or full-time basis. The duties of personnel employed pursuant to this
63 section shall be as determined by the President of the Senate.

PART IV

SECTION 4-1.

66 During any day or period of time during which the General Assembly is not in session,
67 including without limitation any day or period of adjournment during a regular or special
68 session, each of the following officers shall be a committee of one for each day spent on
69 official business: the President Pro Tempore, the Majority Leader, and the Minority Leader.
70 For each such day spent on official business each of such officers shall receive the expense,
71 mileage, and travel allowances authorized by law for members of interim legislative
72 committees. Each such officer shall provide with his or her claim for such allowances for
73 each such day a brief statement of the nature of the official business carried out on such day.
74 These officers shall not be subject to Section 5-3 (limit on number of days).

SECTION 4-2.

76 (a) During any day or period of time during which the General Assembly is not in session,
77 including without limitation any day or period of adjournment during a regular or special
78 session, each other member of the Senate is designated as a committee of one for the purpose
79 of carrying out legislative duties only within the State of Georgia. Subject to any limits
80 established pursuant to Section 5-3, for each such day of service, each member shall receive
81 the expense, mileage, and travel allowances authorized by law for legislative members of
82 interim legislative committees. Each such member shall provide with his or her claim for
83 such allowances for each such day a brief statement of the nature of the legislative duties
84 carried out on such day.

85 (b) In addition to the days provided for in subsection (a) of this section and without counting
86 towards the limit specified in said subsection (a), each member of the Senate is designated
87 as a committee of one for the purpose of carrying out legislative duties on any weekday
88 which: (1) is a one-day recess or adjournment during a regular session; and (2) occurs after
89 Monday and prior to Friday. For each such day of service, each member shall receive the
90 expense and travel allowances (not including mileage which shall be covered by the weekly
91 round trip) for legislative members of interim legislative committees. Each such member
92 shall provide with his or her claim for such day a brief statement of the nature of the
93 legislative duties carried out on such day.

94 **SECTION 4-3.**

95 Pursuant to the provisions of law, in addition to any other compensation they receive as
96 members of the General Assembly, the President Pro Tempore, the Majority Leader, and the
97 Minority Leader each shall receive an amount of \$2,400.00 per annum, as salary, to be paid
98 in equal monthly or semimonthly installments; and each Administration Floor Leader shall
99 receive an amount of \$1,200.00 per annum, as salary, to be paid in equal monthly or
100 semimonthly installments.

101 **PART V**

102 **SECTION 5-1.**

103 During any period or day of adjournment during a regular or special session, the President
104 of the Senate is empowered to give authorization for standing committees of the Senate and
105 such other committees as the President of the Senate might create to remain at the Capitol
106 during any such period of time for the purpose of considering and studying proposed
107 legislation and other matters. Members of such committees as shall be designated by the
108 President of the Senate to remain at the Capitol shall receive the expense, mileage, and travel
109 allowances authorized by law for members of interim committees.

110 **SECTION 5-2.**

111 The President of the Senate is authorized to appoint committees from the members of the
112 Senate to serve as interim legislative study committees and for the purpose of performing
113 such duties as he or she shall deem necessary. Such committees are authorized to serve
114 during the interim and the members thereof shall receive the expense, mileage, and travel
115 allowances authorized by law for legislative members of interim legislative committees. The
116 President of the Senate shall designate the chairperson of any such committee and shall
117 prescribe the time for which any such committee is authorized to function. The President of

118 the Senate is authorized to extend the time allowed for any committee, whether the
119 committee is created by resolution or by the President of the Senate. The chairperson of any
120 standing committee is empowered to authorize his or her committee or any standing
121 subcommittee of his or her committee to function during the interim for the purpose of
122 performing such duties as the chairperson shall deem necessary. The members shall receive
123 the expense, mileage, and travel allowances authorized by law for legislative members of
124 interim legislative committees.

125 **SECTION 5-3.**

126 The Senate Committee on Administrative Affairs shall be authorized to set limits on the
127 number of days that a member shall receive the allowances authorized in Sections 4-2
128 (committee of one) and 5-2 (committee meetings during interim). For this purpose a year
129 shall begin on the opening day of a regular session and end on the day prior to the next
130 opening day.

131 **PART VI**

132 **SECTION 6-1.**

133 The funds necessary to carry out the provisions of Parts 1, 4, and 5 of this resolution shall
134 come from funds appropriated or otherwise available for the operation of the Senate. The
135 funds necessary to carry out the provisions of Part 2 of this resolution shall come from funds
136 appropriated or otherwise available for the operation of the Secretary of the Senate's Office.
137 The funds necessary to carry out the provisions of Part 3 of this resolution shall come from
138 funds appropriated or otherwise available for the operation of the President of the Senate's
139 Office.

140 **SECTION 6-2.**

141 Any personnel employed pursuant to this resolution shall serve at the pleasure of the
142 appointing authority; and any such personnel may be discharged by the appointing authority
143 with or without cause.

144 **SECTION 6-3.**

145 This resolution shall take effect immediately upon its adoption by the Senate.
