A BILL TO BE ENTITLED AN ACT

1	To amend Title 47 of the Official Code of Georgia Annotated, relating to retirement and
2	pensions, so as to provide that venue in any action brought against the boards of trustees of
3	the Employees' Retirement System of Georgia, the Public School Employees Retirement
4	System, the Georgia Legislative Retirement System, the Georgia Defined Contribution Plan,
5	the Georgia Judicial Retirement System, and the Georgia Military Pension Fund shall lie in
6	the Superior Court of Fulton County; to repeal conflicting laws; and for other purposes.
7	BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8	SECTION 1.
9	Title 47 of the Official Code of Georgia Annotated, relating to retirement and pensions, is
10	amended by revising Code Section 47-2-25, relating to the legal adviser of the board of
11	trustees of the Employees' Retirement System of Georgia, as follows:
12	"47-2-25.
13	(a) The Attorney General shall be the legal advisor adviser of the board of trustees.
14	(b) Any action against the retirement system shall be brought in the Superior Court of
15	Fulton County, Georgia, and such court shall have exclusive, original jurisdiction of such
16	actions."
17	SECTION 2.
18	Said title is further amended by revising Code Section 47-4-24, relating to the legal adviser
19	of the Board of Trustees of the Public School Employees Retirement System, as follows:
20	"47-4-24.
21	(a) The Attorney General shall be the legal advisor adviser of the board.
22	(b) Any action against the retirement system shall be brought in the Superior Court of
23	Fulton County, Georgia, and such court shall have exclusive, original jurisdiction of such
24	actions."

28	(a) The Attorney General shall be the legal adviser of the board.

31	SECTION 4.
32	Said title is further amended by revising Code Section 47-22-6, relating to the legal adviser
33	of the Georgia Defined Contribution Plan, as follows:

35	(a) The Attorney General shall be the legal advisor adviser of the board.
36	(b) Any action against the board shall be brought in the Superior Court of Fulton County,
37	Georgia, and such court shall have exclusive, original jurisdiction of such actions."

40	of the Board of Trustees of the Georgia Judicial Retirement System, as follows:
