1 Commending Edwin Howard (Buddy) Gratton, Jr., on his retirement from the Department

2 of Transportation; and for other purposes.

WHEREAS, Edwin Howard (Buddy) Gratton, Jr., resides in Lawrenceville, Georgia, with
his wife, Karen, and daughters, Kelsey and Samantha; and

5 WHEREAS, Buddy Gratton graduated from the University of Florida in 1982 with a
6 Bachelor of Science degree in Civil Engineering, and, in 1986, he earned a Master of Science

7 degree in Civil Engineering (Structures) from the Georgia Institute of Technology; and

8 WHEREAS, he joined the Georgia Department of Transportation in 1983, serving as a
9 Bridge Design Engineer 2, 3, and 4 before being named State Bridge Maintenance Engineer

10 in 1993; and

11 WHEREAS, he was instrumental in conducting and managing the safety inspections and

12 subsequent reopenings of hundreds of middle and south Georgia bridges affected by flooding

13 associated with Tropical Storm Alberto in 1994; and

14 WHEREAS, he was named Assistant State Maintenance Engineer in 1996 and, in 1999, was

15 appointed Executive Assistant to the Chief Engineer and then State Maintenance Engineer;

17 WHEREAS, Buddy Gratton quickly rose through the ranks as Metro Atlanta District18 Engineer and Director of Preconstruction; and

- 19 WHEREAS, he successfully administered the letting to construction of some 90 interstate
- 20 highway intersection improvement projects valued at more than \$330 million between 2000
- 21 and 2004; and

- 22 WHEREAS, in September of 2006, in recognition of his achievement, sound judgment, and
- 23 leadership, he was selected to be the Deputy Commissioner of the department; and
- 24 WHEREAS, during his 26 years with the department, his responsibilities have included
- 25 oversight of the Division of Field Districts, the Division of Equal Employment Opportunity,
- 26 the Division of Operations, which included the Offices of Maintenance, Traffic Operations,
- 27 Utilities and Equipment Management, and the Office of State Aid Administration; and
- 28 WHEREAS, during his career, he also oversaw the Offices of Environment and Location,
- 29 Right of Way, Road Design, Urban Design, Consultant Design/Program Delivery, Bridge
- 30 Design and Office of Communications, Human Resources, and the Division of Information
- 31 Technology; and
- 32 WHEREAS, Buddy Gratton is a Registered Professional Engineer and is a member of the
- 33 American Society of Civil Engineers, the Georgia DOT Engineers Association, and the
- 34 Georgia Partners for Transportation Quality Initiative Steering Committee; and
- 35 WHEREAS, Buddy Gratton has conducted himself throughout his career with the utmost 36 professionalism and integrity, helping to guide the department through its challenges,
- 37 including developing and bringing to fruition quality initiatives; and
- 38 WHEREAS, his career has been notable for his tireless devotion to the department and its 39 employees as well as to the citizens of Georgia, and his leadership will be greatly missed.
