A BILL TO BE ENTITLED
AN ACT

1 To amend Subpart 1 of Part 6 of Article 6 of Chapter 2 of Title 20 of the Official Code of
2 Georgia Annotated, relating to certificated professional personnel under the "Quality Basic
3 Education Act," so as to revise certain provisions relating to the Georgia Master Teacher
4 Program; to provide for a bonus for teachers receiving a Master Teacher Certification; to
5 establish a Distinguished Teacher Leader Certification; to provide for criteria; to provide for
6 applications; to provide for a bonus for teachers receiving a Distinguished Teacher Leader
7 Certification; to provide for automatic certification renewal of Master Teachers' and
8 Distinguished Teacher Leaders' teaching certificates; to provide for related matters; to repeal
9 conflicting laws; and for other purposes.

10 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

12 Subpart 1 of Part 6 of Article 6 of Chapter 2 of Title 20 of the Official Code of Georgia
13 Annotated, relating to certificated professional personnel under the "Quality Basic Education
14 Act," is amended by revising Code Section 20-2-205, relating to the Georgia Master Teacher
15 Program, as follows:

16 "20-2-205.

17 (a) The General Assembly finds that excellent public school teachers deserve recognition
18 for the extraordinary learning opportunity they provide to Georgia students.

19 (b) The Professional Standards Commission is authorized and directed to establish the
20 'Georgia Master Teacher and Distinguished Teacher Leader Program' to provide
21 recognition to certificated public school teachers who exhibit excellence in the classroom.

22 (c)(1) The Professional Standards Commission shall establish criteria for a Master
23 Teacher Certification. Such criteria shall include, at a minimum, evidence of student
24 achievement, which must include student progress. Such criteria may also include, at the
25 discretion of the Professional Standards Commission, mentoring, department chair
26 position, or other requirements. A public school teacher with three or more years of

27 teaching experience in Georgia may submit an application to the Professional Standards
28 Commission for a Master Teacher Certification. The Professional Standards Commission
29 shall review each application and determine whether a teacher meets the criteria for a
30 Master Teacher Certification. If the Professional Standards Commission finds that a
31 teacher's application meets the criteria, the teacher ~~will~~ shall be given a Master Teacher
32 Certification, and that teacher ~~will~~ shall be known as and may be called a Master Teacher
33 for a term to be determined pursuant to rules and regulations of the Professional
34 Standards Commission, but in no event longer than ~~seven~~ five years. The Professional
35 Standards Commission is authorized to develop rules and regulations governing the
36 Master Teacher Certification.

37 (2) On and after June 30, 2010, each teacher receiving a Master Teacher Certification
38 pursuant to this subsection shall receive a bonus equal to 10 percent of such teacher's
39 state salary each year such certification is in force. This paragraph shall be subject to
40 appropriations from the General Assembly.

41 (d)(1) The Professional Standards Commission shall establish criteria for a Distinguished
42 Teacher Leader Certification. Such criteria shall include, at a minimum, a Master
43 Teacher Certification; a master's degree or higher in a content field, curriculum and
44 instruction, or a related field; a teacher leader endorsement from the Professional
45 Standards Commission; and a recommendation by the teacher's principal or peer faculty.
46 Such criteria may also include, at the discretion of the Professional Standards
47 Commission, mentoring, department chair position, or other requirements. A public
48 school teacher with five or more years of teaching experience in Georgia may submit an
49 application to the Professional Standards Commission for a Distinguished Teacher Leader
50 Certification. The Professional Standards Commission shall review each application and
51 determine whether a teacher meets the criteria for a Distinguished Teacher Leader
52 Certification. If the Professional Standards Commission finds that a teacher's application
53 meets the criteria, the teacher shall be given a Distinguished Teacher Leader
54 Certification, and that teacher shall be known as and may be called a Distinguished
55 Teacher Leader for a term to be determined pursuant to rules and regulations of the
56 Professional Standards Commission, but in no event longer than five years. The
57 Professional Standards Commission is authorized to develop rules and regulations
58 governing the Distinguished Teacher Leader Certification.

59 (2) On and after June 30, 2010, each teacher receiving a Distinguished Teacher Leader
60 Certification pursuant to this subsection shall receive a bonus equal to 15 percent of such
61 teacher's state salary each year such certification is in force. This paragraph shall be
62 subject to appropriations from the General Assembly.

63 (e) A teacher receiving a Master Teacher Certification or Distinguished Teacher Leader
64 Certification pursuant to this Code section shall have automatic certification renewal of
65 such teacher's teaching certificate issued by the Professional Standards Commission
66 pursuant to Code Section 20-2-200 during the term the Master Teacher Certification or
67 Distinguished Teacher Leader Certification is in force.

68 ~~(d) This Code section shall be repealed on June 30, 2009."~~

70 All laws and parts of laws in conflict with this Act are repealed.
