AS PASSED SENATE

A BILL TO BE ENTITLED

AN ACT

1 To amend Part 3 of Article 16 of Chapter 2 of Title 20 of the Official Code of Georgia
2 Annotated, relating to student health in elementary and secondary education, so as to provide
3 for possession and self-administration of auto-injectable epinephrine by students; to provide
4 for a definition; to provide for local board of education policies; to provide for requirements
5 and conditions; to provide for disciplinary action for misuse of auto-injectable epinephrine;
6 to provide for limited liability; to provide for related matters; to repeal conflicting laws; and
7 for other purposes.

8 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

9 **SECTION 1.**

10 Part 3 of Article 16 of Chapter 2 of Title 20 of the Official Code of Georgia Annotated,
11 relating to student health in elementary and secondary education, is amended by adding a
12 new Code section to read as follows:

13 "20-2-776.

14 (a) As used in this Code section, the term 'auto-injectable epinephrine' means a disposable
15 drug delivery device that is easily transportable and contains a premeasured single dose of
16 epinephrine used to treat life-threatening allergic reactions.

17 (b) Each local board of education shall adopt a policy authorizing a student to carry and
18 self-administer prescription auto-injectable epinephrine. Such policy shall provide that in
19 order to carry and self-administer prescription auto-injectable epinephrine, the student's
20 parent or guardian shall provide:

21 (1) A written statement from a physician licensed under Chapter 34 of Title 43 detailing
22 the name of the medication, method, amount, and time schedules by which the
23 medication is to be taken, and confirming that the student is able to self-administer
24 auto-injectable epinephrine; and

25 (2) A written statement by the parent or guardian consenting to the self-administration,
26 providing a release for the school nurse or other designated school personnel to consult
27 with the physician regarding any questions that may arise with regard to the medication,
28 and releasing the school system and its employees and agents from civil liability if the

29 self-administering student suffers an adverse reaction as a result of self-administering
30 auto-injectable epinephrine pursuant to this Code section.

31 The written statements specified in this subsection shall be provided at least annually and
32 more frequently if the medication, dosage, frequency of administration, or reason for
33 administration changes.

34 (c) The policy adopted pursuant to subsection (b) of this Code section shall include
35 provisions to protect the safety of all students from the misuse or abuse of auto-injectable
36 epinephrine.

37 (d) Any student who is authorized for self-administration of epinephrine pursuant to this
38 Code section may possess and use auto-injectable epinephrine:

39 (1) While in school;

40 (2) At a school sponsored activity;

41 (3) While under the supervision of school personnel; or

42 (4) While in before-school or after-school care on school operated property.

43 (e) A student may be subject to disciplinary action if he or she uses auto-injectable
44 epinephrine in a manner other than as prescribed.

45 (f) A local school system and its employees and agents shall incur no liability other than
46 for willful or wanton misconduct for any injury to a student caused by his or her use of
47 auto-injectable epinephrine."

48 **SECTION 2.**

49 All laws and parts of laws in conflict with this Act are repealed.
