A RESOLUTION

- 1 Urging the Board of Trustees and the president of Georgia Military College to maintain the
- 2 current military programs at the military junior college of Georgia, Georgia Military College;
- 3 and for other purposes.
- 4 WHEREAS, Georgia Military College is a public independent junior college within the State
- 5 of Georgia; and
- 6 WHEREAS, in 1950, Georgia Military College was designated as a United States
- 7 Department of the Army Military Junior College, and today, it continues to accept a mission
- 8 of developing military leaders; and
- 9 WHEREAS, Georgia Military College is one of only five colleges in the United States
- authorized to award a commission as a 2nd Lieutenant in just two years time; and
- WHEREAS, Georgia Military College has been designated by the United States Military
- 12 Academy at West Point as one of only five preparatory colleges in the United States; and
- 13 WHEREAS, the Georgia General Assembly finds that it is essential for our national defense
- 14 to encourage citizens in considering military leadership positions as honorable and rewarding
- 15 professions; and
- 16 WHEREAS, Georgia Military College's military training programs are providing valuable
- 17 assets to the Georgia National Guard, the Army Reserves, and to active United States Army
- 18 forces; and
- 19 WHEREAS, a diverse junior college, Georgia Military College is coeducational and offers
- 20 students a variety of clubs, student organizations, activities, and character development
- 21 opportunities; and

WHEREAS, Georgia Military College takes great pride in alumni that include the former

- 23 Secretary of Labor in the Ford Administration; former Deputy Postmaster General; former
- 24 United States Congressman and Chairman of the House of Naval Affairs Committee and
- 25 later Chairman of the House Armed Services Committee; former Governor of the State of
- 26 Georgia; numerous Georgia General Assembly Senators and Representatives; many local
- 27 government officials; and untold numbers of general officers and others who have served our
- 28 country honorably during combat, disaster-relief, and other peacetime operations; and
- 29 WHEREAS, one distinction, however, separates Georgia Military College from every other
- 30 junior college in this state: the school's military science program; and
- 31 WHEREAS, the military science program at Georgia Military College has a history of
- 32 excellence and prominence not only in this state but also throughout this country and around
- 33 the world; and
- 34 WHEREAS, it is in the best interests of this state to preserve the military science and military
- 35 commissioning programs at Georgia Military College.
- 36 NOW, THEREFORE, BE IT RESOLVED BY THE GENERAL ASSEMBLY OF
- 37 GEORGIA that this body hereby urges the Board of Trustees and the president of Georgia
- 38 Military College to maintain the current military program at the military junior college of
- 39 Georgia, Georgia Military College.
- 40 BE IT FURTHER RESOLVED that Georgia Military College is hereby designated as the
- 41 State of Georgia's Military Junior College.
- 42 BE IT FURTHER RESOLVED that the Secretary of the Senate is authorized and directed
- 43 to transmit an appropriate copy of this resolution to the Board of Trustees and the president
- 44 of Georgia Military College.
