

House Resolution 282

A RESOLUTION

1 Supporting the goals and ideals of a National Epidermolysis Bullosa Awareness Week to
2 raise public awareness and understanding of epidermolysis bullosa, recognizing the need for
3 a cure for the disease, and encouraging the people of this state and interested groups to
4 support the week; and for other purposes.

5 WHEREAS, epidermolysis bullosa is a rare disease characterized by the presence of
6 extremely fragile skin that results in the development of recurrent, painful blisters, open
7 sores, and, in some forms of the disease, disfiguring scars, disabling musculoskeletal
8 deformities, and internal blistering; and

9 WHEREAS, approximately 12,500 individuals in the United States are affected by the
10 disease; and

11 WHEREAS, data from the National Epidermolysis Bullosa Registry indicate that of every
12 one million live births, 20 infants are born with the disease; and

13 WHEREAS, there currently is no cure for the disease; and

14 WHEREAS, children with the disease require almost around-the-clock care; and

15 WHEREAS, approximately 90 percent of individuals with epidermolysis bullosa report
16 experiencing pain on an average day; and

17 WHEREAS, the skin is so fragile for individuals with the disease that even minor rubbing
18 and day-to-day activity may cause blistering, including from activities such as writing,
19 eating, walking, and from the seams on their clothes; and

20 WHEREAS, most individuals with the disease have inherited the disease through genes they
21 receive from one or both parents; and

22 WHEREAS, epidermolysis bullosa is so rare that many health care practitioners have never
23 heard of it or seen a patient with it; and

24 WHEREAS, individuals with epidermolysis bullosa often feel isolated because of the lack
25 of knowledge about the disease and the impact that it has on the body; and

26 WHEREAS, more funds should be dedicated toward research to develop treatments and
27 eventually a cure for the disease; and

28 WHEREAS, the last week of October would be an appropriate time to recognize National
29 Epidermolysis Bullosa Week in order to raise public awareness about the prevalence of
30 epidermolysis bullosa, the impact it has on families, and the need for additional research into
31 a cure for the disease.

32 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES that
33 the members of this body:

34 (1) Support the goals and ideals of a National Epidermolysis Bullosa Awareness Week to
35 raise public awareness and understanding of epidermolysis bullosa;

36 (2) Recognize the need for a cure for the disease; and

37 (3) Encourage the people of this state and interested groups to support the week through
38 appropriate ceremonies and activities to promote public awareness of epidermolysis bullosa
39 and to foster understanding of the impact of the disease on patients and their families.
