## A RESOLUTION

- 1 Recognizing and commending Ms. Kay Whithear; and for other purposes.
- 2 WHEREAS, Ms. Kay Whithear has served as executive director of Lilburn Cooperative  
3 Ministry since the organization's creation in 1994; and
- 4 WHEREAS, Lilburn Cooperative Ministry was founded by four churches in the Lilburn  
5 community in order to pool resources for outreach ministries and have a greater impact upon  
6 the Lilburn area; and
- 7 WHEREAS, over the years, Lilburn Cooperative Ministry has grown and expanded, moving  
8 from its original location in a small house it shared with Habitat for Humanity at Mountain  
9 Park United Methodist Church to its current location, with room to accommodate all the  
10 ministry's needs; and
- 11 WHEREAS, Lilburn Cooperative Ministry's mission is to give maximum support to clients  
12 while allowing them to maintain their dignity and self worth by assisting with their utility  
13 bills, medical expenses, and food costs and providing spiritual support; and
- 14 WHEREAS, now a collaborative effort of over 40 churches in the Lilburn area, Lilburn  
15 Cooperative Ministry has given clients over \$2,000,000.00 in services and aid; and
- 16 WHEREAS, a major project organized by Lilburn Cooperative Ministry each month, with  
17 the help of local girl scout and boy scout troops, the Lilburn Post Office, and Providence  
18 Christian Academy, is a food drive which has provided over 1,000 tons of food to families  
19 in need; and
- 20 WHEREAS, under the leadership and vision of Ms. Whithear, Lilburn Cooperative Ministry  
21 opened Lily's Cloak Thrift Store in 1999, which has generated nearly \$1 million in revenue  
22 since its decade-long existence; and

23 WHEREAS, Ms. Whithear's significant organizational and leadership talents, her remarkable  
24 patience and diplomacy, her keen sense of vision, and her sensitivity to the needs of the  
25 citizens of this state have earned her the respect and admiration of her colleagues and  
26 associates; and

27 WHEREAS, it is abundantly fitting and proper that the outstanding accomplishments of Ms.  
28 Whithear as executive director of Lilburn Cooperative Ministry be appropriately recognized.

29 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES that  
30 the members of this body commend Ms. Kay Whithear for her efficient, effective, unselfish,  
31 and dedicated public service to Lilburn Cooperative Ministry.
