A BILL TO BE ENTITLED  
AN ACT

1 To amend Chapter 1 of Title 28 of the Official Code of Georgia Annotated, relating to  
2 general provisions applicable to the General Assembly, so as to authorize the use of process  
3 to secure the attendance of witnesses and the production of documents before legislative  
4 committees; to provide for service, witness fees, and records; to provide for criminal failure  
5 to respond to a subpoena or answer questions and punishment therefor; to provide for other  
6 related matters; to repeal conflicting laws; and for other purposes.

7 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 **SECTION 1.**

9 Chapter 1 of Title 28 of the Official Code of Georgia Annotated, relating to general  
10 provisions applicable to the General Assembly, is amended by adding a new Code section  
11 to read as follows:

12 "28-1-18.

13 (a) As used in this Code section, the term 'committee' includes any standing committee of  
14 the General Assembly established by rules of the Senate or House of Representatives, any  
15 subcommittee of any such standing committee, and any interim committee established by  
16 resolution of the Senate or House of Representatives, by joint resolution, or by order of the  
17 President of the Senate or the Speaker of the House of Representatives; provided, however,  
18 that the term shall not include any interim committee which does not have members of the  
19 General Assembly as a majority of the members of the interim committee.

20 (b) Process in the form of a subpoena may be issued by any committee to secure the  
21 attendance of a witness, the production of documents, or both. The issuance of process  
22 shall be authorized by vote of the committee and carried out by the chairperson of the  
23 committee following such authorization.

24 (c) Service of subpoenas issued under this Code section shall be made by any person  
25 appointed for such purpose by the presiding officer of the Senate or the House of  
26 Representatives.

27 (d) Witnesses appearing under subpoena shall be entitled to witness fees as provided in  
28 Code Section 24-10-24. In the case of a person who resides outside of Fulton County,  
29 service of a subpoena under this Code section shall be accompanied by the tender of a  
30 witness fee and mileage in the same amounts as specified under Code Section 24-10-24.  
31 The legislative fiscal officer shall issue checks for this purpose upon requisition of the  
32 chairperson issuing the subpoena, and tender of payment in the form of a check so issued  
33 shall suffice to validate the service.

34 (e) The Secretary of the Senate and the Clerk of the House of Representatives shall  
35 provide subpoena forms and shall keep permanent records of the issuance of subpoenas,  
36 the return of service thereof, and the issuance of certifications under paragraph (2) of  
37 subsection (f) of this Code section.

38 (f)(1) Any person who willfully fails to comply with a subpoena under this Code section  
39 or who, having appeared, refuses to answer any question pertinent to the question under  
40 inquiry shall upon conviction be guilty of a misdemeanor.

41 (2) Upon the failure of a person under subpoena to appear or answer pertinent questions,  
42 the chairperson issuing the subpoena shall make a certification of such fact to the  
43 appropriate prosecuting attorney who shall have the duty to promptly investigate and  
44 prosecute any violation of this Code section."

45 **SECTION 2.**

46 All laws and parts of laws in conflict with this Act are repealed.
