A BILL TO BE ENTITLED

AN ACT

1 To amend Titles 26 and Title 43 of the Official Code of Georgia Annotated, relating to food,
2 drugs, and cosmetics and to professions and businesses, respectively, so as to clarify that the
3 applications submitted for certain professions and businesses are to be made in the form
4 prescribed and not necessarily as a written document; to change provisions relating to
5 examinations to obtain a license to engage in the practice of pharmacy; to change certain
6 provisions relating to the general powers of the division director; to change certain provisions
7 relating to veteran examinations; to provide for notification of current laws, rules, and
8 regulations and standards of conduct relating to the practice of architecture; to provide that
9 the service upon the division director on behalf of the State Board of Barbers or the State
10 Board of Physical Therapy shall be at his or her office; to change certain provisions
11 regarding the training, utilization, and licensing of apprentices in barbershops; to revise
12 certain provisions relating to the record of revocation of chiropractic licenses; to change
13 certain provisions relating to the rules and regulations as to sanitary requirements and
14 inspections relative to cosmetologists; to revise certain requirements for application for
15 low-voltage electrical contracting licenses; to require the examination for the land
16 surveyor-in-training certificate be board approved; to change provisions as to notice of
17 meetings of the State Board of Hearing Aid Dealers and Dispensers; to revise the general
18 powers and duties of the State Board of Hearing Aid Dealers and Dispensers and the division
19 director; to change certain provisions relating to the issuance of licenses relative to hearing
20 aid dealers and dispensers; to amend provisions relating to the qualifications and examination
21 of hearing aid dispenser apprentices; to provide for notice to the hearing aid dealer licensee
22 or permit holder; to change certain provisions relating to fees for licensure of landscape
23 architects; to provide that applicants for licensure as dispensing opticians may be required
24 to pass a board approved examination; to change certain provisions relating to examinations
25 and examination fees relative to dispensing opticians; to amend certain provisions as to
26 continuing education requirements relative to license renewals of dispensing opticians; to
27 change certain provisions relating to examinations for licenses to practice podiatric medicine;
28 to change certain provisions relating to the examination of applicants and appeals relative to

29 psychologists; to change certain provisions relating to the test an applicant for a used motor
 30 vehicle and parts dealer license must pass; to provide for board approved examinations for
 31 applicants for certification as operators or laboratory analysts of treatment plants; to provide
 32 for related matters; to provide for an effective date; to repeal conflicting laws; and for other
 33 purposes.

34 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

35 **SECTION 1.**

36 Title 26 of the Official Code of Georgia Annotated, relating to food, drugs, and cosmetics,
 37 is amended by revising subsections (a) and (b) of Code Section 26-4-41, relating to
 38 qualifications for license, examination, and internships and other training programs relative
 39 to pharmacists and pharmacies, as follows:

40 "(a) *Qualifications.* To obtain a license to engage in the practice of pharmacy, an applicant
 41 for licensure by examination shall:

42 (1) Have submitted a ~~written~~ an application in the form prescribed by the board;

43 (2) Have attained the age of majority;

44 (3) Be of good moral character;

45 (4) Have graduated and received a professional undergraduate degree from a college or
 46 school of pharmacy as the same may be approved by the board; provided, however, that,
 47 since it would be impractical for the board to evaluate a school or college of pharmacy
 48 located in another country, the board may accept a graduate from such a school or college
 49 as so long as the graduate has completed all requirements of the Foreign Pharmacy
 50 Equivalency Certification Program administered by the National Association of Boards
 51 of Pharmacy. This shall include successful completion of all required examinations and
 52 the issuance of the equivalency certificate and be based upon an individual evaluation by
 53 the board of the applicant's educational experience, professional background, and
 54 proficiency in the English language;

55 (5) Have completed an internship or other program that has been approved by the board
 56 or demonstrated to the board's satisfaction that experience in the practice of pharmacy
 57 which meets or exceeds the minimum internship requirements of the board;

58 (6) Have successfully passed an examination or examinations approved by the board;
 59 and

60 (7) Have paid the fees specified by the board for the examination and any related
 61 materials and have paid for the issuance of the license.

62 (b) *Examinations.*

63 (1) The examination for licensure required under paragraph (6) of subsection (a) of this
 64 Code section shall be made available ~~by the board~~ at least two times during each year.
 65 ~~The board shall determine the content and subject matter of each examination, and the~~
 66 ~~place, time, and date of administration of the examination;~~

67 (2) The examination shall be prepared to measure the competence of the applicant to
 68 engage in the practice of pharmacy. The board may employ, cooperate, and contract with
 69 any organization or consultant in the preparation and grading of an examination, but shall
 70 retain the sole discretion and responsibility for determining which applicants have
 71 successfully passed such an examination; ~~and.~~

72 (3) Any person who takes the board approved examination and fails the examination may
 73 repeat the examination at regular intervals of administration; however, a person may not
 74 take the examination more than three times without permission from the board. A person
 75 who has taken the board approved examination and failed the examination for the third
 76 time may not practice as a pharmacy intern. A person who takes the board approved
 77 examination and successfully completes the examination must become licensed within
 78 two years of the examination date or the results of the examination shall become invalid."

79

SECTION 2.

80 Said title is further amended by revising subsection (c) of Code Section 26-4-42, relating to
 81 license transfers for pharmacists licensed in another jurisdiction relative to pharmacists and
 82 pharmacies, as follows:

83 "(c) To obtain a license to engage in the practice of pharmacy in this state, a pharmacist
 84 who is a graduate of a pharmacy school or college located in another country must
 85 complete all requirements of the Foreign Pharmacy Equivalency Certification Program
 86 administered by the National Association of Boards of Pharmacy. This shall include
 87 without being limited to successful completion of all required examinations and the
 88 issuance of the equivalency certificate, and an individual evaluation by the board of the
 89 applicant's proficiency in the English language. Additionally, a foreign pharmacy graduate
 90 applicant shall:

- 91 (1) Have submitted ~~a written~~ an application in the form prescribed by the board;
 92 (2) Have attained the age of majority;
 93 (3) Be of good moral character;
 94 (4) Have possessed at the time of initial licensure as a pharmacist all qualifications
 95 necessary to have been eligible for licensure at that time in this state;

- 96 (5) Have graduated and been granted a pharmacy degree from a college or school of
 97 pharmacy recognized by the National Association of Boards of Pharmacy Foreign
 98 Pharmacy Graduate Examination Committee;
 99 (6) Have successfully passed an examination approved by the board; and
 100 (7) Have paid the fees specified by the board."

101 **SECTION 3.**

102 Said title is further amended by revising subsection (a) of Code Section 26-4-46, relating to
 103 pharmacy interns, eligibility, and requirements for licenses, as follows:

104 "(a) To obtain a license as a pharmacy intern, an applicant shall:

- 105 (1) Have submitted ~~a written~~ an application in the form prescribed by the board of
 106 pharmacy;
 107 (2) Have attained the age of majority;
 108 (3) Be of good moral character; and
 109 (4) Have paid the fees specified by the board for the issuance of the license."

110 **SECTION 4.**

111 Title 43 of the Official Code of Georgia Annotated, relating to professions and businesses,
 112 is amended by revising subsection (j) of Code Section 43-1-2, relating to appointment and
 113 general powers of division director, members and meetings of professional licensing boards,
 114 examination standards, roster of licenses, and funding, as follows:

115 "(j) The division director ~~shall~~ may establish administrative standards for the examination
 116 of applicants for licensure by the various professional licensing boards, notwithstanding
 117 any other provisions of law to the contrary. These administrative standards ~~shall~~ may
 118 include the setting of date, time, and location of examinations, subject to the approval of
 119 the respective professional licensing boards. Notwithstanding any other provisions of law
 120 to the contrary, examination criteria, examination grading procedures, examination fees,
 121 examination passing score requirements, and other matters pertaining to the examination
 122 of applicants for licensure may be adopted by rules of the respective professional licensing
 123 boards as necessary to implement such examination standards. Examination standards,
 124 including examination criteria, grading procedures, and passing score requirements,
 125 developed in agreement or in conjunction with a national association of state boards or
 126 other related national association for the administration of a nationally recognized uniform
 127 examination may be adopted in lieu of state standards by the respective professional
 128 licensing boards."

129 **SECTION 5.**

130 Said title is further amended by revising Code Section 43-1-9, relating to point credit for
131 veterans taking examination given by professional licensing boards, as follows:

132 "43-1-9.

133 Any applicant taking an examination ~~given~~ required by any professional licensing board
134 except the State Board of Accountancy shall receive points in the following manner:

135 (1) Any applicant who served on active duty in the armed forces of the United States or
136 on active duty in a reserve component of the armed forces of the United States, including
137 the National Guard, for a period of one year or more, of which at least 90 days were
138 served during wartime or during any conflict when military personnel were committed
139 by the President of the United States, shall be entitled to a credit of five points. Such
140 points shall be added by the person grading the examination to the grade made by the
141 applicant in answering the questions propounded in any such examination;

142 (2) Any applicant who is a disabled veteran and who served on active duty in the armed
143 forces of the United States or on active duty in a reserve component of the armed forces
144 of the United States, including the National Guard, during wartime or during any conflict
145 when military personnel were committed by the President of the United States shall be
146 entitled to a credit of five points if the disability was for an injury or illness incurred in
147 the line of duty and such disability is officially rated at less than 10 percent at the time
148 of taking the examination. Such points shall be added by the person grading the
149 examination to the grade made by the applicant in answering the questions propounded
150 in any such examination; and

151 (3) Any applicant who is a disabled veteran who served on active duty in the armed
152 forces of the United States or on active duty in a reserve component of the armed forces
153 of the United States, including the National Guard, during wartime or during any conflict
154 when military personnel were committed by the President of the United States shall be
155 entitled to a credit of ten points if the disability was for an injury or illness incurred in the
156 line of duty and such disability is officially rated at 10 percent or above at the time of
157 taking the examination. Such points shall be added by the person grading the
158 examination to the grade made by the applicant in answering questions propounded in
159 any such examination."

160 **SECTION 6.**

161 Said title is further amended by revising Code Section 43-1-10, relating to credit to veteran's
162 grades when examination given in parts or by subject, as follows:

163 "43-1-10.

164 If an examination given by a professional licensing board is ~~given~~ required in parts or by
 165 subjects and the applicant is required to make a minimum grade on each of the parts or
 166 subjects, the points to which the applicant is entitled shall be added to the grade made on
 167 each part or subject before the average of his or her grade on all of the parts or subjects is
 168 determined."

169 **SECTION 7.**

170 Said title is further amended by revising Code Section 43-1-11, relating to veteran's
 171 examination to be graded prior to determination of eligibility for credit, as follows:

172 "43-1-11.

173 A person grading an examination ~~given~~ required by a professional licensing board shall
 174 first grade the examination without reference to veteran credit, determining thereafter from
 175 the proof submitted whether an applicant is a veteran and is entitled to such credit; if so,
 176 the credit shall be added; and if after such addition the applicant equals or exceeds the
 177 grade required to pass the examination, the applicant shall be entitled to be certified as
 178 having passed the examination."

179 **SECTION 8.**

180 Said title is further amended by revising subsection (b) of Code Section 43-4-9, relating to
 181 adoption of rules, regulations, and standards of conduct and utilization of the Internet relative
 182 to architects, as follows:

183 "(b) The board shall post all current laws, rules, regulations, and standards of conduct
 184 relating to the practice of architecture in this state on the board's official website. The
 185 board shall also provide on the website notification of recent changes in such laws, rules,
 186 regulations, or standards and information pertaining to disciplinary actions taken by the
 187 board. ~~Individual notice of changes in such laws, rules, regulations, or standards shall be
 188 sent by the board at least once a year to each registered architect and building official.
 189 Individual notice may be sent by e-mail or regular mail."~~

190 **SECTION 9.**

191 Said title is further amended by revising Code Section 43-7-7, relating to board meetings,
 192 secretary of the board, service of process and documents, and records relative to barbers, as
 193 follows:

194 "43-7-7.

195 The board shall meet at least six days a year but shall not meet more than 36 days in one
 196 year. All meetings shall be open to the public except that the board may hold restricted
 197 attendance sessions to prepare, give, and grade examinations and to deliberate in
 198 connection with the decision in a contested case. The division director shall be secretary
 199 of the board and, in addition to his or her duties as prescribed by Code Section 43-1-3, shall
 200 perform such other administrative duties as may be prescribed by the board. All legal
 201 process and all documents required by law to be served upon or filed with the board shall
 202 be served upon or filed with the division director at his or her office ~~in Atlanta~~. All official
 203 records of the board, or affidavits by the division director as to the content of such records,
 204 shall be prima-facie evidence of all matters required to be kept therein."

205 **SECTION 10.**

206 Said title is further amended by revising Code Section 43-7-12 , relating to requirements for
 207 license to operate a barbershop, as follows:

208 "43-7-12.

209 A license to operate a barbershop shall be issued, renewed, or restored to any person who
 210 can show that such barbershop:

- 211 (1) Provides and maintains such physical and sanitary facilities and equipment as may
 212 be required by the rules and regulations of the board;
- 213 ~~(2) Does not train more than one apprentice at any one time, which apprentice shall be~~
 214 ~~under the supervision of a master barber~~ Trains and utilizes apprentices in a manner and
 215 number as required by the board; and
- 216 (3) Does business only at the location shown on the application for licensure."

217 **SECTION 11.**

218 Said title is further amended by revising subsection (a) of Code Section 43-7-16 , relating to
 219 requirement for license as apprentice barber and limitation on renewal, as follows:

220 "(a) A license to practice barbering as an apprentice shall be issued to any person applicant
 221 who shall furnish the board evidence that such applicant:

- 222 (1) ~~Evidence that he will~~ Will practice under the supervision of a licensed barber with
 223 at least 18 months' experience in the practice of barbering; and
- 224 (2) ~~Evidence that he has completed the fifth grade of school instruction or its equivalent~~
 225 Is 16 years of age or older."

226 **SECTION 12.**

227 Said title is further amended by revising subsections (a), (b), and (c) of Code Section 43-9-7,
 228 relating to qualifications of applicants for license to practice chiropractic, as follows:

229 "(a) Any person wishing to practice chiropractic in this state shall make ~~written~~ application
 230 to the board through the division director in such form as may be adopted and directed by
 231 the board.

232 (b) ~~Application shall be in writing and shall be signed by the applicant in his own~~
 233 ~~handwriting; shall be sworn to before some officer authorized under the laws to administer~~
 234 ~~oaths; The application~~ shall recite the history of the applicant's educational qualifications,
 235 how long he has studied chiropractic, what collateral branches, if any, he has studied, and
 236 the length of time he has engaged in clinical practice, with proof thereof in the form of
 237 diplomas, certificates, etc.; and shall accompany the application with satisfactory evidence
 238 of good character and reputation.

239 (c) Each applicant shall ~~send~~ provide with his application an application fee in an amount
 240 established by the board."

241 **SECTION 13.**

242 Said title is further amended by revising Code Section 43-9-14, relating to record of license
 243 revocation relating to chiropractors, as follows:

244 "43-9-14.

245 ~~In all cases wherein a license has been revoked and no appeal has been taken within the~~
 246 ~~time allowed by law, it shall be the duty of the division director, immediately after the~~
 247 ~~expiration of the time allowed for appeal, to transmit to the clerk of the superior court in~~
 248 ~~whose office the revoked license is recorded a copy of the order of the board revoking the~~
 249 ~~license, certified by the division director, and it shall be the duty of the clerk to cancel the~~
 250 ~~record of the license by entering upon the face thereof a copy of the certified order. In cases~~
 251 ~~wherein appeal proceedings are had and not sustained, the revoked license shall be~~
 252 ~~canceled in the manner provided in this Code section immediately after the final~~
 253 ~~termination of such case. Reserved."~~

254 **SECTION 14.**

255 Said title is further amended by revising Code Section 43-10-6, relating to rules and
 256 regulations as to sanitary requirements, instruction on HIV and AIDS, inspections, and
 257 unsanitary conditions as nuisances relative to cosmetologists, as follows:

258 "43-10-6.

259 (a) The board is authorized to adopt reasonable rules and regulations prescribing the
 260 sanitary requirements of beauty shops, beauty salons, schools of cosmetology, schools of

261 esthetics, schools of hair design, and schools of nail care, subject to the approval of the
 262 Department of Human Resources, and to cause the rules and regulations or any subsequent
 263 revisions to be in suitable form, ~~and to transmit a copy thereof~~ The board shall make the
 264 rules and regulations available to the proprietor of each beauty shop, beauty salon, school
 265 of cosmetology, school of esthetics, school of hair design, or school of nail care. It shall
 266 be the duty of every proprietor or person operating a beauty shop, salon, school of
 267 cosmetology, school of esthetics, school of hair design, and school of nail care in this state
 268 to keep a copy of such rules and regulations posted in a conspicuous place in his or her
 269 business, so as to be easily read by his or her customers.

270 (b) The board is authorized to adopt reasonable rules and regulations requiring that persons
 271 licensed under this chapter undergo instruction on Human Immunodeficiency Virus and
 272 Acquired Immune Deficiency Syndrome.

273 (c) Any inspector employed by the ~~division director~~ Secretary of State shall have the
 274 power to enter and make reasonable examination of any beauty shop, salon, and school in
 275 the state during business hours for the purpose of enforcing the rules and regulations of the
 276 board and for the purpose of ascertaining the sanitary conditions thereof.

277 (d) Any beauty shop, salon, or school in which tools, appliances, and furnishings used
 278 therein are kept in an unclean and unsanitary condition so as to endanger health is declared
 279 to be a public nuisance."

280 SECTION 15.

281 Said title is further amended by revising subsection (c) of Code Section 43-14-8.1, relating
 282 to license requirement for low-voltage electrical contracting, businesses conducted by
 283 partnerships, limited liability companies, and corporations, and applications relative to
 284 electrical contracting, as follows:

285 "(c) Any person desiring to qualify under the provisions of this subsection who meets the
 286 requirements of this subsection, submits proper application prior to and including
 287 December 31, 1984, and pays or has paid the required fees and is not otherwise in violation
 288 of this chapter shall be issued a state-wide Low-voltage Contractor Class LV-A, LV-G,
 289 LV-U, or LV-T license without examination. An individual desiring to obtain Low-voltage
 290 Contractor Class LV-T shall submit to the division an affidavit ~~sworn before a notary~~
 291 ~~public~~ which outlines the experience of said individual in the practice of low-voltage
 292 wiring relating to telecommunication systems. An individual desiring to obtain a
 293 Low-voltage Contractor Class LV-A license shall submit to the division an affidavit, ~~sworn~~
 294 ~~before a notary public~~, which outlines the experience of said individual in the practice of
 295 low-voltage wiring relating to alarm systems. An individual desiring to obtain a
 296 Low-voltage Contractor Class LV-G license shall submit to the division an affidavit, ~~sworn~~

297 ~~before a notary public~~, which outlines the experience of said individual in the practice of
 298 low-voltage wiring relating to general systems. Each such affidavit for licensure shall
 299 describe in detail the installation of at least three complete low-voltage wiring jobs which
 300 shall demonstrate that the individual has successfully performed low-voltage wiring in the
 301 area of licensure requested for a period of at least one year immediately prior to the time
 302 of application. An individual desiring to obtain a Low-voltage Contractor Class LV-U
 303 license shall submit to the division an affidavit, ~~sworn before a notary public~~, which
 304 outlines the experience of said individual in the practice of low-voltage wiring relating to
 305 alarm and telecommunication systems and which describes in detail the installation of at
 306 least six complete low-voltage wiring jobs, three in alarm and three in telecommunication
 307 systems, which shall demonstrate that the individual has successfully performed
 308 low-voltage wiring in those areas for a period of at least one year immediately prior to the
 309 time of application."

310

SECTION 16.

311 Said title is further amended by revising Code Section 43-15-12, relating to land
 312 surveyor-in-training certificate and eligibility, as follows:

313 "43-15-12.

314 To be eligible for certification as a land surveyor-in-training, an applicant must meet the
 315 following minimum requirements:

- 316 (1)(A) Earn a bachelor's degree in a curriculum approved by the board; ~~or~~
 317 (B) Earn an associate degree, or its equivalent, in a curriculum approved by the board
 318 and acquire not less than two years of combined office and field experience in land
 319 surveying of a nature satisfactory to the board; or
 320 (C) Earn a high school diploma, or its equivalent, and acquire not less than four years'
 321 experience in land surveying of a nature satisfactory to the board; ~~and~~
 322 (2) Acquire a minimum of 15 quarter hours' credit, or its equivalent, in land surveying
 323 subjects in a course of study approved by the board; provided, however, that on and after
 324 January 1, 1995, the minimum requirement shall be 20 quarter hours' credit, five of which
 325 shall be in hydrology; and
 326 (3) Subsequently pass the ~~board's written~~ board approved examination in the
 327 fundamentals of land surveying (land surveyor-in-training examination)."

328

SECTION 17.

329 Said title is further amended by revising subsection (c) of Code Section 43-18-41, relating
 330 to qualifications of embalmer or funeral director applicants, as follows:

331 "(c) In addition to the qualifications set out in subsection (a) of this Code section, an
 332 applicant for a funeral director's license shall have, prior to the issuance of said license, a
 333 valid embalmer's license; shall furnish an affidavit which lists the names of the 50 funerals
 334 at which the apprentice assisted as provided in Code Section 43-18-50; and, effective
 335 January 1, 1991, must pass ~~a written~~ an examination approved by the board which tests
 336 knowledge of the law of this state relating to funeral directors."

337 **SECTION 18.**

338 Said title is further amended by revising paragraph (1) of subsection (a) Code Section
 339 43-18-42, relating to reciprocity and examination upon meeting qualifications relative to
 340 funeral directors and establishments, as follows:

341 "(1)(A) On or after January 1, 1991, such person successfully passes ~~a written~~ an
 342 examination approved by the board which tests knowledge of the law of this state
 343 relating to funeral directors; and

344 (B) Such person satisfied in another state, territory, country, or District of Columbia
 345 the requirements for licensure which are:

346 (i) In effect in Georgia on the date of application; or

347 (ii) Substantially equal to the requirements for a similar license in Georgia; or"

348 **SECTION 19.**

349 Said title is further amended by revising subsection (b) of Code Section 43-20-5, relating to
 350 meetings, reimbursement of members, and notice of meetings relating to the State Board of
 351 Hearing Aid Dealers and Dispensers, as follows:

352 "(b) The division director shall notify each member of the board ~~by certified mail or~~
 353 ~~statutory overnight delivery~~ not less than ten days in advance of the time and place of any
 354 meeting of the board."

355 **SECTION 20.**

356 Said title is further amended by revising Code Section 43-20-6, relating to general powers
 357 and duties of the State Board of Hearing Aid Dealers and Dispensers and the division
 358 director, as follows:

359 "43-20-6.

360 (a) The board shall have the responsibility and duty of administering and enforcing this
 361 chapter. ~~The board shall be responsible for preparing the examinations required by this~~
 362 ~~chapter, and the division director shall assist the board in carrying out this chapter.~~ The
 363 board shall have the power to establish and to revise minimal procedure and equipment
 364 requirements which shall be used in the dispensing of hearing aids.

365 (b) The board shall:

366 ~~(1) Authorize, with the advice of the division director, all disbursements necessary to~~
 367 ~~carry out this chapter and the rules and regulations promulgated by the board;~~

368 ~~(2)~~(1) Supervise the issuance of licenses and administer qualifying examinations;

369 ~~(3)~~(2) License persons who make proper application to the division director and who
 370 meet the qualifications for licensure;

371 ~~(4) Purchase and maintain or rent facilities necessary to carry out the examination of~~
 372 ~~applicants as provided in this chapter;~~

373 ~~(5)~~(3) Issue and renew licenses;

374 ~~(6)~~(4) Suspend, revoke, or otherwise sanction licenses in the manner provided in this
 375 chapter;

376 ~~(7)~~(5) Appoint representatives to conduct or supervise examinations; and

377 ~~(8)~~(6) Provide to each licensed dealer Make available to the public a copy of this chapter,
 378 any amendments thereto, and all adopted rules.

379 (c) The division director shall be guided by the recommendations of the board in all
 380 matters relating to this chapter and shall assist the board in carrying out this chapter.

381 (d) In the administration and enforcement of this chapter, the board shall have the power
 382 to adopt reasonable rules and regulations not inconsistent with this chapter and the
 383 Constitution and laws of this state or of the United States for governing its times and places
 384 of meetings; for organization and reorganization; for the holding of examinations; for
 385 governing all other matters requisite to the exercising of its powers; for the performance
 386 of its duties relating to examinations; for granting, suspending, revoking, or otherwise
