A BILL TO BE ENTITLED
AN ACT

1 To amend Title 32 of the Official Code of Georgia Annotated, relating to highways, bridges,
2 and ferries, so as to enact the "Transforming Transportation Investment Act"; to abolish the
3 State Road and Tollway Authority; to create the State Transportation Agency and the State
4 Transportation Authority; to provide for short titles; to provide for definitions; to provide for
5 purposes of the authority; to provide for transition of duties, responsibilities, functions,
6 powers, and jurisdiction; to provide for membership; to provide for a quorum and filling of
7 vacancies; to provide for powers of the authority; to provide for expenditure of funds; to
8 provide for collection of tolls; to provide for air quality standards within certain geographic
9 areas; to provide for delegation by the Governor of certain powers to the authority; to provide
10 for developments of regional impact; to provide for cooperation with the Georgia Rail
11 Passenger Authority and the Georgia Environmental Facilities Authority; to provide for the
12 awarding of contracts; to provide for the transfer of property to the authority; to provide for
13 the disposition of revenue; to provide for liberal construction of provisions; to provide for
14 a streetcar pilot project; to provide for the issuance of revenue bonds; to provide for the
15 issuance of guaranteed revenue bonds; to provide for the disposition of revenue from bonds;
16 to provide for the replacement of lost bonds; to provide that revenue bonds are not debts of
17 the State of Georgia; to provide tax exemption for the revenue bonds; to provide venue for
18 proceedings on bonds; to amend Chapter 32 of Title 50 of the Official Code of Georgia
19 Annotated, relating to the Georgia Regional Transportation Authority, so as to abolish said
20 authority; to correct cross-references; to provide for related matters; to provide for effective
21 dates; to repeal conflicting laws; and for other purposes.

22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

23 **SECTION .1.**

24 This Act shall be known and may be cited as the "Transforming Transportation Investment
25 Act."

26 **PART I**

27 Provisions Applicable

28 to the

29 Department of Transportation

30 and the

31 State Transportation Board

32 **SECTION 1-1.**

33 Title 32 of the Official Code of Georgia Annotated, relating to highways, bridges, and ferries,
34 is amended by revising paragraphs (21) and (27) and by adding new paragraphs (10.1),
35 (26.1), (27.2), and (27.3) in Code Section 32-1-3, relating to definitions, as follows:

36 "(10.1) 'Federal Public Transportation Fund' means the fund established in Code Section
37 32-5-2."

38 "(21) 'Private road' means a privately owned road or way, including any bridge thereon,
39 which is only open for the benefit of one or more individuals and not for the general
40 public. This term also means a road which lies on privately owned land. The term does
41 not include any road or road facility built under the terms of a public-private partnership
42 agreement with a state agency or any political subdivision of the state."

43 "(26.1) 'Secretary of transportation' means the state's chief executive officer for
44 transportation and shall be the secretary of the State Transportation Authority selected
45 pursuant to subsection (d) of Code Section 32-12-5."

46 "(27) 'State agency' means any authority, division, department, instrumentality, branch,
47 or other body of the state to which state governmental functions have been delegated."

48 "(27.2) 'State Public Transportation Fund' means the fund established Code Section
49 32-5-20.

50 (27.3) 'State Transportation Authority' means the authority established in Chapter 12 of
51 this title to plan and coordinate transportation projects in the state."

52 **SECTION 1-2.**

53 Said title is further amended in Code Section 32-1-8, relating to construction and
54 maintenance of private roads, by revising said Code section as follows:

55 "32-1-8.

56 It shall be unlawful for any official, officer, or employee of the department, the State Road
57 and Tollway Authority ~~Transportation~~ Authority, the Georgia Highway Authority, or any
58 similar authority or of any county or municipality to authorize the construction or
59 maintenance of any private road."

60 **SECTION 1-3.**

61 Said title is further amended in Code Section 32-2-1, relating to the composition of the
62 Department of Transportation, by revising said Code section as follows:

63 "32-2-1.

64 The Department of Transportation shall consist of the ~~State Transportation Board, the~~
65 ~~commissioner of transportation, the deputy commissioner of transportation, the chief~~
66 ~~engineer, the treasurer and the assistant treasurer~~ commissioner of transportation, and such
67 subordinate employees as may be deemed necessary by the commissioner. The primary
68 purpose of the department is to provide for maintenance and repairs to the state highway
69 system. Subject to approval of plans and approval or award of funding by the State
70 Transportation Agency or the State Transportation Authority by grant, agreement, or order,
71 the department shall improve, construct, maintain, or repair the state public highway
72 system. Subject to approval of plans and approval or award of funding by the State
73 Transportation Agency or the State Transportation Authority, the department and other
74 state or local entities or political subdivisions may contract for the department to improve,
75 construct, maintain, and repair roads and bridges."

76 **SECTION 1-4.**

77 Said title is further amended in Code Section 32-2-2, relating to powers and duties of the
78 Department of Transportation, by revising paragraphs (1), (2), (5), (7), and (19) of subsection
79 (a) and subsection (b) as follows:

80 "(1) Subject to approval of the State Transportation Authority, the ~~The~~ department shall
81 ~~plan, designate, may~~ improve, manage, control, construct, and maintain a state highway
82 system and ~~shall have control of and~~ responsibility for ~~all~~ certain construction,
83 maintenance, or ~~any~~ other work upon the state highway system and all other work which
84 may be designated to be done by the department by this title or any other law. However,
85 on those portions of the state highway system lying within the corporate limits of any
86 municipality, the department shall be required to provide only substantial maintenance
87 activities and operations, including but not limited to reconstruction and major
88 resurfacing, reconstruction of bridges, erection and maintenance of official department
89 signs, painting of striping and pavement delineators, furnishing of guardrails and bridge
90 rails, and other major maintenance activities; and, furthermore, the ~~department~~ State
91 Transportation Authority may by contract authorize and require any rapid transit
92 authority created by the General Assembly to plan, design, and construct, at no cost to the
93 ~~department~~ authority and subject to the ~~department's~~ authority's review and approval of
94 design and construction, segments of the state highway system necessary to replace those
95 portions of the system which the rapid transit authority and the ~~department~~ State

96 Transportation Authority agree must be relocated in order to avoid conflicts between the
 97 rapid transit authority's facilities and the state highway system;

98 ~~(2) Except for appropriations to authorize the issuance of general obligation debt for~~
 99 ~~public road work, or to pay such debt, the department shall be the state agency to receive~~
 100 ~~and shall have control and supervision of all funds appropriated for public road work by~~
 101 ~~the state and activities incident thereto from the net proceeds of motor fuel tax, as~~
 102 ~~provided in Article III, Section IX, Paragraph VI(b) of the Constitution of Georgia and~~
 103 ~~any other funds appropriated or provided for by law for such purposes or for performing~~
 104 ~~other functions of the department. If the General Assembly fails to appropriate all of the~~
 105 ~~net proceeds of the motor fuel tax to the department, to the State of Georgia General~~
 106 ~~Obligation Debt Sinking Fund, and to counties for public road work and activities~~
 107 ~~incident thereto, any such unappropriated part of such funds, exclusive of those proceeds~~
 108 ~~required by law to be provided as grants to counties for the construction and maintenance~~
 109 ~~of county roads, shall be made available to the department by the director of the Office~~
 110 ~~of Treasury and Fiscal Services, notwithstanding any provisions to the contrary in Part~~
 111 ~~1 of Article 4 of Chapter 12 of Title 45, the 'Budget Act' Reserved;~~"

112 "(5) The department, subject to approval of the State Transportation Authority, shall have
 113 the authority to negotiate, let, and enter into contracts with the Georgia Highway
 114 Authority, the State Road and Tollway Authority Transportation Authority, any person,
 115 any state agency, or any county or municipality of the state for the construction or
 116 maintenance of any public road or any other mode of transportation or for the benefit of
 117 or pertaining to the department or its employees in such manner and subject to such
 118 express limitations as may be provided by law;"

119 ~~"(7) The department and the State Road and Tollway Authority shall be the proper~~
 120 ~~agencies of the state to discharge all duties imposed on the state by any act of Congress~~
 121 ~~allotting federal funds to be expended for public road and other transportation purposes~~
 122 ~~in this state. Upon delegation or approval by the State Transportation Agency or the State~~
 123 ~~Transportation Authority, the ~~The~~ department shall have the authority to accept and use~~
 124 ~~federal funds; to enter into any contracts or agreements with the United States or its~~
 125 ~~agencies or subdivisions relating to the planning, financing, construction, improvement,~~
 126 ~~operation, and maintenance of any public road or other mode or system of transportation;~~
 127 ~~and to do all things necessary, proper, or expedient to achieve compliance with the~~
 128 ~~provisions and requirements of all applicable federal-aid acts and programs. Nothing in~~
 129 ~~this title is intended to conflict with any federal law; and, in case of such conflict, such~~
 130 ~~portion as may be in conflict with such federal law is declared of no effect to the extent~~
 131 ~~of the conflict;"~~

132 "(19) Code Sections 32-3-1 and 32-6-115 notwithstanding and at the direction of the
 133 State Transportation Authority, the department ~~may~~ shall by contract grant to any rapid
 134 transit authority created by the General Assembly, under such terms and conditions as the
 135 department may deem appropriate, the right to occupy or traverse a portion of the right
 136 of way of any road on the state highway system by or with its mass transportation
 137 facilities. Furthermore, at the direction of the State Transportation Authority, the
 138 department ~~may~~ shall by contract lease to the rapid transit authority, under such terms and
 139 conditions as the department may deem appropriate, the right to occupy, operate,
 140 maintain, or traverse by or with its mass transportation facilities any parking facility
 141 constructed by the department. Notwithstanding Code Section 48-2-17, all net revenue
 142 derived from the lease shall be utilized by the department to offset the cost of
 143 constructing any parking facility. Regardless of any financial expenditures by the rapid
 144 transit authority, no right of use or lease granted under this paragraph shall merge into or
 145 become a property interest of the rapid transit authority. Upon the transfer of the title of
 146 the mass transportation facilities to private ownership or upon the operation of the rapid
 147 transportation facilities for the financial gain of private persons, such rights granted by
 148 the department shall automatically terminate and all rapid transportation facilities shall
 149 be removed from the rights of way of the state highway system.

150 (b) In addition to the powers specifically delegated to it in this title and so long as not
 151 inconsistent with any powers granted to, or plans adopted by, the State Transportation
 152 Authority, the department shall have the authority to perform all acts which are necessary,
 153 proper, or incidental to the efficient operation and development of the department and of
 154 the state highway system and of other modes and systems of transportation; ~~and this title~~
 155 ~~shall be liberally construed to that end.~~ Any power vested by law in the department but not
 156 implemented by specific provisions for the exercise thereof may be executed and carried
 157 out by the department in a reasonable manner pursuant to such rules, regulations, and
 158 procedures as the department may adopt and subject to such limitations as may be provided
 159 by law."

160 **SECTION 1-5.**

161 Said title is further amended in Code Section 32-2-3, relating to development of
 162 transportation plans, by repealing said Code section and designating it as "Reserved."

163 **SECTION 1-6.**

164 Said title is further amended in Code Section 32-2-4.1, relating to the Gateway Center, by
 165 revising subsection (a) as follows:

166 "(a) Notwithstanding any other provision of law to the contrary, the department may
 167 acquire, construct, operate, and maintain a demonstration safety rest area and information
 168 center in Cobb County. For purposes of this Code section, the safety rest area and
 169 information center shall be known as the 'Gateway Center,' but the ~~State Transportation~~
 170 ~~Board~~ department may name or designate the center in its discretion. In addition to the
 171 powers provided in this Code section, cumulatively, the department shall have the same
 172 powers with respect to Gateway Center which the department otherwise enjoys with
 173 respect to safety rest areas, information centers, and welcome centers.

174 **SECTION 1-7.**

175 Said title is further amended in Code Section 32-2-5, relating to actions by or against the
 176 department, by revising subsection (b) as follows:

177 "(b) All actions brought ex contractu by or against the department shall be brought in a
 178 county where any part of the work is to be or has been performed. All other actions by or
 179 against the department shall be brought in the county in which the cause of action arose.
 180 Service upon the department shall be sufficient by serving a second original process issued
 181 from the county where the action is filed upon the commissioner personally or by leaving
 182 a copy of the same in the office of the commissioner in ~~the Department of Transportation~~
 183 ~~Building~~, Atlanta, Georgia."

184 **SECTION 1-8.**

185 Said title is further amended in Code Section 32-2-6, relating to liability of the department
 186 for actions against counties, by revising subsection (a) as follows:

187 "(a) The department shall defend any action and be responsible for all damages awarded
 188 therein in any court of this state against any county under existing laws whenever the cause
 189 of action accrues on a public road which at the time of accrual had been designated by the
 190 department as a part of the state highway system; provided, however, that no action may
 191 be brought under this Code section until the construction of the public road on which the
 192 injury complained of occurred has been completed and such public road has been officially
 193 opened to traffic as provided in subsection (b) of this Code section. When any such action
 194 is brought against a county in any court of this state, it shall be the duty of the plaintiff to
 195 provide for service of notice of the pendency of such action against the county upon the
 196 department by providing for service of a second original process, issued from the court
 197 where the action is filed, upon the commissioner personally or by leaving a copy of the
 198 same in the office of the commissioner in ~~the Department of Transportation Building~~,
 199 Atlanta, Georgia. The service of process in such action upon the county shall not be
 200 perfected until such second original process has been served as provided in this Code

201 section. The department shall also have the right and authority to defend, adjust, and settle
202 in the name of such county and on its behalf any claim for damages for which the
203 department ultimately may be liable under this Code section."

204

SECTION 1-9.

205 Said title is further amended in Code Section 32-2-20, relating to composition of board,
206 qualifications of members, terms of office, manner of selection of members, filling of
207 vacancies, officers, meetings, and compensation of members, by repealing subsections (d)
208 through (f), which read as follows:

209 "(d) The board shall, by majority vote of those members present and voting at regular
210 sessions, elect from their number a chairman and vice-chairman who shall serve at the
211 pleasure of the board. In like manner, the board shall also elect a secretary, who need not
212 necessarily be a member of the board, and who shall also serve at the pleasure of the board.

213 (e) The board shall meet in regular session at least one day each month, at least nine of
214 which regular sessions are to be held at the headquarters of the Department of
215 Transportation in Atlanta, and at such other special meetings as may be called by the
216 commissioner, by the chairman, or by a majority of the members of the board upon
217 reasonable written notice to all members of the board. Further, the chairman of the board
218 or the commissioner is authorized from time to time to call meetings of committees of the
219 board which are established by board policy; and to require the attendance of a member or
220 members of the board at places inside or outside the state when, in the opinion of the
221 chairman or the commissioner, the member or members of the board are needed to attend
222 properly to the department's business. A majority of the board shall constitute a quorum
223 for the transaction of all business including election or removal of the commissioner.
224 Except as otherwise provided in this title, any power of the board may be exercised by a
225 majority vote of those members present at any meeting at which there is a quorum.

226 (f) The members of the board shall receive no salary but shall receive for each day of
227 actual attendance at meetings of the board and the committee meetings the per diem and
228 transportation costs prescribed in Code Section 45-7-21. A like sum shall be paid for each
229 day actually spent in studying the transportation needs of the state or attending other
230 functions as a representative of the board, not to exceed 60 days in any calendar year. In
231 addition, they shall receive actual transportation costs while traveling by public carrier or
232 the legal mileage rate for the use of a personal automobile in connection with such
233 attendance and road study. Such per diem and expense shall be paid from funds
234 appropriated to the department upon presentation, by members of the board, of vouchers
235 approved by the chairperson and signed by the secretary."

236

SECTION 1-10.

237 Said title is further amended in Code Section 32-2-21, relating to the powers and duties of
 238 the State Transportation Board, by repealing said Code section.

239

SECTION 1-11.

240 Said title is further amended in Code Section 32-2-40, relating to the selection of the
 241 commissioner of transportation and the term of office of the commissioner, by revising
 242 subsections (b), (d), and (e) as follows:

243 "(b) The commissioner, his or her successor, and each succeeding commissioner thereafter
 244 shall be selected by a vote of the majority of the total number of members of the board. At
 245 the time of said vote, the board shall stipulate the term the commissioner shall serve, and
 246 said commissioner shall serve during the stipulated term and until his or her successor is
 247 selected by the board and duly qualified. The board shall stipulate one of the following to
 248 be the term of the commissioner:

249 (1) The commissioner shall serve at the pleasure of the board; or

250 (2) The commissioner shall serve any term specified by the board up to and including a
 251 maximum of four years; however, the board shall not specify a term of office that extends
 252 beyond the end of the term of the Governor in office at the time the commissioner's term
 253 is scheduled to begin."

254 "(d) The commissioner shall qualify, upon selection, by executing a bond in the amount
 255 of \$100,000.00 with a corporate surety licensed to do business in this state and payable to
 256 the Governor and his or her successors in office, such bond to be approved by the Governor
 257 and conditioned on the faithful discharge of his or her duties as commissioner. The
 258 premium of such bond shall be paid from funds of the department.

259 (e) The commissioner shall devote full time and attention to the duties and responsibilities
 260 of his or her office. No person who serves as commissioner shall be eligible, except as
 261 hereinafter provided in this subsection, to qualify as a candidate in any primary, special,
 262 or general election for any state or federal elective office nor to hold any such office,
 263 except as hereinafter provided in this subsection, during the time he or she serves as
 264 commissioner and for a period of 12 months after the date he or she ceases to serve as
 265 commissioner. However, nothing contained in this subsection shall prevent the
 266 commissioner from being appointed to any other office nor disqualify him or her from
 267 running in any election to succeed himself or herself in any office to which he or she was
 268 appointed nor to hold such office in the event he or she is elected thereto and otherwise
 269 qualified therefor; provided, however, that the commissioner shall resign as commissioner
 270 of transportation before accepting any such appointive office."

271 **SECTION 1-12.**

272 Said title is further amended in Code Section 32-2-41, relating to the powers, duties, and
 273 authority of the commissioner of transportation, by revising subsection (a) and adding a new
 274 subsection as follows:

275 "(a) As the chief executive officer of the department, the commissioner shall have direct
 276 and full control of the department. ~~He~~ and shall possess, exercise, and perform all the
 277 duties, powers, and authority which may be vested in the department by law, ~~except those~~
 278 ~~duties, powers, and authority which are expressly reserved by law to the board. When the~~
 279 ~~board is not in regular or called session, the commissioner shall perform, exercise, and~~
 280 ~~possess all duties, powers, and authority of the board except:~~

281 (1) ~~Approval of the advertising of nonnegotiated construction contracts;~~

282 (2) ~~Approval of authority lease agreements;~~

283 (3) ~~Confirmation or rejection of the recommendation for appointment of the following~~
 284 ~~department officers: the deputy commissioner, the chief engineer, and the treasurer and~~
 285 ~~the assistant treasurer of the department; and~~

286 (4) ~~Approval of long-range plans and programs of the department.~~

287 ~~The commissioner shall also have~~ such as the authority to exercise the power of eminent
 288 domain and to execute all contracts; and authority lease agreements; ~~and all other functions~~
 289 ~~except those that cannot legally be delegated to him by the board."~~

290 "(c) The commissioner shall perform any transportation duties and implement any
 291 transportation projects or plans delegated or assigned to the commissioner by the secretary
 292 of transportation."

293 **SECTION 1-13.**

294 Said title is further amended in Code Section 32-2-41.1, relating to development of a
 295 State-wide Strategic Transportation Plan, by repealing said Code section and designating it
 296 as "Reserved."

297 **SECTION 1-14.**

298 Said title is further amended in Code Section 32-2-41.2, relating to benchmarks and value
 299 engineering studies to be developed by the commissioner of transportation, by revising
 300 subsections (b) and (d) as follows:

301 "(b) The commissioner shall submit an annual report to the Governor, the Lieutenant
 302 Governor, the Speaker of the House of Representatives, ~~and~~ the chairpersons of the House
 303 and Senate Transportation Committees, and the secretary of transportation detailing the
 304 progress of every construction project valued at \$10 million or more against the
 305 benchmarks. This report shall include an analysis explaining the discrepancies between

306 the benchmarks and actual performance on each project as well as an explanation for
307 delays. This report shall also be published on the website of the department."

308 "(d) Value engineering studies shall be performed on all projects whose costs exceed \$10
309 million, and the commissioner shall submit an annual report to the Governor, the
310 Lieutenant Governor, the Speaker of the House of Representatives, ~~and~~ the chairpersons
311 of the House and Senate Transportation Committees, and the secretary of transportation
312 detailing the amount saved due to the value engineering studies. This report shall also be
313 published on the website of the department."

314 **SECTION 1-15.**

315 Said title is further amended in Code Section 32-2-42, relating to the appointment of a deputy
316 commissioner of transportation, chief engineer, treasurer, and assistant treasurer, by revising
317 said Code section as follows:

318 "32-2-42.

319 (a) The commissioner shall appoint a deputy commissioner of transportation, ~~whose~~
320 ~~appointment shall be subject to the approval of the board;~~ to serve at the pleasure of the
321 commissioner. Before assuming the duties of his or her office, the deputy commissioner
322 shall qualify by giving bond with a corporate surety licensed to do business in this state,
323 such bond to be in the amount of \$100,000.00 and payable to the Governor and his or her
324 successors in office. The bond shall be subject to the approval of the Governor and shall
325 be conditioned on the faithful discharge of the duties of the office, including any duties of
326 the office of the commissioner which the deputy commissioner may be required to perform
327 as acting commissioner. The premium for the bond shall be paid out of the funds of the
328 department. The deputy commissioner shall be the assistant commissioner and shall be
329 empowered to act in his or her own name for the commissioner. The deputy commissioner
330 may exercise to the extent permitted by law only such powers and duties of the
331 commissioner as have been previously assigned to him or her in writing by the
332 commissioner. In the event of the commissioner's temporary incapacity which causes his
333 or her absence from the offices of the Department of Transportation ~~Building~~ in Atlanta,
334 Georgia, for 30 consecutive days, the deputy commissioner shall assume all the powers and
335 duties of the commissioner, to be exercised until such time as the commissioner's
336 temporary absence or incapacity shall cease. In the event of the commissioner's permanent
337 incapacity, the deputy commissioner shall become acting commissioner, as provided in
338 subsection (c) of Code Section 32-2-40.

339 (b) The commissioner shall appoint a chief engineer, ~~whose appointment shall be~~
340 ~~confirmed or rejected by the board at the next regular board meeting following his or her~~
341 ~~appointment;~~ to serve at the pleasure of the commissioner. The chief engineer shall be the

342 chief engineer of the department and shall be a professional engineer registered in
 343 accordance with Chapter 15 of Title 43 and who shall be experienced in highway
 344 engineering.

345 (c) The commissioner shall appoint a treasurer of the department, ~~whose appointment shall~~
 346 ~~be confirmed or rejected by the board at the next regular board meeting following his~~
 347 ~~appointment~~, to serve at the pleasure of the ~~board~~ commissioner. Before assuming the
 348 duties of his or her office, the treasurer shall qualify by giving bond with a corporate surety
 349 licensed to do business in this state, such bond to be in the amount of \$100,000.00 and
 350 payable to the Governor and his or her successors in office. The bond shall be subject to
 351 the approval of the Governor and shall be conditioned on the faithful discharge of the
 352 duties of the office. The premium for the bond shall be paid out of the funds of the
 353 department. The duties of the treasurer shall be to receive all funds from all sources to
 354 which the department is entitled, to account for all funds received by the department, and
 355 to perform such other duties as may be required of him or her by the commissioner. The
 356 commissioner shall have the authority to appoint an assistant treasurer in the same manner
 357 and under the same conditions as set forth in this subsection for the appointment of the
 358 treasurer, including the qualifying in advance by giving bond of the same type, amount, and
 359 paid for in the same manner as required of the treasurer. The assistant treasurer shall
 360 assume the duties of office of treasurer upon the incapacity or death of the treasurer and
 361 shall serve until a new treasurer is appointed as provided in this subsection.

362 (d) Any provision of this title or of any other statute or of any rule or regulation to the
 363 contrary notwithstanding, the commissioner or the deputy commissioner may, in addition
 364 to serving as commissioner or deputy commissioner, also simultaneously serve as chief
 365 engineer, provided that he or she shall be appointed ~~and confirmed~~ and shall possess the
 366 qualifications as prescribed in subsection (b) of this Code section. A commissioner or
 367 deputy commissioner simultaneously serving as chief engineer shall be paid for the
 368 discharge of all his or her duties the sum to which he or she is entitled as commissioner or
 369 deputy commissioner."

370 **SECTION 1-16.**

853 Transportation Committee of the House of Representatives, and to members of the public

1145 **SECTION 3-1.**

1146 Title 32 of the Official Code of Georgia Annotated, relating to highways, bridges, and ferries,
1147 is amended by adding two new chapters to read as follows:

1148 "CHAPTER 11A

1149

1150 32-11A-1.

1151 This chapter shall be known and may be cited as the 'State Transportation Agency Act.'

1152 32-11A-2.

1153 As used in this chapter, the term:

1154 (1) 'Agency' means the State Transportation Agency.

1155 (2) 'Authority' means the State Transportation Authority created by Chapter 12 of this
1156 title.

1157 (3) 'Board' means the State Transportation Agency Board.

1158 32-11A-3.

1159 There is created the State Transportation Agency. The agency shall control, award, grant,
1160 disburse and pay the State Public Transportation Fund in accord with the appropriations
1161 Acts and the allocations and state-wide guidance and policies of the authority. The agency
1162 shall receive all moneys made available to the agency by the General Assembly or
1163 otherwise for purposes of the authority, and the agency shall disburse such moneys to the
1164 authority or otherwise in accord with the terms of the agency's funding, the allocations of
1165 the authority, and authority's state-wide guidance and policies.

1166 32-11A-4.

1167 (a) The members of the authority shall constitute the board of the agency and shall
1168 exercise all of the agency's powers and duties when acting in that capacity. The
1169 chairperson and any other such positions established on the board shall be held by the same
1170 members holding such positions on the authority.

1171 (b) The board shall provide for the holding of regular and special meetings, for bylaws,
1172 and for rules and regulations within its discretion. It shall not be subject to Chapter 13 of
1173 Title 50, the 'Georgia Administrative Procedure Act,' in any capacity or activity. The board
1174 shall hold at least one regular meeting during each fiscal year but may hold as many regular
1175 meetings during any fiscal year as may be deemed necessary. The chairperson is
1176 authorized to call at any time a special meeting of the board, provided at least five business
1177 days' advance notice is provided to each member. A majority of the members then in office
1178 shall constitute a quorum for the transaction of any business and for the exercise of any
1179 power, duty, or function of the board; and no vacancy on the board shall impair the right
1180 of a quorum of the members of the board then in office to transact any business or to
1181 exercise any power, duty, or function of the board. The concurrence of a majority of
1182 members present at any meeting of the board at which a quorum is present shall be
1183 sufficient to constitute official action of the board. All meetings of the board shall be open
1184 to the public except as otherwise provided by state law. Meetings of the board shall
1185 generally be held at the principal office or place of business of the agency but may be held
1186 elsewhere within the state when authorized by the board.

1187 (d) When serving in the capacity of members of the board, the members shall receive
1188 compensation and reimbursements in the same manner as they would when serving in their
1189 capacity as members of the authority.

1191 The secretary of transportation shall be the executive director of the agency and the agency
1192 and authority shall provide his or her compensation. Unless otherwise directed by the
1193 board, the secretary of transportation may employ, terminate, and prescribe duties for
1194 employees of the agency and may arrange for services of employees of the authority. All
1195 members of the board and officers and employees of the agency shall be covered by a
1196 fidelity bond or bonds in such sum or sums and conditioned for such purpose or purposes
1197 as the board shall determine, and the cost thereof shall be paid from funds available to the
1198 agency.

1203 This chapter shall be known and may be cited as the 'State Transportation Authority Act.'

1205 As used in this ~~article~~ chapter, the term:

1206 (1) 'Approach' means that distance on either end of a bridge as shall be required to
1207 develop the maximum traffic capacity of a bridge, including but not limited to necessary
1208 rights of way, grading, paving, minor drainage structures, and such other construction
1209 necessary to the approach.

1210 (2) 'Authority' means the State Transportation Authority. This new authority is a
1211 successor to the State Tollway Authority, ~~created by the 'State Tollway Authority Act,'~~
1212 ~~Ga. L. 1953, Jan.-Feb. Sess., p. 302, as amended particularly by Ga. L. 1972, p. 179, and~~
1213 ~~on and after April 30, 2001, also means the State Road and Tollway Authority, and the~~
1214 Georgia Regional Transportation Authority.

1215 (3) 'Bridge' means a structure, including the approaches thereto, erected in order to afford
1216 unrestricted vehicular passage over any obstruction in any public road, including but not
1217 limited to rivers, streams, ponds, lakes, bays, ravines, gullies, railroads, public highways,
1218 and canals.

1219 (4) 'Clean Air Act' means the federal Clean Air Act, as amended and codified at 42
1220 U.S.C.A. Sections 7401 to 7671q.

1221 ~~(4)~~(5) 'Cost of project' or 'cost' means the cost of construction, including relocation or
1222 adjustments of utilities; the cost of all lands, properties, rights, easements, and franchises
1223 acquired; relocation expenses; the cost of all machinery and equipment necessary for the
1224 operation of the project; financing charges; interest prior to and during construction and
1225 for such a period of time after completion of construction as shall be deemed necessary
1226 to allow the earnings of the project to become sufficient to meet the requirements of the
1227 bond issue; the cost of engineering, legal expenses, plans and specifications, and other
1228 expenses necessary or incident to determining the feasibility or practicability of the
1229 project; administrative expenses; and such other expenses as may be necessary or incident
1230 to the financing authorized in this ~~article~~ chapter, the construction of any project, and the
1231 placing of the same in operation. Any obligation or expense incurred for any of the
1232 foregoing purposes shall be regarded as a part of the cost of the project and may be paid

1233 or reimbursed as such out of the proceeds of revenue bonds issued for such project under
1234 this ~~article~~ chapter.

1235 (6) 'Department' means the Georgia Department of Transportation.

1236 (7) 'Metropolitan planning organization' means the forum for cooperative transportation
1237 decision making for a metropolitan planning area.

1238 (8) 'Metropolitan transportation plan' means the official intermodal transportation plan
1239 that is developed and adopted through the metropolitan transportation planning process
1240 for a metropolitan planning area.

1241 ~~(5)~~(9) 'Project' means land public transportation systems, including: (A) one or more
1242 roads or bridges or a system of roads, bridges, and tunnels or improvements thereto
1243 included on an approved state-wide transportation improvement program on the
1244 Developmental Highway System as set forth in Code Section 32-4-22, as now or
1245 hereafter amended, or a ~~comprehensive transportation plan pursuant to Code Section~~
1246 ~~32-2-3~~ included on the state-wide strategic transportation plan or which are toll access
1247 roads, bridges, or tunnels, with access limited or unlimited as determined by the
1248 authority, and such buildings, structures, parking areas, appurtenances, and facilities
1249 related thereto, including but not limited to approaches, cross streets, roads, bridges,
1250 tunnels, and avenues of access for such system; and (B) any program for mass
1251 transportation or mass transportation facilities as approved by the authority ~~and the~~
1252 ~~department~~ and such buildings, structures, parking areas, appurtenances, and facilities
1253 related thereto, including, but not limited to, approaches, cross streets, roads, bridges,
1254 tunnels, and avenues of access for such facilities.

1255 ~~(6)~~(10) 'Relocation expenses' means all necessary relocation expenses, replacement
1256 housing expenses, relocation advisory services, expenses incident to the transfer of real
1257 property, and litigation expenses of any individual, family, business, farm operation, or
1258 nonprofit organization displaced by authority projects to the extent authorized by the
1259 Uniform Relocation Assistance and Real Property Acquisition Policies Act of 1970, as
1260 amended by the Uniform Relocation Act Amendments of 1987, Title IV of Public Law
1261 100-17.

1262 ~~(6.1)~~(11) 'Revenue' or 'revenues' shall mean any and all moneys received from the
1263 collection of tolls authorized by Code Sections ~~32-10-64 and 32-10-65~~ 32-12-61 and
1264 32-12-62, any federal highway or transit funds and reimbursements, any other federal
1265 highway or transit assistance received from time to time by the authority, any other
1266 moneys of the authority pledged for such purpose, and any other moneys received by the
1267 authority ~~pursuant to~~ from the Georgia Transportation Infrastructure Bank.

1268 ~~(7)~~(12) 'Revenue bonds,' 'revenue bond,' 'bonds,' or 'bond' means any bonds, notes,
1269 interim certificates, reimbursement anticipation notes, or other evidences of indebtedness

1270 of the authority authorized by ~~Part 2 of this article~~ Article 2 of this chapter, including
 1271 without limitation obligations issued to refund any of the foregoing.

1272 ~~(8)~~(13) 'Self-liquidating' means that, in the judgment of the authority, the revenues and
 1273 earnings to be derived by the authority from any project or combination of projects or
 1274 from any other revenues available to the authority, together with any maintenance, repair,
 1275 operational services, funds, rights of way, engineering services, and any other in-kind
 1276 services to be received by the authority from appropriations of the General Assembly, the
 1277 department, other state agencies or authorities, the United States government, or any
 1278 county or municipality, shall be sufficient to provide for the maintenance, repair, and
 1279 operation and to pay the principal and interest of revenue bonds which may be issued for
 1280 the cost of such project, projects, or combination of projects.

1281 (14) 'State implementation plan' means the portion or portions of an applicable
 1282 implementation plan approved or promulgated, or the most recent revision thereof, under
 1283 Sections 110, 301(d), and 175A of the Clean Air Act.

1284 (15) 'State-wide strategic transportation plan' means the official, intermodal,
 1285 comprehensive, fiscally constrained transportation plan which includes projects,
 1286 programs, and other activities to support implementation of the state's strategic
 1287 transportation goals and policies. This plan and the process for developing the plan shall
 1288 comply with 23 C.F.R. Section 450.104.

1289 (16) 'State-wide transportation improvement program' means a state-wide prioritized
 1290 listing of transportation projects covering a period of four years that is consistent with the
 1291 state-wide strategic transportation plan, metropolitan transportation plans, and
 1292 transportation improvement programs and required for multi-modal projects to be eligible
 1293 for funding under Title 23 U.S.C. and Title 49 U.S.C. Chapter 53.

1294 (17) 'Transportation improvement program' means a prioritized listing of transportation
 1295 projects covering a period of four years that is developed and formally adopted by a
 1296 metropolitan planning organization as part of the metropolitan transportation planning
 1297 process, consistent with the metropolitan transportation plan, and required for projects
 1298 to be eligible for funding under Title 23 U.S.C. and Title 49 U.S.C. Chapter 53.

1299 ~~(9)~~(18) 'Utility' means any publicly, privately, or cooperatively owned line, facility, or
 1300 system for producing, transmitting, transporting, or distributing communications, power,
 1301 electricity, light, heat, gas, oil products, passengers, water, steam, clay, waste, storm
 1302 water not connected with highway drainage, and other similar services and commodities,
 1303 including publicly owned fire and police, and traffic signals and street lighting systems,
 1304 which directly or indirectly serve the public. This term also means a person, municipal
 1305 corporation, county, state agency, or public authority which owns or manages a utility as
 1306 defined in this paragraph.

1307 32-12-3.

1308 (a) As used in this Code section, the term:

1309 (1) 'Authority' means the State Transportation Authority established in this chapter.

1310 (2) 'Transferred authorities' means the Georgia Regional Transportation Authority set
 1311 forth in Chapter 32 of Title 50 and the State Road and Tollway Authority set forth in
 1312 Article 2 of Chapter 10 of Title 32, as each entity existed as of June 30, 2009.

1313 (b) Beginning July 1, 2009, all functions, duties, responsibilities, and obligations of the
 1314 transferred authorities shall belong to the authority. The authority shall also succeed to the
 1315 rights, claims, remedies, securities, and any other debt or obligation owing to the
 1316 transferred authorities.

1317 (c) The authority shall be substituted for the transferred authorities on any bonds, claims,
 1318 causes of action, contracts, leases, agreements, or other indebtedness or obligations of the
 1319 transferred authorities. Contracts held by the transferred authorities shall be considered
 1320 contracts of the authority, and any rights of renewal, prerogatives, benefits, and rights of
 1321 enforcement under such contracts shall also be transferred to the authority.

1322 (d) All assets, moneys, properties both tangible and intangible, and other valuable
 1323 instruments and consideration belonging to the transferred authorities on the date of
 1324 transfer shall become the property and assets of the authority.

1325 (e) Rules and regulations previously adopted by the transferred authorities shall remain in
 1326 full force and effect as rules and regulations of the authority until amended, repealed, or
 1327 superseded by action of the authority.

1329 ~~The State Tollway Authority shall continue to be a body corporate and politic and an~~
 1330 ~~instrumentality and public corporation of the state known as the 'State Road and Tollway~~
 1331 ~~Authority.' It shall have perpetual existence. In said name it may contract and be~~
 1332 ~~contracted with, sue and be sued, implead and be impleaded, and complain and defend in~~
 1333 ~~all courts of this state, subject to the limitations of Code Section 32-10-110.~~

1334 (a) There is created the State Transportation Authority as a body corporate and politic,
 1335 which shall be deemed an instrumentality of the State of Georgia and a public corporation
 1336 thereof, for purposes of planning, overseeing transportation construction, and contracting
 1337 with state or private entities to implement construction plans and other transportation
 1338 projects, and managing or causing to be managed land transportation, tollways and tolling,
 1339 public transit, and air quality within designated areas of this state. The authority shall have
 1340 the duties, responsibilities, functions, powers, and authority set forth in this chapter and
 1341 otherwise provided by law. The State Transportation Authority is the successor to the
 1342 Georgia Regional Transportation Authority and the State Road and Tollway Authority and

1343 shall have the duties, responsibilities, functions, powers, and authority formerly held by
 1344 those authorities. The authority shall have perpetual existence. In said name it may
 1345 contract and be contracted with, sue and be sued, implead and be impleaded, and complain
 1346 and defend in all courts of this state. Any change in the name or composition of the
 1347 authority shall in no way affect the vested rights of any person under this chapter or impair
 1348 the obligations of any contracts existing under this chapter.

1349 (b) The authority shall be the state's principal agency for developing, coordinating,
 1350 administering, and managing transportation policies, planning, and programs related to
 1351 design, construction, maintenance, operations, and financing of transportation and is
 1352 specifically charged with the responsibility of highway construction in this state.

1353 (c) The jurisdiction of the authority shall extend throughout this state with respect to land
 1354 transportation, tollways, and public transportation or transit. The jurisdiction of the
 1355 authority with respect to air quality standards shall be as defined in Code Sections 32-12-70
 1356 through 32-12-74.

1357 (d) The authority shall be assigned to the State Transportation Agency for administrative
 1358 purposes pursuant to Code Section 50-4-3.

1360 (a) The terms of office of the members of the State Road and Tollway Authority and the
 1361 Georgia Regional Transportation Authority as of June 30, 2009, shall expire at midnight
 1362 on that date. The terms of office of the members of the authority appointed under the
 1363 provisions of this Code section shall begin on July 1, 2009.

1364 ~~(b)(a) The members of the authority shall be ex officio the Governor, the commissioner~~
 1365 ~~of transportation, the director of the Office of Planning and Budget, one member~~ The
 1366 authority shall be composed of five members to be appointed by the Governor, three

 1396 The books and records shall be inspected and audited by the state auditor at least once a

1399 (a) The secretary of transportation shall be the chief executive officer of the authority who
 1400 shall execute and implement, at the authority's direction, the authority's duties as the state's
 1401 principal agency for developing, coordinating, administering, and managing transportation
 1402 policies, planning, and programs related to design, construction, maintenance, operations,
 1403 and financing of transportation. Furthermore, pursuant to the authority's obligations, the
 1404 secretary of transportation is specifically charged with the responsibility of highway
 1405 construction in this state.

1406 (b) The secretary of transportation, with the approval of the members of the authority, shall
 1407 establish such units within the authority as he or she deems proper for its administration.
 1408 The secretary of transportation shall designate persons to be directors and assistant
 1409 directors of such units to exercise such authority as he or she may delegate to them. The
 1410 secretary of transportation may employ or delegate deputies or other individuals to oversee
 1411 the transportation needs of the state and carry out the duties placed on the secretary by the
 1412 authority. Such deputies and other delegated individuals may include, but shall not be
 1413 limited to, a deputy for finance, a deputy for planning, and a deputy for construction and
 1414 maintenance, who may be the commissioner of transportation.

1415 (c) The secretary of transportation shall have the authority to employ as many persons as
 1416 he or she deems necessary for the administration of the authority and for the discharge of
 1417 the duties of his or her office, and he or she may also engage available officers, personnel,
 1418 and resources within the Department of Transportation to fulfill the purposes of the
 1419 authority. He or she shall issue all necessary directions, instructions, orders, and rules
 1420 applicable to such persons. He or she shall have authority, as he or she deems proper, to
 1421 employ, assign, compensate, and discharge employees of the authority within the
 1422 limitations of the restrictions set forth by law.

1424 (a) The authority shall have, in addition to any other powers conferred in this article
 1425 chapter, the following powers:

1426 (1) To have a seal and alter the same at its pleasure;

1427 (2) To acquire by purchase, lease, exchange, or otherwise and to hold, lease, and dispose
 1428 of real and personal property of every kind and character for its corporate purposes;

1429 (3) To appoint such additional officers, who need not be members of the authority, as the
 1430 authority deems advisable and to employ such experts, employees, and agents as may be
 1431 necessary, in its judgment, to carry on properly the business of the authority; to fix their
 1432 compensation; and to promote and discharge same;

1433 (4) To acquire in its own name by purchase, on such terms and conditions and in such
 1434 manner as it may deem proper, or by condemnation in accordance with any and all
 1435 existing laws applicable to the condemnation of property for public use, including but not
 1436 limited to those procedures in Article 1 of Chapter 3 of this title, real property or rights
 1437 or easements therein or franchises necessary or convenient for its corporate purposes; and

 1439 contracts with respect to the use of or to dispose of the same in any manner it deems to
 1440 the best advantage of the authority, the authority being under no obligation to accept and

 1442 under the authority of this ~~article~~ chapter; and, in any proceedings to condemn, such order
 1443 may be made by the court having jurisdiction of the action or proceedings as may be just
 1444 to the authority and to the owners of the property to be condemned; and no property shall

 1446 unless at the time such property is so acquired a sufficient sum of money be deposited in
 1447 trust to pay and redeem such lien or encumbrance in full;

1448 (5) To make such contracts, leases, or conveyances as the legitimate and necessary
 1449 purposes of this ~~article~~ chapter shall require, including but not limited to contracts for
 1450 construction or maintenance of projects, provided that the authority shall consider the

1451 possible economic, social, and environmental effects of each project, and the authority
 1452 shall assure that possible adverse economic, social, and environmental effects relating to
 1453 any proposed project have been fully considered in developing such project and that the
 1454 final decision on the project is made in the best overall public interest, taking into
 1455 consideration the need for fast, safe, and efficient transportation, public services, and the
 1456 cost of eliminating or minimizing adverse economic, social, and environmental effects.
 1457 Furthermore, in order to assure that adequate consideration is given to economic, social,
 1458 and environmental effects of any ~~tollway~~ project under consideration, the authority shall:

1459 (A) ~~For federal-aid projects, follow~~ Follow the processes required for federal-aid
 1460 highway projects, as determined by the National Environmental Policy Act of 1969, as
 1461 amended, except that final approval of the adequacy of such consideration shall rest
 1462 with the Governor, as provided in subparagraph (C) of this paragraph, acting as the
 1463 chief executive of the state, ~~upon recommendation of the commissioner, acting as chief~~
 1464 ~~administrative officer of the Department of Transportation;~~

1465 (B) In the location and design of any project, avoid the taking of or disruption of
 1466 existing public parkland or public recreation areas unless there are no prudent or
 1467 feasible project location alternates. The determination of prudence and feasibility shall
 1468 be the responsibility of the authority as part of the consideration of the overall public
 1469 interest; and

1470 (C) ~~For federal-aid projects, not~~ Not approve and proceed with acquisition of rights of
 1471 way and construction of a project until: (i) there has been held, or there has been offered
 1472 an opportunity to hold, a public hearing or public hearings on such project in
 1473 compliance with requirements of the Federal-aid Highway Act of 1970, as amended,
 1474 except that neither acquisition of right of way nor construction shall be required to
 1475 cease on any federal-aid project which has received federal approval pursuant to the
 1476 National Environmental Policy Act of 1969, as amended, and is subsequently
 1477 determined to be eligible for construction as an authority project utilizing, in whole or

 1486 and manage projects, as defined in paragraph ~~(5)~~(9) of Code Section ~~32-10-60~~ 32-12-2,
 1487 the cost of any such project to be paid in whole or in part from the proceeds of revenue

1488 bonds of the authority, from other funds available to the authority, or from any
1489 combination of such sources;

1490 (7) To apply for, accept, and administer any federal highway or federal transit funds and
1491 any other federal highway or transit assistance received from time to time for the State
1492 of Georgia and to accept, with the approval of the Governor, loans and grants, either or
1493 both, of money or materials or property of any kind from the United States government
1494 or the State of Georgia or any political subdivision, authority, agency, or instrumentality
1495 of either of them, upon such terms and conditions as the United States government or the
1496 State of Georgia or such political subdivision, authority, agency, or instrumentality of
1497 either of them shall impose;

1498 (8) To borrow money for any of its corporate purposes, to issue negotiable revenue
1499 bonds payable from revenues of such projects, and to provide for the payment of the same
1500 and for the rights of the holders thereof;

1501 (9) To exercise any power usually possessed by private corporations performing similar
1502 functions, which power is not in conflict with the Constitution and laws of Georgia;

1503 (10) To covenant with bondholders for the preparation of annual budgets for each project

3363 As provided in subsection (c) of Code Section ~~32-10-64~~ 32-12-60, the motor vehicle
 3364 registration of any owner who has failed to pay, within 30 days of the date of notice
 3365 thereof, the amount determined by the Office of State Administrative Hearings as due and
 3366 payable for one or more violations of such subsection, shall be immediately suspended by
 3367 operation of law."

SECTION 4-11.

3368
 3369 Code Section 40-6-50 of the Official Code of Georgia Annotated, relating to driving on
 3370 divided highways, controlled-access roadways, and emergency lanes, is amended by revising
 3371 subsection (d) as follows:

3372 "(d) Nothing in this Code section shall prohibit the use of a FlexAuto lane in the manner
 3373 permitted under Code Section ~~32-9-4.1~~ 32-12-16."

SECTION 4-12.

3374

3375 Code Section 40-6-54 of the Official Code of Georgia Annotated, relating to the designation
 3376 of travel lanes for the exclusive use of certain vehicles, is amended by revising subsections
 3377 (a) and (b) as follows:

3378 "(a) The Department of Transportation, with the approval of the State Transportation
 3379 Authority, may designate travel lanes on any road in the state highway system for the
 3380 exclusive use of certain vehicles, as provided in Code Section ~~32-9-4~~ 32-12-15; provided,
 3381 however, that where such designation has been made, the road shall be appropriately
 3382 marked with signs or other roadway markers or markings to inform the traveling public of
 3383 the restrictions imposed.

3384 (b) Any person who violates subsection (b) of Code Section ~~32-9-4~~ 32-12-15 shall be
 3385 guilty of a misdemeanor and, upon conviction thereof, shall be punished by a fine:

3386 (1) Not to exceed \$75.00 for the first such offense;

3387 (2) Not to exceed \$100.00 for the second such offense;

3388 (3) Not to exceed \$150.00 for the third such offense; and

3389 (4) Not to exceed \$150.00 plus one point on such person's driver's license as provided
 3390 for under Code Section 40-5-57 for the fourth or subsequent offense."

SECTION 4-13.

3391

3392 Code Section 40-16-2 of the Official Code of Georgia Annotated, relating to the primary
 3393 responsibilities of the Department of Driver Services, is amended by revising paragraph (10)
 3394 of subsection (b) as follows:

3395 "(10) Enforcement of Code Sections ~~32-9-4~~ 32-12-15 and 40-6-54, relating to
 3396 designation of restricted travel lanes is transferred to the Department of Public Safety;"

SECTION 4-14.

3397

3398 Code Section 45-12-170 of the Official Code of Georgia Annotated, relating to the Office
 3399 of Planning and Budget to perform planning and development function, powers and duties
 3400 generally, and recommendations of planned communities for state development assistance,
 3401 is amended by revising subsection (d) as follows:

3402 "(d) The Office of Planning and Budget shall recommend for certification for state
 3403 development assistance all planned communities which meet the requirements of
 3404 subsection (c) of this Code section. Such recommendations shall be made to the secretary
 3405 of transportation and ~~the chairmen of the State Transportation Board~~, chairpersons of the
 3406 State Board of Education, the Board of Natural Resources, and the Board of Community
 3407 Affairs. If a majority of said ~~chairmen~~ officials approve any recommendation, the

3408 Governor shall be authorized to certify such planned community as eligible for state
3409 development assistance."

3410 **SECTION 4-15.**

3411 Code Section 45-12-203 of the Official Code of Georgia Annotated, relating to membership
3412 on the Governor's Development Council, is amended by revising subsections (a) and (b) as
3413 follows:

3414 "(a) The members of the ~~board of directors of the Georgia Regional Transportation~~
3415 ~~Authority~~ State Transportation Authority provided by ~~Code Section 50-32-4~~ Chapter 12
3416 of Title 32, upon their initial appointment and thereafter, shall constitute the membership
3417 of the council. Membership on that authority or the council shall not constitute an
3418 appointment to an office of honor or trust for purposes of subsection (a) of Code Section
3419 50-32-4.

3420 (b) The chair of the ~~Georgia Regional Transportation Authority~~ State Transportation
3421 Authority shall serve as the chair of the council."

3422 **SECTION 4-16.**

3423 Code Section 50-17-23 of the Official Code of Georgia Annotated, relating to general
3424 obligation and guaranteed revenue debts, sinking and common reserve funds, appropriations,
3425 investments, and taxation to pay debt service requirements, is amended by revising the
3426 introductory language of subsection (a) as follows:

3427 "(a) *General obligation debt.* General obligation debt may not be incurred until the
3428 General Assembly has enacted legislation stating the purposes, in general or specific terms,
3429 for which such issue of debt is to be incurred, specifying the maximum principal amount
3430 of the issue, and appropriating an amount at least sufficient to pay the highest annual debt
3431 service requirements for the issue. Appropriations made in each fiscal year, as provided
3432 in this subsection, for debt service purposes shall not lapse for any reason and shall
3433 continue in effect until the debt for which such appropriation was authorized shall have
3434 been incurred; but the General Assembly may repeal any such appropriation at any time
3435 prior to the incurring of such debt. Following the incurring of debt in any fiscal year for
3436 any purpose for which an appropriation has been made, there shall be deposited in the
3437 sinking fund provided for in paragraph (1) of this subsection an amount equal to the highest
3438 annual debt service requirements for such debt coming due in any succeeding fiscal year.
3439 On or prior to the end of such fiscal year, the commission shall certify to the fiscal officer
3440 of the state the amount of the appropriation for any purpose which has been transferred to
3441 the sinking fund and the amount of the anticipated highest annual debt service requirement
3442 of debt authorized to be issued in such fiscal year for any purpose by resolution of the

3443 commission but which actually will be incurred in the next succeeding fiscal year. The
 3444 remaining appropriation for any purpose, after deducting the aggregate amounts described
 3445 in the preceding sentence, shall lapse, except that any such amount attributable to an
 3446 appropriation to general obligation debt for the construction and improvement of public
 3447 roads and bridges shall not lapse but shall be ~~paid to the Department of Transportation~~
 3448 disbursed to the State Public Transportation Fund. The General Assembly may provide in
 3449 an appropriation of highest annual debt service requirements that if the commission
 3450 determines not to incur the debt so authorized, the commission may expend the
 3451 appropriation as capital outlay for the purposes specified in the appropriation. The
 3452 appropriation as capital outlay shall lapse at the end of the fiscal year of the appropriation
 3453 unless committed as provided by law. The appropriation as highest annual debt service
 3454 shall expire as authorization for debt when the funds are committed as capital outlay but
 3455 shall otherwise lapse as provided by law."

3456 SECTION 4-17.

3457 Code Section 50-17-25, relating to incurring public debt by resolution, sale of evidences of
 3458 indebtedness, form of obligations, validation of bonds, civil claims and actions, is amended
 3459 by revising subsection (b) to add a new paragraph to read as follows:

3460 "(4) A resolution authorizing general obligation debt to acquire, construct, develop,
 3461 extend, enlarge, or improve highways or other public transportation projects must be
 3462 preceded by a resolution of the State Transportation Agency approving the issuance under
 3463 the allocations, guidelines, and policies of the State Transportation Authority."

3464 SECTION 4-18.

3465 Code Section 50-23-4 of the Official Code of Georgia Annotated, relating to definitions
 3466 relative to the Environmental Facilities Authority, is amended by revising subparagraph (B)
 3467 of paragraph (12) as follows:

3468 "(B) Projects authorized by the Georgia Regional Transportation Authority created by
 3469 Chapter 32 of this title as defined in such chapter State Transportation Authority, where
 3470 the authority has been directed to issue revenue bonds, bonds, notes, or other
 3471 obligations to finance such project or the cost of a project in whole or in part, provided
 3472 that the authority's power with respect to such projects authorized by the Georgia
 3473 Regional Transportation Authority State Transportation Authority shall be limited to
 3474 providing such financing and related matters as authorized by the Georgia Regional
 3475 Transportation Authority State Transportation Authority."

3476 **SECTION 4-19.**

3477 Code Section 52-3-5 of the Official Code of Georgia Annotated, relating to the exercise of
3478 the power of eminent domain along the intracoastal waterway, is amended by revising said
3479 Code section as follows:

3480 "52-3-5.

3481 If for any reason the Department of Transportation is unable to secure any such property
3482 or rights required by the United States government for the construction and maintenance
3483 of the intracoastal waterway from the Savannah River to Cumberland Sound by voluntary
3484 agreement with the owner or owners thereof on terms and conditions satisfactory to it, the
3485 department is vested with the power to condemn the same and in so doing to employ the
3486 way, means, method, and procedure of Chapter 2 of Title 22 and Article 6 of Chapter 3 of
3487 Title 22, relating to the acquisition of property by condemnation on the part of the State of
3488 Georgia and of the United States; and in all instances any general and specific benefits to
3489 the owner or owners of such property or lands shall be offset against any damages to such
3490 property or lands. When the easement or property is thus acquired, a deed shall be
3491 executed conveying it to the United States. All easements granted under the authority of
3492 this Code section shall be approved by the ~~State Transportation Board~~ State Transportation
3493 Authority and shall be executed by the commissioner of transportation."

3494 **PART V**

3495 Provisions Repealing the Georgia Regional Transportation Authority

3496 **SECTION 5-1.**

3497 Chapter 32 of Title 50 of the Official Code of Georgia Annotated, relating to the Georgia
3498 Regional Transportation Authority, is repealed in its entirety and designated as reserved.

3499 **PART VI**

3500 Effective Date; Repealer

3501 **SECTION 6-1.**

3502 This Act shall become effective on July 1, 2009, except for Chapter 11A of Title 32 and
3503 Code Section 32-12-5 of the Official Code of Georgia Annotated, as enacted by this Act,
3504 which shall become effective upon the Governor's signature.

3505 **SECTION 6-2.**

3506 All laws and parts of laws in conflict with this Act are repealed.
