A RESOLUTION

- 1 Requesting that the board of directors of the Georgia Lottery Corporation develop methods
- 2 to increase funding available for the Georgia HOPE scholarship program through its lottery
- 3 revenue and that it provide the Senate with a report of its suggestions and findings; and for
- 4 other purposes.
- 5 WHEREAS, the Georgia Lottery has been helping to fund the education of Georgia's
- 6 children for over 15 years and is internationally recognized as one of the best operated state
- 7 lotteries; and
- 8 WHEREAS, the Georgia Lottery has raised more than \$10.5 billion for HOPE scholarships,
- 9 technology improvements, and pre-K programs; and
- 10 WHEREAS, over 1.1 million Georgia students have received HOPE scholarships funded by
- 11 the Georgia Lottery, and over 900,000 Georgia children have benefited from pre-K programs
- 12 funded by the Georgia Lottery; and
- 13 WHEREAS, Georgia families have come to depend on the HOPE scholarships and pre-K
- programs generated through the Georgia Lottery; however, the state's lottery revenue growth
- using traditional lottery games has reached its apex and has slowed to an annual growth rate
- of less than 1 percent; and
- 17 WHEREAS, lottery expenditures for HOPE scholarships and pre-K programs are projected
- 18 to continue to increase at an annual rate of over 6 percent and exceed revenue brought in
- 19 through the Georgia Lottery starting in fiscal year 2010; and
- 20 WHEREAS, because Georgia is the fourth fastest growing state in the nation, the demand
- 21 for the programs funded by the Georgia Lottery will continue to increase; and

22 WHEREAS, the rising costs of higher education and pre-K programs will also place

- 23 additional demands to increase the money generated by the Georgia Lottery; and
- 24 WHEREAS, without a substantial increase in lottery revenues, Georgia parents and students
- 25 are likely to experience significant reductions in the availability of HOPE scholarships and
- 26 pre-K programs in the coming years; and
- 27 WHEREAS, the board of directors of the Georgia Lottery Corporation is obligated to
- 28 consider all revenue raising options available to increase lottery revenues to fund HOPE
- 29 scholarship and pre-K programs.
- 30 NOW, THEREFORE, BE IT RESOLVED BY THE SENATE that the members of this body
- 31 request that the board of directors of the Georgia Lottery Corporation develop methods to
- 32 increase lottery revenue in order to preserve and grow Georgia's HOPE scholarship and
- 33 pre-K programs.
- 34 BE IT FURTHER RESOLVED that the board of directors of the Georgia Lottery
- 35 Corporation is requested to provide, in a timely manner, the Senate with a report outlining
- 36 the board's review and conclusions.
