A BILL TO BE ENTITLED AN ACT

- 1 To amend Title 40 of the Official Code of Georgia Annotated, relating to motor vehicles and
- 2 traffic, so as to provide for the assessment of points for a violation of Code Section 40-6-241,
- 3 relating to the use of radios and mobile telephones while driving; to provide that a driver who
- 4 is involved in an accident while using a wireless electronic device to write, send, or read text
- 5 based communications while operating a motor vehicle shall be in violation of Code Section
- 6 40-6-241; to provide a penalty; to provide for related matters; to provide for an effective
- 7 date; to repeal conflicting laws; and for other purposes.

8 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

9 **SECTION 1.** 10 Title 40 of the Official Code of Georgia Annotated, relating to motor vehicles and traffic, is 11 amended in Code Section 40-5-57, relating to the suspension or revocation of the licenses 12 of habitually negligent or dangerous drivers and to the point system, by revising 13 subparagraph (c)(1)(A) as follows: 14 "(c)(1)(A) Except as provided in subparagraph (C) of this paragraph, the points to be 15 assessed for each offense shall be as provided in the following schedule: 16 Aggressive driving 6 points 17 Reckless driving 4 points 18 Unlawful passing of a school bus 6 points 19 Improper passing on a hill or a curve 4 points 20 Exceeding the speed limit by more than 14 miles per hour but less than 19 miles per hour 21 2 points 22 Exceeding the speed limit by 19 miles per hour or more 23 but less than 24 miles per hour 3 points 24 Exceeding the speed limit by 24 miles per hour or more 25

26	Exceeding the speed limit by 34 miles per hour or more	6 points
27	Disobedience of any traffic-control device or traffic officer	3 points
28	Too fast for conditions	0 points
29	Possessing an open container of an alcoholic beverage while driving	2 points
30	Failure to adequately secure a load, except fresh farm produce, resulting	
31	in loss of such load onto the roadway which results in an accident	2 points
32	Violation of child safety restraint requirements, first offense	1 point
33	Violation of child safety restraint requirements, second or	
34	subsequent offense	2 points
35	Engaging in activities which distract the driver resulting in

38	SECTION 2.	
39	Said title is further amended by revising Code Section 40-6-241, relating to the exercise of	
40	due care by drivers and the allowance for the proper use of radios and mobile telep	phones, as
41	follows:	
42	"40-6-241.	
43	A driver shall exercise due care in operating a motor vehicle on the highways of	f this state
44	and shall not engage in any actions which shall distract such driver from the safe	operation
45	of such vehicle, provided that the proper use of a radio, citizens band radio, or mobile	
46	telephone shall not be a violation of this Code section. If a driver engages in	an action
47	which distracts such driver from the safe operation of a motor vehicle, including the use	
48	of a wireless communications device to write, send, or read a text based communications	unication,
49	and such action contributes to an accident resulting in physical injury or property	y damage,
50	such driver shall be guilty of a misdemeanor and upon conviction thereof shall be	punished
51	by a fine not to exceed \$50.00 and assessment of points under Code Section 40)-5-57 <u>.</u> ″
52	SECTION 3.	
53	This Act shall become effective upon its approval by the Governor or upon its becoming law	
54	without such approval.
