A BILL TO BE ENTITLED AN ACT

- 1 To amend an Act to reconstitute the Meriwether County Board of Education, approved
- 2 March 28, 1985 (Ga. L. 1985, p. 4611), as amended, so as to stagger the terms which
- 3 members of the board are elected; to provide that members in office shall continue to serve
- 4 for the remainder of their terms; to change vacancy provisions; to provide for related matters;
- 5 to provide for submission of this Act to the United States Attorney General; to provide for
- 6 an effective date; to repeal conflicting laws; and for other purposes.

7 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 SECTION 1.

- 9 An Act to reconstitute the Meriwether County Board of Education, approved March 28, 1985
- 10 (Ga. L. 1985, p. 4611), as amended, is amended by striking Sections 2, 3, and 5 and inserting
- in lieu thereof the following:
- 12 "SECTION 2.
- 13 The Meriwether County Board of Education shall consist of five members.
- 14 SECTION 3.
- 15 (a) The board members in office on the effective date of this Act shall serve out the terms
- to which they were elected.
- 17 (b) Each member of the board shall represent one of the five education districts described
- in Section 4 of this Act, and the member representing each education district shall be
- 19 elected solely by the voters who reside in that education district.
- 20 (c) At the November, 2012, general election, board members representing Districts 1, 3,
- and 5 shall be elected to serve a term of office of two years beginning on January 1, 2013,
- and ending on December 31, 2014, and until their successors are elected and qualified. At
- 23 the November, 2014, general election, successors for such board members shall be elected
- to serve a term of four years beginning on January 1, 2015, and ending on December 31,

25 2018, and until their successors are elected and qualified. Thereafter, successors to such

- board members shall be elected at the November general election immediately preceding
- 27 the end of their respective terms of office and shall take office on January 1 immediately
- following such election for a term of four years and until their successors are elected and
- 29 qualified.
- 30 (d) At the November, 2012, general election, board members representing Districts 2 and
- 4 shall be elected to serve a term of office of four years beginning January 1, 2013, and
- 32 ending on December 31, 2016, and until their successors are elected and qualified.
- Thereafter, successors to such board members shall be elected at the November general
- 34 election immediately preceding the end of their respective terms of office and shall take
- office on January 1 immediately following such election for a term of four years and until
- their successors are elected and qualified.
- 37 (e) Each candidate for election to the board of education shall at the time of qualification
- for election be a resident of the education district such candidate is seeking to represent.
- 39 The office of any member of the board of education who ceases to be a resident of the
- 40 education district such member represents shall become vacant by operation of law as of
- 41 the date of the change of residency.
- 42 (f) Each candidate for election to the board of education shall have resided within the
- 43 Meriwether County School District for a continuous period of two years immediately
- 44 preceding the date of the general election and shall at the time of qualification be a
- 45 qualified voter of Meriwether County."
- 46 "SECTION 5.
- 47 Any vacancy in office upon the board which occurs for any reason other than expiration
- of term shall be filled according to the provisions of Code Section 20-2-54.1."
- 49 SECTION 2.
- 50 Pursuant to Section 5 of the federal Voting Rights Act of 1965, as amended, it shall be the
- 51 duty of the attorney of the Meriwether County Board of Education to submit this Act to the
- 52 United States Attorney General for approval.
- SECTION 3.
- 54 This Act shall become effective upon its approval by the Governor or upon its becoming law
- 55 without such approval.
- SECTION 4.
- 57 All laws and parts of laws in conflict with this Act are repealed.
