A BILL TO BE ENTITLED AN ACT

- 1 To amend an Act creating a new charter for the City of Kennesaw, approved April 10, 1971
- 2 (Ga. L. 1971, p. 3620), as amended, so as to change the provisions relating to the corporate
- 3 limits of the city; to repeal conflicting laws; and for other purposes.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

5 **SECTION 1.** An Act creating a new charter for the City of Kennesaw, approved April 10, 1971 (Ga. L. 6 7 1971, p. 3620), as amended, is amended by adding at the end of Section 1.02 the following: 8 "The corporate limits of the City of Kennesaw shall also include the following described 9 parcels of land: 10 TRACTS I AND IV 11 All that tract or parcel of land lying and being in Land Lots 174, 175, and 206 of the 20th 12 District, 2nd Section of Cobb County, Georgia, being more part particularly described as 13 follows: 14 BEGINNING at a iron pin placed at the intersection of the northwesterly right-of-way of 15 Roberts Road (70-foot right-of-way) and the northeasterly right-of-way of Old U.S. Highway 41 (100-foot right-of-way); running thence along the northeasterly right-of-way 16 of U.S. Highway 41 and following the curvature thereof a distance of 200.0 feet (said 17 18
