## A RESOLUTION

- 1 Recognizing and commending Dr. Beverly L. Hall; and for other purposes.
- 2 WHEREAS, Dr. Beverly L. Hall has long been recognized by the citizens of this state for the  
3 vital role that she has played in the teaching profession and her deep personal commitment  
4 to the education of the students of Georgia; and
- 5 WHEREAS, Dr. Hall has served as superintendent of Atlanta Public Schools since 1999, and  
6 her outstanding commitment to the students of Georgia has been recognized with her  
7 selection as the 2009 National Superintendent of the Year by the American Association of  
8 School Administrators, the top professional honor for a K-12 education leader in the United  
9 States; and
- 10 WHEREAS, she is the first superintendent from Georgia to be named National  
11 Superintendent of the Year, and during her tenure as superintendent she has raised the  
12 operational professionalism and the academic performance of the Atlanta Public Schools  
13 system to new heights; and
- 14 WHEREAS, Atlanta Public Schools students' test scores on state and national standardized  
15 tests have risen consistently in her nine-year tenure; and
- 16 WHEREAS, Dr. Hall was recognized in December as the 2009 Georgia Superintendent of  
17 the Year by the Georgia School Superintendents Association and the Georgia School Boards  
18 Association; and
- 19 WHEREAS, other accolades received by Dr. Hall include National Urban Superintendent  
20 of the Year by the Council of the Great City Schools and Superintendent of the Year by the  
21 National Alliance of Black School Educators; and

22 WHEREAS, Dr. Hall has also been honored by the Southern Christian Leadership  
23 Conference; the Concerned Black Clergy; the Big Brothers, Big Sisters of Atlanta; and the  
24 Atlanta Urban Debate League for her contributions to education; and

25 WHEREAS, she has been honored by the Carnegie Corporation with a national humanitarian  
26 award and has been named among the 100 most influential Georgians by *Georgia Trend*  
27 magazine for three consecutive years; and

28 WHEREAS, in recognition of her contributions to the students in this state, it is abundantly  
29 fitting and proper for this body to honor the extraordinary commitment and accomplishments  
30 of this outstanding individual.

31 NOW, THEREFORE, BE IT RESOLVED BY THE SENATE that the members of this body  
32 heartily and gratefully commend Dr. Beverly L. Hall for her sacrifice, foresight,  
33 accomplishment, and contributions on behalf of education in Georgia and for the positive  
34 influence she has had upon the lives and futures of countless young people in this state.
