A BILL TO BE ENTITLED AN ACT

- 1 To amend Article 2 of Chapter 3 of Title 12 of the Official Code of Georgia Annotated,
- 2 relating to state parks and recreational areas generally, so as to provide for permits for the
- 3 construction and maintenance of boat shelters on High Falls Lake; to provide for a transition
- 4 period; to provide for a fee; to provide for inspections; to provide an effective date; to repeal
- 5 conflicting laws; and for other purposes.

6 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

7 SECTION 1.

- 8 Article 2 of Chapter 3 of Title 12 of the Official Code of Georgia Annotated, relating to state
- 9 parks and recreational areas generally, is amended by revising Code Section 12-3-34, relating
- 10 to permits for construction, maintenance, and use of boat docks on High Falls Lake, as
- 11 follows:
- 12 "12-3-34.
- 13 (a) The Department of Natural Resources is authorized to issue revocable permits for the
- 14 construction, maintenance, and use of boat docks <u>and boat shelters</u> on High Falls Lake by
- 15 the owners or lessees of private property abutting the high-water mark of such lake. Such
- permits shall constitute limited revocable licenses. Such permits shall be issued for periods
- of three years from the date of issuance and shall be transferable; provided, however, that
- in order to stagger the renewal periods, the department is authorized to issue permits of one-
- or two-year duration with the fee prorated appropriately. The fee for such permit for each
- 20 three-year period shall be fixed by rule or regulation of the Board of Natural Resources in
- a reasonable amount not to exceed \$50.00 \$75.00 for boat docks and \$75.00 for boat
- 22 <u>shelters</u>. The fees collected for such permits shall be miscellaneous funds for purposes of
- use by the Department of Natural Resources pursuant to Code Section 12-3-2.
- 24 (b) No person shall construct or maintain a boat dock <u>or boat shelter</u> below the high-water
- 25 mark of High Falls Lake without a valid permit from the Department of Natural Resources.

It shall be the duty of the owner of any <u>boat</u> dock <u>or boat shelter</u> on High Falls Lake to keep such dock <u>or shelter</u> in good repair. All such <u>boat</u> docks <u>and boat shelters</u> shall conform to standards for construction, design, maintenance, and repair specified in rules and regulations of the department and restrictions or conditions in the permit. It shall be the duty of the owner of such <u>boat</u> dock <u>or boat shelter</u> to remove any <u>such</u> dock <u>or shelter</u> which is not in

- 32 (c) It shall be the duty of the owner of any <u>boat</u> dock or <u>boat shelter or</u> the holder of any 33 permit issued under this Code section to notify the department when he or she sells or
- otherwise transfers the property for which the boat dock <u>or boat shelter</u> is permitted.

compliance with such rules and regulations or permit.

- 35 (d) The department and any official or employee thereof is authorized to inspect any boat
- dock or boat shelter on High Falls Lake and to remove or cause to be removed any such
- 37 dock <u>or shelter</u> for which a permit is not in effect or which violates the standards for
- 38 construction, design, maintenance, and repair or the permit conditions imposed by the
- 39 department.

- 40 (e) This Code section shall not affect the validity of any permit in effect on March 1, 1993,
- 41 and the owners of docks for which such permits are in effect on March 1, 1993, may
- 42 maintain such docks and enjoy the use thereof for the remainder of the period for which
- such permits were issued, subject to the terms and conditions thereof.
- 44 (f)(e) The Board of Natural Resources is authorized to adopt rules and regulations
- 45 necessary or convenient to carry out this Code section and is authorized to impose
- reasonable terms and conditions on the granting of permits and the construction of boat
- docks and boat shelters on High Falls Lake by the owners or lessees of private property
- abutting the high-water mark of such lake.
- 49 $\frac{g}{f}$ Any permit may be revoked by the department for any violation of this Code section,
- any rule or regulation of the Board of Natural Resources, or any condition contained in such
- 51 permit."

52 SECTION 2.

- 53 This Act shall become effective upon its approval by the Governor or upon its becoming law
- 54 without such approval.

55 SECTION 3.

56 All laws and parts of laws in conflict with this Act are repealed.
