## A RESOLUTION

- 1 Recognizing and commending Business Executives for National Security (BENS) and the
- 2 Georgia Business Force and inviting them to appear before the House of Representatives;

- 5 of Georgia to develop an effective public-private partnership for homeland security and

- 16 affiliated Business Operations Center member companies and associations actively
- 17 participated in training, exercises, and six mobilizations in response to actual emergencies;

- 19 WHEREAS, the Georgia Business Force published guidelines for business response to a
- 20 bioterrorist attack, led regional exercises with a Strategic National Stockpile scenario, and
- 21 constructively introduced a private sector perspective to numerous disaster planning
