A RESOLUTION

- 1 Recognizing March 25, 2009, as Omega Psi Phi Fraternity, Inc., Day at the state capitol; and
- 2 for other purposes.
- 3 WHEREAS, Omega Psi Phi Fraternity, Inc., was founded at Howard University on
- 4 November 17, 1911, by three students, Brother Oscar J. Cooper, M.D., Brother Frank
- 5 Coleman, Ph.D., and Brother Edgar A. Love, D.D., and Brother Ernest E. Just, Ph.D., who
- 6 served as their faculty advisor; and
- 7 WHEREAS, the Eta Chapter of Omega Psi Phi Fraternity, Inc., was founded in Atlanta,
- 8 Georgia, on December 1, 1919, by Harold H. Thomas, Horace A. Hodges, Harvey Smith, and
- 9 Lawrence R. Harper with the aid of Raymond G. Robinson, the Fraternity's seventh Grand
- 10 Basileus, and was chartered on December 27 of that same year, becoming the first chapter
- of any black Greek letter organization to be founded and chartered in the State of Georgia;
- 12 it was renamed Eta Omega Chapter in 1923, "The Mother Pearl of the Seventh District" of
- 13 Omega Psi Phi Fraternity, Inc.; and
- 14 WHEREAS, many members of Omega Psi Phi Fraternity, Inc., have distinguished
- 15 themselves in several different areas of service, to wit: Benjamin E. Mays, distinguished
- 16 President of Morehouse College; Thurbert E. Baker, the first African American Attorney
- 17 General in the State of Georgia; Jesse Hill, the first African American appointed to the
- 18 Georgia Board of Regents; and Eldridge McMillan, the second African American appointed,
- 19 the first African American to chair, and, with his service of over 30 years, the longest serving
- 20 member of the Georgia Board of Regents; and
- 21 WHEREAS, Georgia has produced two Grand Basilei of Omega Psi Phi Fraternity, Inc.,
- Harold Thomas and Mosses C. Norman; and three First Vice Grand Basilei, John Calhoun,
- 23 Jesse O. Thomas, and Joe Brooks; and

24 WHEREAS, Omega Psi Phi Fraternity chapters have raised millions of dollars for

- 28 Representative Joe Heckstall (1967, Kappa Epsilon Chapter); Brother Representative
- 29 Winfred J. Dukes (1975, Gamma Zeta Chapter); Brother Representative Calvin Smyre (1980,
- 30 Lambda Iota Chapter); and Brother Representative Quincy Murphy (1976, Psi Omega

- 32 WHEREAS, the Brother Legislators were assisted in the development of this the first annual
- day of legislative recognition of Omega Psi Phi Fraternity, Inc., in the State of Georgia by
- 34 Brother Dr. H. Benjamin Williams (1962, Beta Gamma Chapter); Brother Benjamin Hill
- 35 (1972, Tau Psi Chapter); Brother Jason Jackson (2001, Eta Omega Chapter); Brother
- 36 Daymetrie Williams (2003, Beta Psi Chapter); Brother Royce Collins (2007, Lambda Phi
- 37 Chapter); and Brother Kenneth English (2008, Eta Omega Chapter) and coordinated by
- 38 Brother William S. Cannon V (1972, Eta Omega Chapter).
- 39 NOW, THEREFORE, BE IT RESOLVED BY THE SENATE that the members of this body
- 40 recognize Omega Psi Phi Fraternity, Inc., and commend the cardinal principles of Manhood,
- 41 Scholarship, Perseverance, and Uplift endorsed by its members and their exemplary public
