A BILL TO BE ENTITLED AN ACT

- 1 To provide for a nonbinding, advisory referendum for the purpose of ascertaining whether
- 2 the General Assembly should enact legislation authorizing the City of Gainesville to select
- 3 its mayor by city-wide election; to provide for legislative purposes and findings; to provide
- 4 for procedures and requirements relating thereto; to provide for a referendum and effective
- 5 dates; to repeal conflicting laws; and for other purposes.

6 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

7 SECTION 1.

- 8 (a) It is the purpose of this Act to provide for a nonbinding, advisory referendum for the
- 9 purpose of ascertaining whether the General Assembly should enact legislation authorizing
- 10 the City of Gainesville to select its mayor by city-wide election.
- 11 (b) It is found, determined, and declared that the holding of the nonbinding, advisory
- 12 referendum provided for in this Act is:
- 13 (1) In all respects for the benefit of the people of the City of Gainesville;
- 14 (2) A public purpose; and
- 15 (3) An essential governmental function for which public funds may be expended.

16 SECTION 2.

- 17 Unless prohibited by the federal Voting Rights Act of 1965, as amended, the municipal
- 18 election superintendent of the City of Gainesville shall call and conduct a nonbinding,
- 19 advisory referendum election as provided in this section for the purpose of submitting a
- 20 question to the electors of the City of Gainesville to determine whether a majority of said
- 21 electors want the General Assembly to enact legislation authorizing the City of Gainesville
- 22 to select its mayor by city-wide election. The municipal election superintendent shall
- 23 conduct that election on the Tuesday after the first Monday in November, 2009, and shall
- 24 issue the call and conduct that election as provided by general law. The municipal election
- 25 superintendent shall cause the date and purpose of the election to be published once a week

26 for two weeks immediately preceding the date thereof in the official organ of Hall County. 27 The ballot shall have written or printed thereon the words: 28 "NONBINDING ADVISORY REFERENDUM 29 Should the General Assembly enact legislation authorizing the City of () YES Gainesville to select its mayor by city-wide election?" 30 () NO All persons desiring to vote for approval of the question shall vote "Yes," and all persons 31 desiring to vote for rejection of the question shall vote "No." The expense of such election 32 shall be borne by the City of Gainesville. It shall be the election superintendent's duty to 33 certify the result thereof to the Secretary of State and to each member of the General 34 Assembly whose senatorial or representative district lies wholly on partially within the City 35 of Gainesville. 36 37 **SECTION 3.**

Except as otherwise provided in Section 2 of this Act, this Act shall become effective upon

its approval by the Governor or upon its becoming law without such approval.
