

House Bill 633 (AS PASSED HOUSE AND SENATE)

A BILL TO BE ENTITLED

AN ACT

1 To amend an Act to provide for an additional \$10,000.00 homestead exemption from certain
 2 City of Alpharetta ad valorem taxes for municipal purposes, approved April 23, 1999 (Ga.
 3 L.1999, p. 4836), as amended, so as to increase the exemption amount from \$30,000.00 to
 4 \$40,000.00 over a two-year phase-in period; to provide for a referendum, effective dates, and
 5 automatic repeal under certain circumstances; to repeal conflicting laws; and for other
 6 purposes.

7 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 **SECTION 1.**

9 An Act to provide for an additional \$10,000.00 homestead exemption from certain City of
 10 Alpharetta ad valorem taxes for municipal purposes, approved April 23, 1999 (Ga. L. 1999,
 11 p. 4836), as amended, is amended by revising subsection (b) of Section 1 to read as follows:

12 "(b)(1) Each resident of the City of Alpharetta is granted an exemption on that person's
 13 homestead from all City of Alpharetta ad valorem taxes for municipal purposes as
 14 follows:

15 (A) For the taxable year beginning on or after January 1, 2010, and prior to
 16 January 1, 2011, in the amount of \$35,000.00 of the assessed value of that homestead;
 17 and

18 (B) For all taxable years beginning on or after January 1, 2011, in the amount of
 19 \$40,000.00 of the assessed value of that homestead.

20 (2) The value of the homestead in excess of any exemption granted therefor shall remain
 21 subject to ad valorem taxation."

22 **SECTION 2.**

23 Unless prohibited by the federal Voting Rights Act of 1965, as amended, the election
 24 superintendent of the City of Alpharetta shall call and conduct an election as provided in this

25 section for the purpose of submitting this Act to the electors of the City of Alpharetta for
 26 approval or rejection. The election superintendent shall conduct that election on the date of
 27 the state-wide general election on November 3, 2009, and shall issue the call and conduct
 28 that election as provided by general law. The superintendent shall cause the date and purpose
 29 of the election to be published once a week for two weeks immediately preceding the date
 30 thereof in the official organ of Fulton County. The ballot shall have written or printed
 31 thereon the words:

32 " YES Shall the Act be approved which increases the homestead exemption from
 33 all City of Alpharetta ad valorem taxes for municipal purposes for residents
 34 NO of the City of Alpharetta from \$30,000.00 to \$40,000.00 after a two-year
 35 phase-in period?"

36 All persons desiring to vote for approval of the Act shall vote "Yes" and all persons desiring
 37 to vote for rejection of the Act shall vote "No." If more than one-half of the votes cast on
 38 such question are for approval of the Act, then Section 1 of this Act shall become of full
 39 force and effect on January 1, 2009, and shall be applicable to all taxable years beginning on
 40 or after January 1, 2010. If Section 1 of this Act is not so approved or if the election is not
 41 conducted as provided in this section, Section 1 of this Act shall not become effective and
 42 this Act shall be automatically repealed on the first day of January immediately following
 43 that election date. The expense of such election shall be borne by the City of Alpharetta. It
 44 shall be the superintendent's duty to certify the result thereof to the Secretary of State.

45 **SECTION 3.**

46 Except as otherwise specified in Section 2 of this Act, this Act shall become effective upon
 47 its approval by the Governor or upon its becoming law without such approval.

48 **SECTION 4.**

49 All laws and parts of laws in conflict with this Act are repealed.
