A RESOLUTION

1 Congratulating Mr. Burrell Ellis on his election as Chief Executive Officer of DeKalb
2 County; and for other purposes.

4 vital role that he has played in leadership and his deep personal commitment to the welfare
5 of the citizens of DeKalb County and the State of Georgia; and

21 Men of America, Big Brothers and Big Sisters, the Democratic Party, and his church, St.
22 Philip AME; and

23 WHEREAS, Mr. Ellis is united in love and marriage to his wife, Philippa, and they have
24 been blessed with two remarkable children, Victoria and Burrell III; and

25 WHEREAS, it is abundantly fitting and proper that the outstanding accomplishments of this
26 remarkable and distinguished Georgian be appropriately recognized.
