- 16 WHEREAS, on March 16, 1994, the GISC held its first gathering at Mr. Kennan Carter's
- 17 club, Ziggy Mahoney's in St. Simons, and these dedicated dancers have been shagging there
- 18 once a week ever since; and
- 19 WHEREAS, the GISC has heightened the appreciation of shagging with dedicated officers
- 20 Judy Bennett, Tom Holmes, Donita Taylor, and Frank Cullen; and board members Angie
- 21 Michael, Jim Belvin, Jim Royal, Pat Rountree, Richard Applegate, Jimmy Stevenson, and
- 22 Phyllis Buffkin.
