## A RESOLUTION

1 Recognizing April 10, 2009, as 100 Black Women Empowerment Day at the state capitol;  
2 and for other purposes.

3 WHEREAS, the National Coalition of 100 Black Women, Inc., (NCBW) consists of more  
4 than 7,000 members representing 63 chapters in 24 states around the nation; and

5 WHEREAS, NCBW was founded with the purpose of developing socially conscious female  
6 leaders who are committed to furthering equity and empowerment for women of color in  
7 society at large; and

8 WHEREAS, members of the NCBW are dedicated to improving the environment of their  
9 neighborhoods, rebuilding their communities, and enhancing the quality of public and private  
10 resources for the growth and development of disadvantaged youth; and

11 WHEREAS, the Stone Mountain-Lithonia Chapter of NCBW has organized its first coalition  
12 of advocacy day summit, entitled A United Voice for Change - A Day of Empowerment and  
13 Motivation, to be held at the state capitol on April 10, 2009, from 9 A.M. to 3 P.M.; and

14 WHEREAS, this innovative event will bring together over 100 women from across the  
15 metropolitan Atlanta area to meet with their elected officials and provide them with the  
16 opportunity to urge their officials to support issues such as affordable and accessible health  
17 care, quality education for all children, and solutions to the area's problem with high  
18 foreclosure rates; and

19 WHEREAS, keynote speaker for this important gathering is NCBW founder Jewell Jackson  
20 McCabe, who will lead the effort to educate those in attendance of the legislative process and  
21 facilitate an open dialogue between elected officials and members of the NCBW regarding  
22 issues that affect the African American community; and

23 WHEREAS, the guiding leadership of the Stone Mountain-Lithonia Chapter of NCBW  
24 president, Lynita Mitchell Blackwell, and vice president and chairman of empowerment day,  
25 Talvia Peterson, have made this outstanding event possible; and

26 WHEREAS, many leaders of the Georgia General Assembly and Georgia government are  
27 members of local chapters of the NCBW, including Representative Pamela Stephenson,  
28 Representative Alisha Thomas-Morgan, Representative Dee Dawkins-Haigler,  
29 Commissioner Connie Stokes, and Commissioner Sharon Barnes Stutton.

30 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES that  
31 the members of this body commend the National Coalition of 100 Black Women, Inc., and  
32 its Stone Mountain-Lithonia Chapter; recognize April 10, 2009, as 100 Black Women  
33 Empowerment Day at the state capitol; and extend their most sincere best wishes to the  
34 organization for its continued success.

35 BE IT FURTHER RESOLVED that the Clerk of the House of Representatives is authorized  
36 and instructed to transmit an appropriate copy of this resolution to the Stone  
37 Mountain-Lithonia Chapter of the National Coalition of 100 Black Women.
