5 WHEREAS, of the four major annual golf tournaments, the Augusta event is the only one 6 that is held at the same venue year after year; and

7 WHEREAS, visitors for the Augusta Masters Tournament will be in Augusta, Georgia, from
8 April 6-12, 2009; and

- 9 WHEREAS, the purpose of the Georgia Golf Hall of Fame is to preserve golf history in both
- 10 the state and region, to honor those who have produced lasting contributions to the sport of
- 11 golf in this state or elsewhere, and to inspire Georgia youth involved in golf to reach their

- 13 WHEREAS, the Georgia Golf Hall of Fame is dedicated to the preservation and promotion
- 14 of Georgia's golf traditions, heritage, achievements, and excellence; and
- 15 WHEREAS, the Georgia Golf Hall of Fame supports the goals of honoring the game of golf,
- 16 identifying and selecting candidates for induction into the Georgia Golf Hall of Fame,
- 17 enshrining individual contributions or achievements in the sport of golf or golf industry, and
- 18 paying tribute to those inducted into the Georgia Golf Hall of Fame; and

WHEREAS, the Georgia Golf Hall of Fame is committed to preserving and illustrating golf
history in the State of Georgia; promoting golf and golf heritage in the State of Georgia;
promoting this state's golf clubs, organizations, and associations; enhancing public
