- 4 vital role that he has played in leadership and his deep personal commitment to the welfare
- 5 of the citizens of Georgia; and

- 6 WHEREAS, he has diligently and conscientiously devoted innumerable hours of his time,
- 7 talents, and energy toward the betterment of his community and improving the lives of at-risk
- 8 youths as evidenced dramatically by his years of superlative service with the Boys & Girls
- 9 Clubs organization; and

- 10 WHEREAS, Mr. Tipton began his career with Boys & Girls Clubs as a part-time staff
- 11 member while he attended college; and

- 12 WHEREAS, after graduating Magna Cum Laude from East Tennessee State University, Mr.
- 13 Tipton accepted a position at the Kingsport Tennessee Boys Club, where he eventually
- 14 became executive director; and

- 15 WHEREAS, in 1981, Mr. Tipton relocated to the Atlanta area and was named director of
- 16 operations for the Atlanta Club, where he played a vital role in merging the Atlanta Boys
- 17 Club and the Atlanta Girls Club into a single organization; and

- 18 WHEREAS, his passion for improving and uplifting the lives of at-risk children has been
- 19 recognized with numerous awards and accolades, and his excellent leadership skills and keen
- 20 sense of vision have earned him the respect and admiration of his colleagues and associates;

22 WHEREAS, his reputation as an ambassador for the Boys & Girls Clubs program
23 contributed to him earning the position of president and chief professional officer of Boys
24 & Girls Clubs of Metro Atlanta in 1994; and

25 WHEREAS, under his guidance, the organization grew to 30 Clubs, serving over 17,000
26 youth in the metropolitan Atlanta area; and

27 WHEREAS, it is abundantly fitting and proper that the outstanding accomplishments of this
28 remarkable and distinguished Georgian be appropriately recognized.

29 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES that
30 the members of this body commend Mr. Jerry Tipton for his over five decades of efficient,
31 effective, unselfish, and dedicated service on behalf of at-risk youth; congratulate him upon
