

## Senate Resolution 931

## A RESOLUTION

1 Honoring and celebrating the 91st birthday of Mr. Frank C. Sidella; and for other purposes.

2 WHEREAS, Mr. Frank C. Sidella has long been recognized by the citizens of this nation for  
3 the vital role that he has played in leadership and his deep personal commitment to the  
4 welfare of the citizens of the United States; and

5 WHEREAS, he earned a bachelor's degree from Temple University, master's degrees in  
6 taxation and public administration from Southeastern University, and a doctoral degree from  
7 Pacific Western University; and

8 WHEREAS, Mr. Sidella served as a guardian of this nation's freedom and liberty for nearly  
9 three decades with the United States Army in the infantry, counter-intelligence, and military  
10 police corps, valiantly and courageously protecting democracy during World War II and the  
11 Korean and Vietnam conflicts; and

12 WHEREAS, after his retirement from the military as a Lt. Colonel in 1970, Mr. Sidella  
13 worked for the U.S. Marshals Service in Washington, D.C., where he assisted in the  
14 development of training programs and the establishment of the first U.S. Marshals Service  
15 training academy; and

16 WHEREAS, his leadership was invaluable to the Consolidated Federal Law Enforcement  
17 Training Center as a Special Assistant to the Director and as Assistant Associate Director for  
18 Programs and Academics at the National Emergency Training Center for FEMA; and

19 WHEREAS, Mr. Sidella was recognized with the U.S. Marshals Service's Commendation  
20 for Outstanding Service in honor of his initiative, creativity, and dedication to the tasks of  
21 establishing required training and education at the National Emergency Training Center, the  
22 1969 Freedom's Foundation Award, and the George Washington Honor Medal; and

23 WHEREAS, an outstanding community servant, Mr. Sidella has served as a field supervisor  
24 for the U.S. Census, director of the Sea Palms Property Owners Association, and a member  
25 of the St. Simons Island Rotary Club; and

26 WHEREAS, he is a person of magnanimous strengths with an unimpeachable reputation for  
27 integrity, intelligence, fairness, and honor, and by the example he has made of his life and  
28 the great service he has given to this country, he makes this world a better place in which to  
29 live, and it is only fitting and proper that he be appropriately recognized during this very  
30 special and memorable time of his life.

31 NOW, THEREFORE, BE IT RESOLVED BY THE SENATE that the members of this body  
32 join in commending Mr. Frank C. Sidella on the occasion of his 91st birthday and wishing  
33 him many more years of happiness.
