A BILL TO BE ENTITLED
AN ACT

1 To amend Title 40 of the Official Code of Georgia Annotated, relating to motor vehicles and
2 traffic, so as to provide a limitation on the amount charged for motor vehicle registration
3 records; to establish the frequency of updates of motor vehicle registration records that must
4 be provided; to provide for related matters; to repeal conflicting laws; and for other purposes.

6 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

7 **SECTION 1.**

8 Title 40 of the Official Code of Georgia Annotated, relating to motor vehicles and traffic, is
9 amended by revising subsection (d) of Code Section 40-2-130, relating to records of
10 certificates of registration, as follows:

11 "(d) Except as otherwise required in the federal Driver's Privacy Protection Act of 1994,
12 18 U.S.C. Chapter 123, personal information furnished under paragraphs (1) through (5)
13 of subsection (c) of this Code section shall be limited to the natural person's name, address,
14 and driver identification number. The personal information obtained by a business under
15 this Code section shall not be resold or redisclosed for any purposes other than those
16 permitted under the federal Driver's Privacy Protection Act of 1994, 18 U.S.C. Chapter
17 123, without the written consent of the individual. Furnishing of information to a business
18 under this Code section shall be pursuant to a contract entered into by such business and
19 the state which specifies the consideration to be paid by such business to the state for such
20 information ~~and the frequency of updates, which shall not exceed \$1,000.00 per year. The~~
21 frequency of the updates of such information provided to a business shall be no less than
22 weekly, unless the business requests that the information be provided on a less frequent
23 basis."

24 **SECTION 2.**

25 Said title is further amended by revising subsection (f) of Code Section 40-3-23, relating to
26 the issuance of certificate of title, maintenance of record of certificates issued, public
27 inspection, and furnishing records for fee, as follows:

28 "(f) Except as otherwise required in the federal Driver's Privacy Protection Act of 1994,
29 18 U.S.C. Chapter 123, personal information furnished under paragraphs (1), (2), and (3)
30 of subsection (d) of this Code section shall be limited to the natural person's name, address,
31 and driver identification number. The personal information obtained by a business under
32 this Code section shall not be resold or redisclosed for any purposes other than those
33 permitted under the federal Driver's Privacy Protection Act of 1994, 18 U.S.C. Chapter
34 123, without the written consent of the individual. Furnishing of information to a business
35 under this Code section shall be pursuant to a contract entered into by such business and
36 the state which specifies the consideration to be paid by such business to the state for such
37 information ~~and the frequency of updates, which shall not exceed \$1,000.00 per year. The~~
38 frequency of the updates of such information provided to a business shall be no less than
39 weekly, unless the business requests that the information be provided on a less frequent
40 basis."

41 **SECTION 3.**

42 All laws and parts of laws in conflict with this Act are repealed.
