7 WHEREAS, he has served Monroe County and the Flint Judicial Circuit for the past 56 8 years, being elected and serving as the Solicitor General of the Flint Judicial Circuit from 9 1954-1963, as the sole Judge of the Superior Court, Flint Judicial Circuit, from 1964-1978, 10 and serving as a Senior Judge from 1978 to the present; and

11 WHEREAS, the Honorable Hugh D. Sosebee has had a profound effect on Monroe County 12 by envisioning and helping to build the first and present hospital in Monroe County as a 13 member of the Hospital Board, by serving as a charter member of the Monroe County 14 Chamber of Commerce, and by serving as the County Attorney and the City Attorney of 15 Forsyth, Georgia; and

WHEREAS, he served as the longest serving member of the State Bar of Georgia Board of 16 17 Governors, as a Justice of the Supreme Court of Georgia during disqualifications, and as a

charter member of the Georgia Code Revision Committee; and 18

WHEREAS, the Honorable Hugh D. Sosebee has devoted his life to his family, community, 19

20 State, and God; and his tireless work, personal honesty and integrity, and dedication to the

21 courts has inspired confidence in the judicial system as a whole.
