A BILL TO BE ENTITLED AN ACT

- 1 To amend Title 46 of the Official Code of Georgia Annotated, relating to public utilities and
- 2 public transportation, so as to provide for the regulation of private emergency warning point
- 3 to multipoint systems by the Public Service Commission; to define certain terms; to provide
- 4 for audits; to provide for immunity from liability for failure to deliver information over an
- 5 emergency warning point to multipoint system; to provide for related matters; to repeal
- conflicting laws; and for other purposes. 6

BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 **SECTION 1.** 9 Title 46 of the Official Code of Georgia Annotated, relating to public utilities and public 10 transportation, is amended by revising paragraph (5.1) of Code Section 46-1-1, relating to 11 definitions, exclusions, and certain rules, as follows: 12 "(5.1) 'Exempt rideshare' means: 13 (A) Government endorsed rideshare programs; 14 (B) Rideshare programs in which a rideshare driver seeks reimbursement for, or the 15 rideshare participants pool or otherwise share, rideshare costs such as fuel; or 16 (C) The leasing or rental of a vehicle, in the ordinary course of the lessor's or rentor's 17 business, for rideshare purposes as part of a government endorsed rideshare program, 18 or for rideshare under a contract requiring compliance with subparagraph (B) of this 19 paragraph. 'Emergency warning point to multipoint system' means an emergency warning point to multipoint, geographic messaging system that is: 20 21 (A) Owned, controlled, or offered by a private company, individual, firm, partnership, or association; and 22 23 (B) Operated in whole or in part in this state utilizing: 24

- (i) The FM 57 kHz Radio Broadcast Data System standard and a codeable,
- 25 programmable receiver; or
- 26 (ii) The FM broadcast band generally and a codeable, programmable receiver."

27	SECTION 2.
28	Said title is further amended by adding new paragraphs to Code Section 46-1-1, relating to
29	definitions, exclusions, and Georgia Forest Products Trucking Rules, to read as follows:
30	"(5.2) 'Emergency warning point to multipoint system provider' means a private company
31	providing emergency warning point to multipoint system services to the public.
32	(5.3) 'Emergency warning point to multipoint system services' means the provision of
33	an emergency warning point to multipoint system to the public including but not limited
34	to the wireless addresses for delivery, testing, and monitoring over the FM broadcast
35	<u>band.</u>
36	(5.4) 'Exempt rideshare' means:
37	(A) Government endorsed rideshare programs;
38	(B) Rideshare programs in which a rideshare driver seeks reimbursement for, or the
39	rideshare participants pool or otherwise share, rideshare costs such as fuel; or
40	(C) The leasing or rental of a vehicle, in the ordinary course of the lessor's or rentor's
41	business, for rideshare purposes as part of a government endorsed rideshare program,
42	or for rideshare under a contract requiring compliance with subparagraph (B) of this
43	paragraph."
44	SECTION 3.
45	Said title is further amended by adding a new Code section to read as follows:
46	" <u>46-2-22.1.</u>
47	All emergency warning point to multipoint systems shall be under the jurisdiction and
48	control of the commission, which shall have full power to regulate and determine just and
49	reasonable rates and charges to be made by any emergency warning point to multipoint
50	system provider for any service performed by such provider."
51	SECTION 4.
52	Said title is further amended by adding a new chapter to read as follows:
52	"CHAPTED 12
53	"CHAPTER 12
54	46-12-1.
55	(a) At least once every five years, the commission shall cause to be performed a
56	management audit of each emergency warning point to multipoint system provider to
57	determine whether it is being managed in an efficient and effective manner.
58	(b) The management audit provided for in this Code section shall be performed by a
59	qualified and reputable management auditor of national reputation, to be selected by the
	4 reputation of national reputation, to be belocted by the

60 commission from a list of not less than three such auditors, which list shall be made up by 61 mutual agreement of the commission and the emergency warning point to multipoint 62 system provider. The management auditor shall report the results of the audit to the 63 commission. 64 (c) In the event that the commission and the emergency warning point to multipoint system provider are unable to agree on a list of management auditors, either party may petition the 65 66 Superior Court of Fulton County to select, within 30 days of filing, such a list after a 67 hearing on the petition. 68 (d) The audited emergency warning point to multipoint system provider shall pay for the 69 management audit. The cost of the management audit shall be recognized by the 70 commission as an operating expense of the emergency warning point to multipoint system 71 provider; and the emergency warning point to multipoint system provider's rates shall be 72 fixed by the commission to recover this retail expense amortized over such period as the

- 75 <u>Municipal corporations, counties, consolidated governments, or any other political</u>

- 77 <u>to multipoint system providers shall not be liable for failure to deliver information over an</u>
- 78 emergency warning point to multipoint system."

80 All laws and parts of laws in conflict with this Act are repealed.
