## A RESOLUTION

1 Recognizing and commending Mrs. Peggy Gainer on her outstanding public service; and for  
2 other purposes.

3 WHEREAS, Mrs. Peggy Gainer has long been recognized by the citizens of this state for the  
4 vital role that she has played in leadership and her deep personal commitment to the welfare  
5 of the citizens of Georgia; and

6 WHEREAS, she has diligently and conscientiously devoted innumerable hours of her time,  
7 talents, resources, and energy for 50 years toward the betterment of her community and state  
8 as evidenced dramatically by her superlative service to the Newton Medical Center  
9 Auxiliary; and

10 WHEREAS, Mrs. Gainer was one of the founding members of the Newton Medical Center  
11 Auxiliary in 1960 which has raised nearly \$2 million for various projects in all areas of the  
12 hospital; and

13 WHEREAS, Mrs. Gainer's significant organizational and leadership talents, her remarkable  
14 patience and diplomacy, her keen sense of vision, and her sensitivity to the needs of the  
15 citizens of this state have earned her the respect and admiration of her fellow volunteers as  
16 well as hospital staff and administration; and

17 WHEREAS, in recognition for her unwavering support of the Newton Medical Center  
18 Auxiliary, the hospital's auxiliary office has been renamed The Gainer Center in her honor;

20 WHEREAS, Mrs. Gainer is the only charter member still active in the organization and  
21 served as the auxiliary's first treasurer; and

22 WHEREAS, she served as president of the auxiliary from 1980 to 1982, is the founder of the  
23 auxiliary's Cinderella Shop, and has served in nearly every auxiliary office; and

24 WHEREAS, she is a person of magnanimous strengths with an unimpeachable reputation for  
25 integrity, intelligence, fairness, and kindness; and

26 WHEREAS, Mrs. Gainer has served with honor and distinction with the Newton Medical  
27 Center Auxiliary, and her vision and unyielding commitment have set the standard for public  
28 service; and

29 WHEREAS, it is abundantly fitting and proper that the outstanding accomplishments of this  
30 remarkable and distinguished Georgian be appropriately recognized.

31 NOW, THEREFORE, BE IT RESOLVED BY THE SENATE that the members of this body  
32 commend Mrs. Peggy Gainer for her efficient, effective, unselfish, and dedicated public  
33 service to the Newton Medical Center Auxiliary and the State of Georgia.
