A RESOLUTION

1 Recognizing and commending Representative Roger Bruce in appreciation for his service
2 to the citizens of Douglas and Fulton counties; and for other purposes.

3 WHEREAS, Representative Roger Bruce has long been recognized by the citizens of this
4 state for the vital role that he has played in leadership and his deep personal commitment to
5 the welfare of the citizens of Georgia; and

6 WHEREAS, first elected in 2002, Representative Bruce serves the constituents of House
7 District 64, which includes parts of Atlanta and unincorporated parts of Douglas and Fulton
8 counties; and

9 WHEREAS, a native of Harlem, New York, Representative Bruce graduated as the battalion
10 executive officer at St. Emma Military Academy and studied political science at Morehouse
11 College, where he was president of the Political Science Club and reinstated the Frederick
12 Douglas Tutorial Institute to help struggling high school students; and

13 WHEREAS, as a member of the House of Representatives, Representative Bruce has served
14 as the Fulton County Delegation chairperson since 2009, the delegation's vice chairperson
15 since 2002, and is a member of the House Committees on Game, Fish, and Parks; Judiciary;
16 and Small Business Development and Job Creation; and

17 WHEREAS, a member of the 1980 Leadership Atlanta class, Representative Bruce has
18 focused much of his work on helping elderly and young people, serving as the original
19 sponsor for the Time Out for Schools Act, which allows parents time off from work to attend
20 school meetings without fear of termination; and

21 WHEREAS, a compassionate community leader, Representative Bruce serves on the Usher
22 Board at Cascade United Methodist Church, is on the board of trustees for the

23 Interdenominational Theological Center, and serves on the board of the Fulton Atlanta
24 Community Action Authority and All Children are Special; and

25 WHEREAS, Representative Bruce's significant organizational and leadership talents, his
26 remarkable patience and diplomacy, his keen sense of vision, and his sensitivity to the needs
27 of the citizens of this state have earned him the respect and admiration of his colleagues and
28 associates; and

29 WHEREAS, Representative Bruce has served with honor and distinction with the Georgia
30 House of Representatives, and his vision and unyielding commitment to the citizens of
31 Fulton County and Georgia have set the standard for public service; and

32 WHEREAS, it is abundantly fitting and proper that the outstanding accomplishments of this
33 remarkable and distinguished Georgian be appropriately recognized.

34 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES that
35 the members of this body commend Representative Roger Bruce for his efficient, effective,
36 unselfish, and dedicated public service to the State of Georgia.
