

House Bill 216

A BILL TO BE ENTITLED
AN ACT

1 To amend Article 1 of Chapter 2 of Title 46 of the Official Code of Georgia Annotated,
2 relating to the organization and members of the Public Service Commission, to change
3 certain provisions relating to the chairperson of the commission and his or her selection; to
4 provide for related matters; to repeal conflicting laws; and for other purposes.

5 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

6 style="text-align:center">**SECTION 1.**

7 Article 1 of Chapter 2 of Title 46 of the Official Code of Georgia Annotated, relating to the
8 organization and members of the Public Service Commission, is amended by revising Code
9 Section 46-2-5, relating to the chairperson of the Public Service Commission and selection,
10 as follows:

11 "46-2-5.

12 (a) There shall be a ~~chairman~~ chairperson of the commission. The ~~chairman~~ chairperson
13 shall be selected on an annual basis and shall take office within 15 days after the first day
14 of January. ~~The initial chairman selected under this Code section shall take office within~~
15 ~~15 days after April 20, 1992, and shall serve for a term of office as chairman expiring~~
16 ~~January 1, 1993. Thereafter a new chairman shall take office within 15 days after the first~~
17 ~~day of January in 1993 and each subsequent year, and each such chairman shall serve for~~
18 ~~a one-year term of office as chairman.~~

19 (b) The ~~chairman~~ chairperson shall be selected by the members of the commission
20 according to the following rules; and for purposes of these rules, seniority on the
21 commission shall be determined according to the longest period of continuous unbroken
22 service:

23 (1) A member of the commission with less than one year of continuous unbroken service
24 on the commission shall not be eligible to take office as ~~chairman~~ chairperson;

25 (2) A member of the commission who has previously served as ~~chairman~~ chairperson
26 shall not be eligible to serve again as ~~chairman~~ chairperson until each other eligible

27 member (i.e., each other member with more than one year of continuous service on the
28 commission) has served as ~~chairman~~ chairperson or has deferred service as ~~chairman~~
29 chairperson;

30 (3) Subject to paragraphs (1) and (2) of this subsection, the most senior member of the
31 commission who is eligible to serve as ~~chairman~~ chairperson shall be selected to the
32 office of ~~chairman~~ chairperson; provided, however, that such member may elect to defer
33 service as ~~chairman~~ chairperson for a period of one year, at the conclusion of which year
34 such member shall resume his or her place at the head of the order of rotation for the
35 ~~chairmanship~~ chairpersonship; and

36 (4) If in any year the foregoing rules fail to provide for a ~~chairman~~ chairperson because
37 two or more members have equal seniority, then the member to serve as ~~chairman~~
38 chairperson shall be selected by lot.

39 (c) Anything in subsection (b) of this Code section to the contrary notwithstanding, the
40 members of the commission may by ~~unanimous~~ majority vote of the members select any
41 member as ~~chairman~~ chairperson for any given year for a term of office as ~~chairman~~
42 chairperson as specified in subsection (a) of this Code section.

43 (d) The ~~chairman~~ chairperson shall give his or her entire time to the duties of his or her
44 office."

46 All laws and parts of laws in conflict with this Act are repealed.
