A RESOLUTION

1 Recognizing and commending Ms. Marjorie Seon on her outstanding public service; and for
2 other purposes.

3 WHEREAS, Ms. Marjorie Seon has long been recognized by the citizens of this state for the
4 vital role that she has played in leadership and her deep personal commitment to the welfare
5 of the citizens of Georgia; and

6 WHEREAS, she has diligently and conscientiously devoted innumerable hours of her time,
7 talents, and energy toward the betterment of her community and state as evidenced
8 dramatically by her superlative service as a Cobb County Court Appointed Special Advocate
9 (CASA) for the past four years; and

10 WHEREAS, Ms. Seon has served 18 children involved in the juvenile court system due to
11 abuse and neglect, driving hundreds of miles and logging countless hours to advocate for
12 children in crisis; and

13 WHEREAS, as a CASA volunteer, Ms. Seon appears in court, writes reports, contacts family
14 members, visits with the children at least once a month, and remains actively involved until
15 the children are placed in a safe, permanent home; and

16 WHEREAS, a native of New York, Ms. Seon has an extensive background with domestic
17 violence awareness, an area in which she also volunteers her free time; and

18 WHEREAS, Ms. Seon works as a business office associate, where she has been recognized
19 for her volunteer work with a community service award; and

20 WHEREAS, her significant organizational and leadership talents, her remarkable patience
21 and diplomacy, her keen sense of vision, and her sensitivity to the needs of the citizens of
22 this state have earned her the respect and admiration of her colleagues and associates; and

23 WHEREAS, Ms. Seon is the proud mother of two sons, Donald and Darren, and her
24 stepdaughter, June; and

25 WHEREAS, she is a person of magnanimous strengths with an unimpeachable reputation for
26 integrity, intelligence, fairness, and kindness; and

27 WHEREAS, Ms. Seon has served with honor and distinction as a Cobb County CASA and
28 her vision and unyielding commitment have set the standard for public service; and

29 WHEREAS, it is abundantly fitting and proper that the outstanding accomplishments of this
30 remarkable and distinguished Georgian be appropriately recognized.

31 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES that
32 the members of this body commend Ms. Marjorie Seon for her efficient, effective, unselfish,
33 and dedicated public service to the children of Cobb County.
