

Senate Bill 157

A BILL TO BE ENTITLED
AN ACT

1 To amend Chapter 8 of Title 12 of the Official Code of Georgia Annotated, relating to waste
2 management, so as to provide that local solid waste management and reporting shall be
3 optional; to provide for related matters; to repeal conflicting laws; and for other purposes.

4 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

5 style="text-align:center">**SECTION 1.**

6 Chapter 8 of Title 12 of the Official Code of Georgia Annotated, relating to waste
7 management, is amended by revising Code Section 12-8-31.1, relating to local,
8 multijurisdictional, or regional solid waste plans, as follows:

9 "12-8-31.1.

10 (a) Each city and county in Georgia shall develop or be included in a comprehensive solid
11 waste management plan not later than July 1, 1993. Said plan may be developed
12 independently as a local plan or jointly with other jurisdictions as a multijurisdictional or
13 regional solid waste plan, ~~and shall conform to the plan development procedures developed~~
14 ~~and promulgated by the~~ The Department of Community Affairs under the provisions of
15 Chapter 13 of Title 50 shall promulgate solid waste planning guidance that a city or county
16 may use to update or amend such city or county's solid waste plan.

17 (b) The local, multijurisdictional, or regional solid waste plan and plan updates shall, at
18 a minimum, provide for the assurance of adequate solid waste handling capability and
19 capacity within the planning area for at least ten years from the date of completion of the
20 plan which shall specifically include an adequate collection and disposal capability; shall
21 enumerate the solid waste handling facilities as to size and type; and shall identify those
22 sites which are not suitable for solid waste handling facilities based on environmental and
23 land use factors.

24 (c) ~~The review process for local, multijurisdictional, and regional solid waste management~~
25 ~~plans shall be in such form as developed and promulgated by the Department of~~
26 ~~Community Affairs under the provisions of Chapter 13 of Title 50. The regional~~

27 ~~commission for each geographical location in which a local, multijurisdictional, or regional~~
 28 ~~plan applies shall confirm that the local, multijurisdictional, or regional plan is consistent~~
 29 ~~with the state solid waste management plan~~ To be included as part of a local,
 30 multijurisdictional, or regional solid waste plan, each city and county included as part of
 31 the plan shall adopt the plan and any plan updates by local ordinance or resolution.

32 (d) Effective January 1, 1992, each city and county ~~shall~~ may report annually to the
 33 Department of Community Affairs on the status of solid waste management in the
 34 jurisdiction. Such reports may be individual or collective in nature or, in lieu of local
 35 reports, a regional report may be filed by any of the several regional commissions for
 36 political jurisdictions within their region. The annual report ~~shall~~ may include but not be
 37 limited to:

- 38 (1) The amount of solid waste collected, processed, and disposed of in the area;
- 39 (2) The progress on the reduction in solid waste, as evidenced by the solid waste
 40 received at disposal facilities, ~~which are not exempt from subsection (c) of Code~~
 41 ~~Section 12-8-21~~, in the planning area since the previous reporting period and total
 42 cumulative progress made toward meeting the 25 percent waste reduction goal goals of
 43 the state;
- 44 (3) The remaining permitted capacity of disposal facilities;
- 45 (4) Recycling and composting activities in existence;
- 46 (5) Public information and education activities during the reporting period; and
- 47 (6) Any other pertinent information as may be required.

48 (e) After July 1, 1992, no permit, grant, or loan shall be issued for any municipal solid
 49 waste disposal facility or any solid waste handling equipment or recycling equipment used
 50 in conjunction therewith in a county or region which is not consistent with a local,
 51 multijurisdictional, or regional solid waste management plan. Each application for a
 52 permit, grant, or loan issued after July 1, 1992, shall include the following:

- 53 (1) Certification that the facility for which a permit is sought complies with local land
 54 use and zoning requirements, if any;
- 55 (2) Verification that the facility for which a permit is sought meets the ten-year capacity
 56 needs identified in the local, multijurisdictional, or regional solid waste management
 57 plan; and
- 58 (3) Demonstration that the host jurisdiction and all jurisdictions generating solid waste
 59 destined for the applicant's facility are part of an approved solid waste management plan
 60 or updated plan developed in accordance consistent with standards promulgated pursuant
 61 to this part, and are actively involved in, and have a strategy for, meeting the state-wide
 62 goal for reduction of solid waste disposal ~~by July 1, 1996~~.

63 (f) This Code section shall not apply to:

64 (1) Any solid waste disposal facility which is operated exclusively by a private solid
 65 waste generator on property owned by the private solid waste generator for the purpose
 66 of accepting solid waste exclusively from the private solid waste generator so long as the
 67 operation of the solid waste disposal facility does not adversely affect the public health
 68 or the environment. After commencement of operation by a private solid waste generator
 69 of a solid waste disposal facility which is permitted but not included in a local or regional
 70 solid waste management plan, an amendment into a local or regional solid waste
 71 management plan shall be required for any solid waste which is to be no longer disposed
 72 of by the private solid waste generator in its own solid waste disposal facility prior to any
 73 substantial reduction in the amount of solid waste accepted by the solid waste disposal
 74 facility or its closure; or

75 (2) Effective September 1, 1994, any privately owned solid waste handling facility
 76 seeking a permit or major modification of an existing permit where the host local
 77 governing authority has failed ~~either to submit or to~~ to make a good faith effort, as
 78 determined by the Department of Community Affairs, to ~~submit~~ develop and adopt a
 79 local solid waste management plan or to be included in a multijurisdictional or regional
 80 solid waste management plan; provided, however, that the permit applicant continues to
 81 be obligated to demonstrate that all generating jurisdictions from which waste will be
 82 received are part of an approved solid waste management plan developed in accordance
 83 with ~~standards~~ planning guidance promulgated pursuant to this part and have a strategy
 84 to meet and are actively engaged in meeting the state-wide goal of reducing waste ~~by 25~~
 85 ~~percent by July 1, 1996.~~

86 (g) Effective July 1, 1991, it shall be the responsibility of the owner or operator of each
 87 municipal solid waste disposal facility to keep an accurate written record of all amounts of
 88 solid waste measured in tons received at the facility. Measurement in tons of solid waste
 89 received shall be accomplished by one or more of the following methods:

90 (1) The provision of stationary or portable scales at the disposal facility for weighing
 91 incoming waste;

92 (2) Implementation of contractual or other arrangements for the use of scales at a
 93 location other than the disposal facility for weighing all waste destined for disposal at the
 94 facility; or

95 (3) Implementation of contractual or other arrangements for the use of scales at a
 96 location other than the disposal facility to weigh representative samples of the solid waste
 97 received at the disposal facility on a basis which is sufficiently frequent to estimate
 98 accurately the amount of solid waste received at the disposal facility."

SECTION 2.

100 Said chapter is further amended by repealing and reserving Code Section 12-8-39.2, relating
101 to reports of costs of solid waste management services.

SECTION 3.

103 All laws and parts of laws in conflict with this Act are repealed.
