A BILL TO BE ENTITLED AN ACT

- 1 To amend Chapter 41 of Title 31 of the Official Code of Georgia Annotated, relating to lead
- 2 poisoning prevention, so as to provide for certain federal regulations copies, fees, corrective
- 3 orders, and violations related to such chapter; to provide for legislative purpose; to provide
- 4 an effective date; to repeal conflicting laws; and for other purposes.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

6 SECTION 1.

- 7 The purpose of this Act is to reenact the provisions of former Code Section 31-41-6, relating
- 8 to federal regulations copies, fees, corrective orders, and violations relative to lead poisoning
- 9 prevention, as such Code section existed immediately prior to its repeal on May 27, 2010,
- 10 by SB 78.

- 11 SECTION 2.
- 12 Chapter 41 of Title 31 of the Official Code of Georgia Annotated, relating to lead poisoning
- prevention, is amended by adding a new Code section to read as follows:
- 14 <u>"31-41-6.</u>
- 15 (a) The department shall make available to all persons licensed or certified under this
- 16 <u>chapter current federal regulations affecting such licensees or certified persons.</u>
- 17 (b) The department is authorized to charge an application fee, a license fee, a license
- renewal fee, or a similar fee and the amount of such fees shall be established by the Board
- of Natural Resources. Each fee so established shall be reasonable and shall be determined
- in such a manner that the total of the fees charged shall approximate the total of the direct
- 21 and the indirect costs to the state of the operation of the licensing program. Fees may be
- 22 <u>refunded for good cause as determined by the department.</u>
- 23 (c) The department is authorized to issue a corrective order to any person in violation of
- 24 <u>this chapter or any regulation promulgated pursuant thereto. The order shall specify the</u>
- 25 provisions of this chapter or any regulation alleged to have been violated and shall order

26 necessary corrective action be taken within a reasonable time to be prescribed in such

- 27 <u>order.</u>
- 28 (d) The department is authorized to revoke or suspend any license, certification, approval,
- 29 <u>or accreditation issued hereunder, in accordance with regulations promulgated pursuant to</u>
- 30 this chapter.
- 31 (e) It shall be unlawful for any person to engage in training or lead-based paint activities
- 32 regulated under this chapter except in such a manner as to conform to and comply with this
- 33 <u>chapter and all applicable regulations and orders established under this chapter.</u>
- 34 (f) Any person violating any of the provisions of this chapter shall be guilty of a
- 35 <u>misdemeanor.</u>"
- 36 SECTION 3.
- 37 This Act shall become effective upon its approval by the Governor or upon its becoming law
- 38 without such approval.
- SECTION 4.
- 40 All laws and parts of laws in conflict with this Act are repealed.
