A BILL TO BE ENTITLED AN ACT

1 To amend Chapter 8 of Title 50 of the Official Code of Georgia Annotated, relating to the 2 Department of Community Affairs, so as to create the Martin Luther King, Jr. Advisory 3 Council; to provide for membership on the council; to provide for terms and duties of 4 members; to provide for an annual report; to provide for the establishment of a not for profit 5 corporation; to provide for related matters; to provide for an effective date; to repeal conflicting laws; and for other purposes. 6 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA: 7 8 **SECTION 1.** 9 Chapter 8 of Title 50 of the Official Code of Georgia Annotated, relating to the Department 10 of Community Affairs, is amended by adding a new article to read as follows: 11 <u>"ARTICLE 10</u>

- (b) The council shall consist of nine members as follows: 15
- (1) The commissioner of community affairs or his or her designee; 16
- 17 (2) Six members to be appointed by the Governor, two of whom shall be between the
- 18 ages of 18 and 22 years;
- 19 (3) One member to be appointed by the President of the Senate; and
- 20 (4) One member to be appointed by the Speaker of the House of Representatives.
- 21 (c) Members shall serve four-year terms. No member of the council shall serve more than
- 22 two consecutive terms.
- 23 (d) Vacancies in the membership of the council shall be filled for the balance of the
- 24 unexpired term by the appointing authority.

- 25 (e) The council shall select annually a chairperson from among its membership. (f) Members of the council shall be subject to removal from office by the appointing 26 27 authority when the actions or condition of a member shall be considered as good cause for 28 <u>removal.</u> 29 (g) A majority of the council shall constitute a quorum for the transaction of business. 30 (h) Members of the council shall serve without compensation but, to the extent moneys are 31 received from voluntary contributions through a not for profit corporation, shall be eligible 32 to receive reimbursement for mileage and other expenses actually incurred in performance 33 of their duties in accordance with the rates and standards for reimbursement of state 34 employees. 35 <u>50-8-241.</u> 36 The Martin Luther King, Jr. Advisory Council shall have the following duties: 37 (1) To promote racial harmony, understanding, respect, and good will among all citizens; 38 (2) To promote principles of nonviolence, peace, and social justice; 39 (3) To promote among the people of Georgia, by appropriate activities, both awareness 40 and appreciation of the Civil Rights movement and advocacy of the principles and legacy 41 of Martin Luther King, Jr.; 42 (4) To develop, coordinate, and advise the state of appropriate ceremonies and activities 43 relating to the observance of the birthday of Martin Luther King, Jr., including, without 44 limitation, providing advice and assistance to local governments and private 45 organizations; 46 (5) To enable the people of Georgia to reflect on the life and teachings of Martin Luther 47 King, Jr., through educational endeavors, cultural performances, exhibitions, and events 48 that are multiethnic and family oriented; and 49 (6) To prepare an annual report for the Governor and the General Assembly detailing the 50 actions taken to fulfill these responsibilities and duties. 51 <u>50-8-242.</u> 52 The Department of Community Affairs is authorized to establish a not for profit 53 corporation and to appoint the members of the board of trustees of such corporation for the 54 purpose of sustaining and furthering the purpose of the council." 55 **SECTION 2.** 56 This Act shall become effective upon its approval by the Governor or upon its becoming law
- 57 without such approval.

SECTION 3.

59 All laws and parts of laws in conflict with this Act are repealed.
