## A BILL TO BE ENTITLED

## AN ACT

1 To amend Chapter 2 of Title 21 of the Official Code of Georgia Annotated, relating to  
 2 primaries and elections generally, so as to provide for oaths of election superintendents and  
 3 election supervisors and designees of boards of election; to provide that appointments of poll  
 4 officers shall be made available to the public; to clarify who may vote in runoff primaries;  
 5 to provide that the list of persons who have qualified with the state executive committee of  
 6 a political party shall be provided to the office of the Secretary of State; to clarify the manner  
 7 of appointment of registrars; to require registrars to check the data bases of convicted felons  
 8 and deceased persons maintained by the Secretary of State prior to approving a voter  
 9 registration application; to provide for the confidentiality of e-mail addresses maintained by  
 10 registrars; to provide for certain adjustments to precincts which contain more than 2,000  
 11 electors when all those electors desiring to vote at the last general election were unable to  
 12 complete voting within one hour following the closing of the polls; to remove the  
 13 requirement to certify that each election shall be conducted using certain voting equipment;  
 14 to allow the use of the federal write-in ballot for voting on constitutional amendments and  
 15 referenda; to clarify that the registrars or absentee ballot clerk may deliver an absentee ballot  
 16 to an elector who is confined in a hospital; to provide for the time for preparation and  
 17 transmittal of absentee ballots; to provide for a notice to be included with absentee ballots  
 18 of all withdrawn, deceased, and disqualified candidates and any substitute candidates; to  
 19 provide for certain notices with regard to the early processing and tabulation of absentee  
 20 ballots; to provide for the option to use different primaries and elections for the pilot project  
 21 for electronic transmission of certain absentee ballots; to change certain provisions regarding  
 22 the maintenance of sample or facsimile ballots; to provide that the superintendent shall  
 23 provide at polling places copies of sample or facsimile ballots for such primary or election  
 24 and a list of the certified write-in candidates; to remove certain archaic language regarding  
 25 vote tabulation machines; to provide for additional vote review panels; to change certain  
 26 provisions regarding the time for certifying election results; to provide for a method for  
 27 recounts for certain elections regarding constitutional amendments and binding referenda;  
 28 to provide for the swearing in of certain persons; to provide for the crime of solicitation of

29 voter fraud; to provide for punishment; to provide for related matters; to repeal conflicting  
30 laws; and for other purposes.

31 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

32 SECTION 1.

33 Chapter 2 of Title 21 of the Official Code of Georgia Annotated, relating to primaries and  
34 elections generally, is amended by revising paragraph (15) of Code Section 21-2-70, relating  
35 to powers and duties of superintendents, as follows:

36 "(15)(A) In the case of a judge of the probate court serving as the election  
37 superintendent, such person shall take an oath in the following form upon assuming  
38 the duties of election superintendent which shall apply to all primaries and elections  
39 conducted by such person throughout such person's tenure as election superintendent:

40 I, \_\_\_\_\_, do swear (or affirm) that I will as  
41 superintendent duly attend the all ensuing election (or primary) primaries and  
42 elections during the continuance thereof, that I will to the best of my ability prevent  
43 any fraud, deceit, or abuse in carrying on the same, that I will make a true and perfect  
44 return of ~~the said election (or primary)~~ such primaries and elections, and that I will at  
45 all times truly, impartially, and faithfully perform my duties in accordance with  
46 Georgia laws to the best of my judgment and ability.

47 (B) In the case of a board of elections, each member of the board shall take an oath in  
48 the following form upon becoming a member of the board which shall apply to all  
49 primaries and elections conducted by the board throughout such person's tenure on the  
50 board:

51 I, \_\_\_\_\_, do swear (or affirm) that I will as a member of  
52 the board of elections duly attend all ensuing primaries and elections during the  
53 continuance thereof, that I will to the best of my ability prevent any fraud, deceit, or  
54 abuse in carrying on the same, that I will make a true and perfect return of such  
55 primaries and elections, and that I will at all times truly, impartially, and faithfully  
56 perform my duties in accordance with Georgia laws to the best of my judgment and  
57 ability.

58 (C) In the case of an election supervisor or designee for a board of elections or board  
59 of elections and registration, the election supervisor or designee shall take an oath in  
60 the following form upon being appointed as an election supervisor or designee of the  
61 board which shall apply to all primaries and elections conducted by the board  
62 throughout such person's tenure:

63 I, \_\_\_\_\_, do swear (or affirm) that I will duly attend all  
 64 ensuing primaries and elections during the continuance thereof, that I will to the best  
 65 of my ability prevent any fraud, deceit, or abuse in carrying on the same, that I will  
 66 make a true and perfect return of such primaries and elections, and that I will at all  
 67 times truly, impartially, and faithfully perform my duties in accordance with Georgia  
 68 laws to the best of my judgment and ability.

69 (D) Each judge of the probate court serving as an election superintendent, each  
 70 member of a board of elections or board of elections and registration, and each election  
 71 supervisor or designee for a board of elections or board of elections and registration  
 72 serving on July 1, 2011, shall take the appropriate oath as set forth in this Code section  
 73 which shall apply to all primaries and elections conducted throughout such person's  
 74 tenure in that position."

75 **SECTION 2.**

76 Said chapter is further amended by revising Code Section 21-2-90, relating to the  
 77 appointment of chief manager and assistant managers, as follows:

78 "21-2-90.

79 All elections and primaries shall be conducted in each polling place by a board consisting  
 80 of a chief manager, who shall be chairperson of such board, and two assistant managers  
 81 assisted by clerks. The managers of each polling place shall be appointed by the  
 82 superintendent or, in the case of municipal elections, by the municipal governing authority.  
 83 If the political parties involved elect to do so, they may submit to the superintendent or  
 84 municipal governing authority, for consideration in making such appointment, a list of  
 85 qualified persons. When such lists are submitted to the appropriate office, the  
 86 superintendent or municipal governing authority, insofar as practicable, shall make  
 87 appointments so that there shall be equal representation on such boards for the political  
 88 parties involved in such elections or primaries. The superintendent or municipal governing  
 89 authority shall make each appointment by entering an order which shall remain of record  
 90 in the appropriate office and shall ~~transmit a copy of~~ make such order ~~to the appointee~~  
 91 available for public inspection upon request. The order shall include the name and address  
 92 of the appointee, his or her title, and a designation of the precinct and primary or election  
 93 in which he or she is to serve."

94 **SECTION 3.**

95 Said chapter is further amended by revising Code Section 21-2-152, relating to the conduct  
 96 of primaries generally, by adding a new subsection to read as follows:

97 "(c) A run-off primary shall be a continuation of the primary and only persons who were  
 98 entitled to vote in the primary shall be entitled to vote therein; and only those votes cast for  
 99 the persons designated for the runoff shall be counted in the tabulation and canvass of the  
 100 votes cast. Any elector who votes in the primary of one party shall not be eligible to vote  
 101 in a primary runoff of any other party other than a primary runoff of the party in whose  
 102 primary such elector voted."

103 **SECTION 4.**

104 Said chapter is further amended by revising paragraph (1) of subsection (d) of Code  
 105 Section 21-2-153, relating to posting of list of all qualified candidates for party nomination,  
 106 as follows:

107 "(d)(1) Within two hours after the qualifications have ceased, the county executive  
 108 committee of each political party shall post at the ~~county courthouse~~ office of the county  
 109 election superintendent a list of all candidates who have qualified with such executive  
 110 committee, and the state executive committee of each political party shall ~~post~~ provide  
 111 a list of all candidates who have qualified with such committee ~~at the courthouse of the~~  
 112 ~~county in which such executive committee's office is located~~ to the office of the Secretary  
 113 of State. If the election superintendent qualifies the candidates for a political party in  
 114 accordance with subsection (c) of this Code section, the election superintendent shall post  
 115 at ~~the county courthouse~~ his or her office a list of all the candidates who have qualified  
 116 with such superintendent for such political party."

117 **SECTION 5.**

118 Said chapter is further amended by revising subsections (a) and (e) of Code  
 119 Section 21-2-212, relating to the appointment of county registrars, as follows:

120 "(a) ~~The~~ Except in the case in which a county has a board of elections and registration, the  
 121 judge of the superior court in each county or the senior judge in time of service in those  
 122 counties having more than one judge shall appoint in accordance with this Code section,  
 123 upon the recommendation of the grand jury of such county, not less than three nor more  
 124 than five judicious, intelligent, and upright electors of such county as county registrars.  
 125 The grand jury shall submit to the judge the names of a number of electors equal to twice  
 126 the number of persons to be appointed and the appointment shall be made therefrom and  
 127 shall be entered on the minutes of the court. When making such appointments when  
 128 appropriate, the judge will designate one of the registrars as chief registrar who shall serve  
 129 as such during such registrar's term of office, and such designation shall likewise be entered  
 130 on the minutes of the court. It shall be the duty of the clerk of the superior court to certify  
 131 the appointments and designation to the Secretary of State within 30 days after the

132 appointments and designation, and commissions shall be issued as for county officers.  
 133 When certifying such names to the Secretary of State, the clerk of the superior court shall  
 134 also list the addresses of the registrars. Such judge will have the right to remove one or  
 135 more of such registrars at any time for cause after notice and hearing. In case of the death,  
 136 resignation, or removal of a registrar, the judge shall appoint a successor who shall serve  
 137 until the next grand jury convenes, at which time the grand jury shall submit to the judge  
 138 the names of two judicious, intelligent, and upright electors of such county; and the judge  
 139 shall make an appointment from said list, such successor to serve the unexpired term of  
 140 such registrar's predecessor in office. In the event the grand jury is in session at the time  
 141 of any such death, removal, or resignation, such grand jury shall immediately submit the  
 142 names of said electors to the judge for such appointment. Each such appointment or  
 143 change in designation shall be entered on the minutes of the court and certified as provided  
 144 in this Code section."

145 ~~"(e) Any other provision of this Code section to the contrary notwithstanding, in any~~  
 146 ~~county of this state having a population of more than 600,000 according to the United~~  
 147 ~~States decennial census of 1990 or any future such census If, within 90 days of the end of~~  
 148 ~~the term or the creation of a vacancy for a county registrar, an appointment is not made in~~  
 149 ~~accordance with subsection (a) of this Code section, the governing authority of the county~~  
 150 ~~shall appoint the county registrars in lieu of the judge of the superior court. The~~  
 151 ~~appointments shall be entered on the minutes of the county governing authority. The~~  
 152 ~~county governing authority shall designate one of the registrars as chief registrar, who shall~~  
 153 ~~serve as such during such registrar's term of office. Such designation shall likewise be~~  
 154 ~~entered on the minutes of such governing authority. It shall be the duty of the county~~  
 155 ~~governing authority to certify the appointments and designation to the Secretary of State~~  
 156 ~~and the clerk of the superior court within 30 days after such appointments and designation.~~  
 157 ~~In certifying such names to the Secretary of State and the clerk of the superior court, the~~  
 158 ~~county governing authority shall also list the addresses of the registrars. Such registrars~~  
 159 ~~shall serve at the pleasure of the governing authority of the county, and the compensation~~  
 160 ~~of the registrars shall be fixed by the governing authority of the county for the term and in~~  
 161 ~~the manner set forth in subsection (a) of this Code section. Any registrar shall have the~~  
 162 ~~right to resign at any time by submitting a resignation to ~~such governing authority~~ the clerk~~  
 163 ~~of the superior court. In the event of the death, resignation, or removal of any registrar,~~  
 164 ~~such registrar's duties and authority as such shall terminate instantly. Successors shall be~~  
 165 ~~appointed ~~by the county governing authority.~~ Each appointment or change in designation~~  
 166 ~~shall be entered on the minutes of such governing authority and certified as provided in this~~  
 167 ~~Code section. The first appointments in any such county under this article shall be made~~  
 168 ~~in the year 1965, and the persons appointed shall assume office July 1, 1965. The~~

169 ~~governing authorities of such counties may furnish such employees and facilities as they~~  
 170 ~~deem necessary for the operation of the office and affairs of the registrars as set forth in~~  
 171 ~~subsection (a) of this Code section.~~"

172 **SECTION 6.**

173 Said chapter is further amended by revising Code Section 21-2-216, relating to qualifications  
 174 of electors generally, by adding a new subsection to read as follows:

175 "(h) Prior to approving the application of a person to register to vote, the registrars may  
 176 check the data bases of persons convicted of felonies and deceased persons maintained by  
 177 the Secretary of State."

178 **SECTION 7.**

179 Said chapter is further amended by revising subsection (b) of Code Section 21-2-225, relating  
 180 to limitations on registration data available for public inspection, as follows:

181 "(b) Except as provided in Code Section 21-2-225.1, all data collected and maintained on  
 182 electors whose names appear on the list of electors maintained by the Secretary of State  
 183 pursuant to this article shall be available for public inspection with the exception of bank  
 184 statements submitted pursuant to subsection (c) of Code Section 21-2-220 and  
 185 subsection (c) of Code Section 21-2-417, the month and day of birth, the social security  
 186 numbers, e-mail addresses, and driver's license numbers of the electors, and the locations  
 187 at which the electors applied to register to vote, which shall remain confidential and shall  
 188 be used only for voter registration purposes; provided, however, that any and all  
 189 information relating to the dates of birth, social security numbers, and driver's license  
 190 numbers of electors may be made available to other agencies of this state, to agencies of  
 191 other states and territories of the United States, and to agencies of the federal government  
 192 if the agency is authorized to maintain such information and the information is used only  
 193 to identify the elector on the receiving agency's data base and is not disseminated further  
 194 and remains confidential. Information regarding an elector's year of birth shall be available  
 195 for public inspection."

196 **SECTION 8.**

197 Said chapter is further amended by revising Code Section 21-2-263, relating to reduction in  
 198 size of precincts containing more than 2,000 electors when voting in such precincts at  
 199 previous general election not completed one hour after closing of polls, as follows:

200 "21-2-263.

201 If at the previous general election a precinct contained more than 2,000 electors and if all  
 202 those electors desiring to vote had not completed voting one hour following the closing of

203 the polls, the superintendent shall either reduce the size of said precinct so that it shall  
 204 contain not more than 2,000 electors in accordance with the procedures prescribed by this  
 205 chapter for the division, alteration, and consolidation of precincts no later than 60 days  
 206 before the next general election or provide additional voting equipment or poll workers or  
 207 both before the next general election. For administering this Code section, the chief  
 208 manager of a precinct which contained more than 2,000 electors at the previous general  
 209 election shall submit a report thereof, under oath, to the superintendent as to the time  
 210 required for completion of voting by all persons in line at the time the polls were closed.  
 211 Any such change in the boundaries of a precinct shall conform with the requirements of  
 212 subsection (a) of Code Section 21-2-261.1."

213 **SECTION 9.**

214 Said chapter is further amended by revising subsection (d) of Code Section 21-2-379.2,  
 215 relating to written verification and certification prior to election or primary, as follows:

216 ~~"(d) At least ten days prior to any primary or election, including special primaries, special~~  
 217 ~~elections, and referendum elections, the election superintendent shall verify and certify in~~  
 218 ~~writing to the Secretary of State that all voting will occur on equipment certified by the~~  
 219 ~~Secretary of State~~ Reserved."

220 **SECTION 10.**

221 Said chapter is further amended by revising paragraph (2) of subsection (b) of Code  
 222 Section 21-2-381, relating to making of application for absentee ballot, as follows:

223 "(2) If found eligible, the registrar or absentee ballot clerk shall certify by signing in the  
 224 proper place on the application and shall either mail the ballot as provided in this Code  
 225 section or issue the ballot to the elector to be voted within the confines of the registrar's  
 226 or absentee ballot clerk's office. The registrar or absentee ballot clerk may ~~or~~ deliver the  
 227 ballot in person to the elector if such elector is confined to a hospital."

228 **SECTION 11.**

229 Said chapter is further amended by revising paragraph (2) of subsection (b) of Code  
 230 Section 21-2-381.1, relating to procedures for voting with special write-in absentee ballots  
 231 by qualified absentee electors, as follows:

232 "(2) Except as provided in paragraph (3) of this subsection, an elector who is entitled to  
 233 vote by absentee ballot under the federal Uniformed and Overseas Citizens Absentee  
 234 Voting Act, 42 U.S.C. Section 1973ff, et seq., as amended, may vote in any election for  
 235 a public office other than for a federal office by using the addendum provided in the  
 236 federal write-in absentee ballot and writing in the title of the office and the name of the

237 candidate for whom the elector is voting. In a general, special, or run-off election, the  
 238 elector may alternatively designate a candidate by writing in a party preference for each  
 239 office, the names of specific candidates for each office, or the name of the person who  
 240 the elector prefers for each office. A written designation of the political party shall be  
 241 counted as a vote for the candidate of that party. In addition, such elector may vote on  
 242 any constitutional amendment or question presented to the electors in such election by  
 243 identifying the constitutional amendment or question with regard to which such elector  
 244 desires to vote and specifying the elector's vote on such amendment or question."

245 **SECTION 12.**

246 Said chapter is further amended by revising subsections (a) and (b) of Code  
 247 Section 21-2-384, relating to preparation and delivery of absentee ballots and supplies, as  
 248 follows:

249 ~~"(a)(1) The superintendent must, at least 45 days prior to any general primary or general~~  
 250 ~~election other than a municipal general primary or general election, and at least 21 days~~  
 251 ~~prior to any municipal general primary or general election, shall, in consultation with the~~  
 252 ~~board of registrars or absentee ballot clerk, prepare, obtain, and deliver before the date~~  
 253 ~~specified in paragraph (2) of this subsection an adequate supply of official absentee~~  
 254 ~~ballots to the board of registrars or absentee ballot clerk for use in the primary or election~~  
 255 ~~or as soon as possible prior to a runoff. Envelopes and other supplies as required by this~~  
 256 ~~article may be ordered by the superintendent, the board of registrars, or the absentee~~  
 257 ~~ballot clerk for use in the primary or election.~~

258 (2) The board of registrars or absentee ballot clerk shall, ~~within two days after the receipt~~  
 259 ~~of such ballots and supplies, mail or issue official absentee ballots to all eligible~~  
 260 ~~applicants at least 45 days, but no earlier than 46 days, prior to any presidential~~  
 261 ~~preference primary, general primary, general election other than a municipal general~~  
 262 ~~primary or general election, or special election in which there is a candidate for a federal~~  
 263 ~~office on the ballot; at least 21 days, but no earlier than 22 days, prior to any municipal~~  
 264 ~~general primary or general election; and as soon as possible prior to a runoff. In the case~~  
 265 ~~of all other special elections, the board of registrars or absentee ballot clerk shall mail or~~  
 266 ~~issue official absentee ballots to all eligible applicants within two days after the receipt~~  
 267 ~~of such ballots and supplies, but no earlier than 22 days prior to the election; provided,~~  
 268 ~~however, that should any elector of the jurisdiction be permitted to vote beginning 45~~  
 269 ~~days prior to a primary or election, all electors of such jurisdiction shall be entitled to~~  
 270 ~~vote beginning 45 days prior to such primary or election. As additional applicants are~~  
 271 ~~determined to be eligible, the board or clerk shall mail or issue official absentee ballots~~  
 272 ~~to such additional applicants immediately upon determining their eligibility; provided,~~



273 however, that no absentee ballot shall be mailed by the registrars or absentee ballot clerk  
 274 on the day prior to a primary or election and provided, further, that no absentee ballot  
 275 shall be issued on the day prior to a primary or election. ~~The board of registrars shall, at  
 276 least 45 days prior to any general primary, or general election other than a municipal  
 277 general primary or general election, and at least 21 days prior to any municipal general  
 278 primary or general election, mail or electronically transmit official absentee ballots to all  
 279 electors who are entitled to vote by absentee ballot under the federal Uniformed and  
 280 Overseas Citizens Absentee Voting Act, 42 U.S.C. Section 1973ff, et seq., as amended.~~

281 (3) The date a ballot is voted in the registrars' or absentee ballot clerk's office or the date  
 282 a ballot is mailed to an elector and the date it is returned shall be entered on the  
 283 application record therefor.

284 (4) The delivery of an absentee ballot to a person confined in a hospital may be made by  
 285 the registrar or clerk on the day of a primary or election or during a five-day period  
 286 immediately preceding the day of such primary or election.

287 (5) In the event an absentee ballot which has been mailed by the board of registrars or  
 288 absentee ballot clerk is not received by the applicant, the applicant may notify the board  
 289 of registrars or absentee ballot clerk and sign an affidavit stating that the absentee ballot  
 290 has not been received. The board of registrars or absentee ballot clerk shall then issue a  
 291 second absentee ballot to the applicant and cancel the original ballot issued. The affidavit  
 292 shall be attached to the original application. A second application for an absentee ballot  
 293 shall not be required.

294 (b) In addition to the mailing envelope, the superintendent, board of registrars, or absentee  
 295 ballot clerk shall provide two envelopes for each official absentee ballot, of such size and  
 296 shape as shall be determined by the Secretary of State, in order to permit the placing of one  
 297 within the other and both within the mailing envelope. On the smaller of the two envelopes  
 298 to be enclosed in the mailing envelope shall be printed the words 'Official Absentee Ballot'  
 299 and nothing else. On the back of the larger of the two envelopes to be enclosed within the  
 300 mailing envelope shall be printed the form of oath of the elector and the oath for persons  
 301 assisting electors, as provided for in Code Section 21-2-409, and the penalties provided for  
 302 in Code Sections 21-2-568, 21-2-573, 21-2-579, and 21-2-599 for violations of oaths; and  
 303 on the face of such envelope shall be printed the name and address of the board of  
 304 registrars or absentee ballot clerk. The mailing envelope addressed to the elector shall  
 305 contain the two envelopes, the official absentee ballot, ~~and~~ the uniform instructions for the  
 306 manner of preparing and returning the ballot, in form and substance as provided by the  
 307 Secretary of State, and a notice in the form provided by the Secretary of State of all  
 308 withdrawn, deceased, and disqualified candidates and any substitute candidates pursuant  
 309 to Code Sections 21-2-134 and 21-2-155 and nothing else. The uniform instructions shall

310 include information specific to the voting system used for absentee voting concerning the  
 311 effect of overvoting or voting for more candidates than one is authorized to vote for a  
 312 particular office and information concerning how the elector may correct errors in voting  
 313 the ballot before it is cast including information on how to obtain a replacement ballot if  
 314 the elector is unable to change the ballot or correct the error."

315 **SECTION 13.**

316 Said chapter is further amended by revising paragraph (3) of subsection (a) of Code  
 317 Section 21-2-386, relating to safekeeping, certification, and validation of absentee ballots,  
 318 as follows:

319 "(3) A county election superintendent may, in his or her discretion, after 7:00 A.M. on  
 320 the day of the primary, election, or runoff open the inner envelopes in accordance with  
 321 the procedures prescribed in this subsection and begin tabulating the absentee ballots. If  
 322 the county election superintendent chooses to open the inner envelopes and begin  
 323 tabulating such ballots prior to the close of the polls on the day of the primary, election,  
 324 or runoff, the superintendent shall notify in writing, at least seven days prior to the  
 325 primary, election, or runoff, the ~~county executive committee or, if there is no organized~~  
 326 ~~county executive committee, the state executive committee of each political party and~~  
 327 ~~political body having candidates whose names appear on the ballot for such election in~~  
 328 ~~such county and each independent and nonpartisan candidate whose name appears on the~~  
 329 ~~ballot for such primary, election, or runoff in such county~~ Secretary of State of the  
 330 superintendent's intent to begin the absentee ballot tabulation prior to the close of the  
 331 polls ~~and their right to appoint monitors to observe the tabulation. Such committee~~ The  
 332 county executive committee or, if there is no organized county executive committee, the  
 333 state executive committee of each political party and political body having candidates  
 334 whose names appear on the ballot for such election in such county shall have the right to  
 335 designate two persons and each independent and nonpartisan candidate whose name  
 336 appears on the ballot for such election in such county shall have the right to designate one  
 337 person to act as monitors for such process. In the event that the only issue to be voted  
 338 upon in an election is a referendum question, the superintendent shall also notify in  
 339 writing the chief judge of the superior court of the county who shall appoint two electors  
 340 of the county to monitor such process."

341 **SECTION 14.**

342 Said chapter is further amended by revising Code Section 21-2-387, relating to pilot program  
 343 for electronic handling of absentee ballots, as follows:

344 "21-2-387.

345 (a) The Secretary of State shall develop and implement a pilot program for the electronic  
346 transmission, receipt, and counting of absentee ballots by persons who are entitled to vote  
347 by absentee ballot under the federal Uniformed and Overseas Citizens Absentee Voting  
348 Act, 42 U.S.C. Section 1973ff, et seq., as amended, for use in a primary or a general  
349 ~~election and general election runoff~~.

350 (b) Such pilot program shall provide, at a minimum, for:

351 (1) The encryption of information and the transmission of such information over a secure  
352 network;

353 (2) The authentication of such information;

354 (3) The verification of the identity and eligibility of the elector to vote in the primary,  
355 ~~election,~~ or runoff, as the case may be;

356 (4) The protection of the privacy, anonymity, and integrity of the ballots cast;

357 (5) The prevention of the casting of multiple ballots by the same elector in ~~an~~ a primary,  
358 ~~election, or runoff;~~

359 (6) The prevention of any tampering, abuse, fraudulent use, or illegal manipulation of  
360 such system;

361 (7) The uninterrupted reliability of such system for casting ballots by qualified voters;

362 (8) The capability of the elector to determine if the electronic transmission of the ballot  
363 was successful;

364 (9) The ability to audit such ballots and to verify that such ballots were properly counted;  
365 and

366 (10) The ability to verify that the information transmitted over the secure network was  
367 not viewed or altered by sites that lie between the voting location and the vote counting  
368 destination.

369 (c) The Secretary of State shall develop procedures by which persons who are eligible to  
370 utilize the pilot program to vote shall be notified of its availability and the procedures and  
371 methods for its utilization.

372 (d) The Secretary of State and the State Election Board are authorized to promulgate such  
373 rules and regulations as necessary to implement the provisions of this Code section.

374 (e) The Secretary of State shall review the results of the pilot program and shall provide  
375 the members of the General Assembly with a comprehensive report no later than 90 days  
376 following the primary or general election ~~and general election runoff~~ in which such pilot  
377 program is used on the effectiveness of such pilot program with any recommendations for  
378 its continued use and any needed changes in such program for future primaries and  
379 elections.

380 (f) The pilot program shall be used in the first primary or general election ~~and general~~  
 381 ~~election runoff~~ following:

382 (1) The inclusion in the Appropriations Act of a specific line item appropriation for  
 383 funding of such pilot program or a determination by the Secretary of State that there is  
 384 adequate funding through public or private funds, or a combination of public and private  
 385 funds, to conduct the pilot program; provided, however, that no funds shall be accepted  
 386 from registered political parties or political bodies for this purpose; and

387 (2) Certification by the Secretary of State that such pilot program is feasible and can be  
 388 implemented for such primary or general election ~~and general election runoff~~.

389 (g) This Code section shall be repealed by operation of law on July 1 of the year following  
 390 the conclusion of the pilot program."

391 **SECTION 15.**

392 Said chapter is further amended by revising subsection (c) of Code Section 21-2-400, relating  
 393 to preparation and distribution of sample or facsimile ballot labels, as follows:

394 "(c) The superintendent shall prepare sample or facsimile ballots or ballot labels, as the  
 395 case may be, for each general election which shall contain each question and the candidates  
 396 who are offering for election for each office which will be voted upon in the county or  
 397 municipality. ~~The superintendent shall maintain such sample or facsimile ballots or ballot~~  
 398 ~~labels at the county courthouse~~ for distribution upon request to interested electors. Such  
 399 sample or facsimile ballots or ballot labels shall comply with Code Section 21-2-575."

400 **SECTION 16.**

401 Said chapter is further amended by revising Code Section 21-2-401, relating to delivery of  
 402 forms and supplies to precincts, by adding a new subsection to read as follows:

403 "(d) The superintendent shall provide at the polling place copies of the sample or facsimile  
 404 ballots for such primary or election as well as a list of the certified write-in candidates for  
 405 such election in the form as provided by the Secretary of State or appropriate municipal  
 406 official pursuant to Code Section 21-2-133."

407 **SECTION 17.**

408 Said chapter is further amended by revising subsection (g) of Code Section 21-2-483, relating  
 409 to counting of ballots, as follows:

410 "(g)(1) ~~The precinct tabulator shall be programmed to return to the voter at the time that~~  
 411 ~~the voter inserts the ballot any ballot on which an overvote is indicated, along with any~~  
 412 ~~ballot that cannot be processed by the tabulator for reevaluation or correction or spoiling~~

413 of the ballot, and a new ballot shall be issued if the voter desires to vote another ballot in  
 414 order to correct mistakes, overvotes, or other problems.

415 ~~(2)(A)~~ The central tabulator shall be programmed to reject any ballot, including  
 416 absentee ballots, on which an overvote is detected and any ballot so rejected shall be  
 417 manually reviewed by the vote review panel described in this Code section to determine  
 418 the voter's intent as described in subsection (c) of Code Section 21-2-438.

419 ~~(B)~~(2)(A) In a partisan election, the vote review panel shall be composed of the  
 420 election superintendent or designee thereof and one person appointed by the county  
 421 executive committee of each political party and body having candidates whose names  
 422 appear on the ballot for such election, provided that, if there is no organized county  
 423 executive committee for a political party or body, the person shall be appointed by the  
 424 state executive committee of the political party or body. In a nonpartisan election, the  
 425 panel shall be composed of the election superintendent or designee thereof and two  
 426 electors of the county, in the case of a county election, or the municipality, in the case  
 427 of a municipal election, appointed by the chief judge of the superior court of the county  
 428 in which the election is held or, in the case of a municipality which is located in more  
 429 than one county, of the county in which the city hall of the municipality is located. The  
 430 panel shall manually review all ballots rejected by the tabulator under ~~subparagraph (A)~~  
 431 paragraph (1) of this paragraph subsection and shall determine by majority vote  
 432 whether the elector's intent can be determined as described in subsection (c) of Code  
 433 Section 21-2-438 and, if so, said vote shall be counted as the elector intended. In the  
 434 event of a tie vote by the vote review panel, the vote of the election superintendent or  
 435 designee thereof shall control.

436 (B) The election superintendent may create multiple vote review panels in accordance  
 437 with subparagraph (A) of this paragraph to handle the processing of such ballots more  
 438 efficiently. Upon the creation of such panels, the election superintendent shall  
 439 designate one of the panels as the chief vote review panel. In the event of a  
 440 disagreement on such additional panels, the ballots in question shall be reviewed by the  
 441 chief vote review panel and decided in accordance with the procedures contained in  
 442 subparagraph (A) of this paragraph."

443 **SECTION 18.**

444 Said chapter is further amended by revising subsection (k) of Code Section 21-2-493, relating  
 445 to computation, canvassing, and tabulation of returns, as follows:

446 "(k) As the returns from each precinct are read, computed, and found to be correct or  
 447 corrected as aforesaid, they shall be recorded on the blanks prepared for the purpose until  
 448 all the returns from the various precincts which are entitled to be counted shall have been

449 duly recorded; then they shall be added together, announced, and attested by the assistants  
 450 who made and computed the entries respectively and shall be signed by the superintendent.  
 451 The consolidated returns shall then be certified by the superintendent in the manner  
 452 required by this chapter. Such returns shall be certified by the superintendent not later than  
 453 5:00 P.M. on the ~~seventh day~~ Monday following the date on which such election was held  
 454 and such returns shall be immediately transmitted to the Secretary of State."

#### 455 **SECTION 19.**

456 Said chapter is further amended by revising subsection (c) of Code Section 21-2-495, relating  
 457 to procedure for recount or recanvass of votes, as follows:

458 "(c)(1) Whenever the difference between the number of votes received by a candidate  
 459 who has been declared nominated for an office in a primary election or who has been  
 460 declared elected to an office in an election or who has been declared eligible for a run-off  
 461 primary or election and the number of votes received by any other candidate or  
 462 candidates not declared so nominated or elected or eligible for a runoff shall be not more  
 463 than 1 percent of the total votes which were cast for such office therein, any such  
 464 candidate or candidates receiving a sufficient number of votes so that the difference  
 465 between his or her vote and that of a candidate declared nominated, elected, or eligible  
 466 for a runoff is not more than 1 percent of the total votes cast, within a period of two  
 467 business days following the certification of the election results, shall have the right to a  
 468 recount of the votes cast, if such request is made in writing by the losing candidate. If the  
 469 office sought is a federal or state office voted upon by the electors of more than one  
 470 county, the request shall be made to the Secretary of State who shall direct that the  
 471 recount be performed in all counties in which electors voted for such office and notify the  
 472 superintendents of the several counties involved of the request. In all other cases, the  
 473 request shall be made to the superintendent. The superintendent or superintendents shall  
 474 order a recount of such votes to be made immediately. If, upon such recount, it is  
 475 determined that the original count was incorrect, the returns and all papers prepared by  
 476 the superintendent, the superintendents, or the Secretary of State shall be corrected  
 477 accordingly and the results recertified.

478 (2) Whenever the difference between the number of votes for approval or rejection of a  
 479 constitutional amendment or binding referendum question shall be not more than 1  
 480 percent of the total votes which were cast on such amendment or question therein, within  
 481 a period of two business days following the certification of the election results, the  
 482 Constitutional Amendments Publication Board shall be authorized in its discretion to call  
 483 for a recount of the votes cast with regard to such amendment or question. In the case of  
 484 a constitutional amendment or state-wide referendum question or a question voted upon

485 by the electors of more than one county, the board shall direct the Secretary of State to  
 486 cause a recount to be performed with regard to such amendment or question in all  
 487 counties involved and notify the superintendents of the recount. In the case of questions  
 488 voted upon by the electors of only one county or municipality, the board shall direct the  
 489 Secretary of State to cause a recount to be conducted by the county or municipality  
 490 involved and the Secretary of State shall notify the superintendent involved of the  
 491 recount. Upon notification, the superintendent or superintendents shall order a recount  
 492 of such votes to be made immediately. If, upon such recount, it is determined that the  
 493 original count was incorrect, the returns and all papers prepared by the superintendent,  
 494 the superintendents, or the Secretary of State shall be corrected accordingly and the  
 495 results recertified."

#### 496 **SECTION 20.**

497 Said chapter is further amended by revising subsection (b) of Code Section 21-2-503, relating  
 498 to issuance of commission to person whose election is contested, and by adding a new  
 499 subsection to read as follows:

500 "(b) Upon the certification of the results of the election, a ~~A~~ person elected to a municipal  
 501 office may be sworn into office notwithstanding that the election of such person may be  
 502 contested in the manner provided by this chapter. Upon the final judgment of the proper  
 503 tribunal having jurisdiction of a contested election which orders a second election or  
 504 declares that another person was legally elected to the office, the person sworn into  
 505 municipal office shall cease to hold the office and shall cease to exercise the powers,  
 506 duties, and privileges of the office immediately.

507 (c) Upon the certification of the results of the election, a person elected to a federal, state,  
 508 or county office may be sworn into office notwithstanding that the election of such person  
 509 may be contested in the manner provided by this chapter. Upon the final judgment of the  
 510 proper tribunal having jurisdiction of a contested election which orders a second election  
 511 or declares that another person was legally elected to the office, the person sworn into such  
 512 office shall cease to hold the office and shall cease to exercise the powers, duties, and  
 513 privileges of the office immediately."

#### 514 **SECTION 21.**

515 Said chapter is further amended by adding a new Code section to Article 15, relating to  
 516 miscellaneous offenses, to read as follows:

517 "21-2-604.

518 (a)(1) A person commits the offense of criminal solicitation to commit election fraud in  
 519 the first degree when, with intent that another person engage in conduct constituting a

520 felony under this article, he or she solicits, requests, commands, importunes, or otherwise  
 521 attempts to cause the other person to engage in such conduct.

522 (2) A person commits the offense of criminal solicitation to commit election fraud in the  
 523 second degree when, with intent that another person engage in conduct constituting a  
 524 misdemeanor under this article, he or she solicits, requests, commands, importunes, or  
 525 otherwise attempts to cause the other person to engage in such conduct.

526 (b)(1) A person convicted of the offense of criminal solicitation to commit election fraud  
 527 in the first degree shall be punished by imprisonment for not less than one nor more than  
 528 three years.

529 (2) A person convicted of the offense of criminal solicitation to commit election fraud  
 530 in the second degree shall be punished as for a misdemeanor.

531 (c) It is no defense to a prosecution for criminal solicitation to commit election fraud that  
 532 the person solicited could not be guilty of the crime solicited.

533 (d) The provisions of subsections (a) through (c) of this Code section are cumulative and  
 534 shall not supersede any other penal law of this state."

535 **SECTION 22.**

536 All laws and parts of laws in conflict with this Act are repealed.
