- 4 1936, and will be celebrating their 75th wedding anniversary this year; and
- 5 WHEREAS, Mr. and Mrs. Starling's 75 year union and unyielding loyalty and devotion to
- 6 one another serve as an inspiration to their family, friends, and neighbors; and
- 7 WHEREAS, Mr. Ronald Starling was born on February 7, 1918, in Bryan County, Georgia,
- 8 to proud parents Sammie William Starling and Elizabeth Purvis Starling; and
- 9 WHEREAS, Mrs. Virginia Starling was born on April 6, 1920, in Bulloch County, Georgia,
- 10 the beloved daughter of Thomas Watson Kicklighter and Lessie Latzak Kicklighter; and

- 19 WHEREAS, a couple with deep and abiding faith, the Starlings are faithful members of
- 20 Lawrence Baptist Church, where Mr. Starling has attended all his life and Mrs. Starling
- 21 became a member in 1937; and

22 WHEREAS, their greatest accomplishments are their three children, seven grandchildren,
23 and ten great-grandchildren; and

24 WHEREAS, the devotion, patience, and understanding they have demonstrated have
25 provided the foundation and framework of success in which all of their family members have
26 developed and flourished; and

27 WHEREAS, known for their generosity and kindness, Mr. and Mrs. Starling have made the
28 world a better place in which to live with many incredible contributions to their family,
